## FACULTY SPOTLIGHT

Professor Todd Parker, originally from Duncan, Oklahoma, graduated from Oklahoma State University with a Bachelors degree in painting and fine arts before pursuing two Master's degrees in Illinois and Virginia. Although his original intent was to become a graphic design artist, he began teaching and found that he enjoyed spreading art through education. After graduation, he decided that it was time to return to Oklahoma, and he began working at SWOSU. He is currently pursuing a Doctorate

degree at the University of Oklahoma and enjoys spending time with his family, hiking, and teaching. He would like to add that Art is one of the most ubiquitous things about humanity and that spreading art and through art, he considers teaching people about the history and culture of Oklahoma a great privilege.

Professor Xiaomiao Wang, originally from Southeast China, studied at the University of Wyoming as well as the University of Nebraska. She came to SWOSU as her first college teaching job. She grew up seeing the variety of traditional clothes worn by the different tribal people that lived in the area and it is a hobby of hers to collect ethnic pieces of clothing.

Recently, Parker and Wang embarked on their first grant writing project. After their second proposal submission, the two were awarded \$6,500 from the Oklahoma Humanities Council for their project entitled "The Circular Movement in Cheyenne and Arapaho Culture". They chose to focus on the Cheyenne and Arapaho people and their culture because they noticed when looking at a map of the population density of Native Americans, Oklahoma has the densest Native American population. It is a fact that Oklahoma is rich in its Native American history, heritage, and culture which is made obvious by the many Native American names of cities, counties and even this state itself. Because the professors had a very basic and narrow knowledge of the tribes, they decided that it would be a great idea to expand not just their personal awareness, but to create an exhibit that would be both beautifully artistic as well as an educational experience for all its viewers. Those offering assistance and advice for the project included the President of the Cheyenne and Arapaho Tribal College, Dr. Henrietta Mann, Professor Gordon Yellowman, and Professor Edgar Heap of Birds. The exhibition was Sept. 12 through Oct. 6, 2011 in the SWOSU Art Department Gallery.

## INTELLECTUAL PROPERTY

The members of the Intellectual Property Committee (IPC) wish to assure that all administrators, faculty, staff, and students are aware of and comply with the Intellectual Property Policies (IPP) governing patents, copyrighted material, trademarks, and other intellectual property created or used by the Southwestern Oklahoma State University community. The IPP complement those policies currently in place by the Regional University System of Oklahoma. Although the IPP are extensive, administration, faculty, staff, and students should be familiar with the contents.

The IPP allow users to properly recognize the rights and obligations concerning the creation or use of intellectual property. To assist our SWOSU community in compliance with governing laws and policies, the IPC members request that you take a moment to review the web sites below.

In the links below, you will find SWOSU's policy on Intellectual Property and related policies and resources of SWOSU and others. You should be familiar with all of these. Additionally, you will find links to assist you in properly using copyrighted material and a form to disclose any intellectual property created.
