- 1. The meeting was called to order at 2:45 p.m. (delayed because of technical difficulties)
- 2. Minutes from the March 27, 2012 meeting were reviewed. Jared Edwards made a motion to approve, Tami Moser seconded, and the motion passed.
- 3. After reports of discussion and positive feedback from the Director of ITS and other, Cindy Dougherty made a motion to recommend the idea that our alumni and former students be allowed to keep their SWOSU email, so that they can more easily contacted. Tami Moser seconded, and the motion passed.
- 4. The committee continues to show interest in revising Remediation Policy Item #7 to the following:

Students wishing to test or re-test while enrolled in a remedial course must take the initial CPT and retest before noon of the semester deadline to add a class, or by Instructor permission.

After more discussion, the committee decided to approach Blake Sonobe for his feedback on the subject.

- 5. Cindy Dougherty reported on the current Tracking Study of correlating the variables of discipline issues, ACT scores, HS GPA, and retention. It was reported that of 554 open discipline files, 78 were housing issues, and the other 476 were Dean of Students issues. Of the 554, 72% have ACT scores below the minimum requirement for admissions, and 60% have HS GPAs below the minimum requirement for admissions. Other interests were brought up such as 1) are these students still enrolled, 2) were they alternatively admitted, and 3) what is the percentage that have graduated. Cindy Foust recommended tracking three years of data. This issue is tabled until the next Assessment Committee meeting.
- 6. Jared Edwards shared his study based on responses to the Career Barriers Inventory-Revised that he administered during Fall 2012 Freshman Orientation classes.
- 7. Updated reports were shared:
 - a. Remediation Survey
 - b. CAAP
 - c. NSSE
 - d. SOSO
- 8. The meeting adjourned at about 5:00 p.m.
