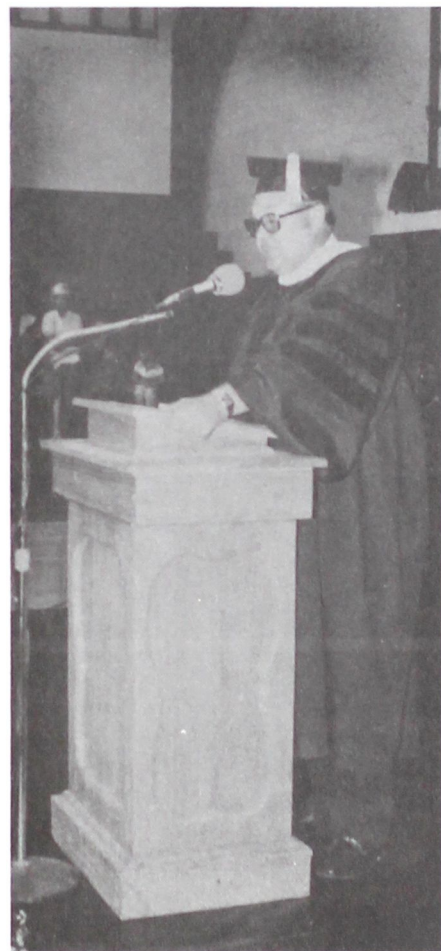

From the desk of the President...

Dear Alumni and Friends:

Today is a beautiful spring day. The Hill is "greening up." The winds are calm, which is a rare treat on campus! But, some things never change. Students are working on their tans and counting the days until the end of the semester. Faculty have accepted that they will not get all of their course material covered.

This has been a good year for Southwestern. Academically, we are fortunate to continue to attract good students. The ACT score for admission is 19, and our student AVERAGE is 21, which is highest average of the ten regional universities in the State. The percentage of students accepting our highest academic scholarships continues to grow, which is a compliment to the teaching and service that students find at Southwestern. Two of our programs, Pharmacy and Hospital Information Management, received continuing accreditation this year; while the Physical Therapy Assistant Program, which is a new cooperative agreement with Caddo-Kiowa Vocational-Technical School, received full accreditation with our initial review.

Our student-athletes have had a good year. Both the men's and women's basketball teams earned their berths in the NAIA national tournaments. Coach Larry Geurkink earned his 500th baseball win this spring. The men's golf team has won two tournaments and are nationally ranked; and the rodeo team has won a couple of tournaments. We will be applying for NCAA, Division II membership this summer. If we are accepted, we will serve a three-year probationary period, which will give us time to review our athletics programs as we move into a new organization. If funding is available, we plan to add women's golf in 1995-96 and women's softball in 1996-97.

The Music Building was dedicated last fall, and the construction of the new classroom building is on schedule and should be completed sometime during the 1995 fall semester. Classes are scheduled to open in the


new facility for the 1996 spring semester. The School of Business, the Computer Science Department, Computer Services, Financial Assistance, and

Student Services will relocate into the new building. Following the move, we will renovate the Math and Business Building, the Science Building, the Education Building, and the Administration Building. The renovations will include the installation of elevators in three of the buildings, and the entire project will take two or three years to complete.

Southwestern will celebrate its 100th year in 2001, which is only six years away. We have such a rich history, and the artifacts continue to accumulate with no place to display our heritage. As a graduate of this institution with a trunkload of good memories, I would like to restore the old Y chapel and use it for a museum. Jim Loomis, our physical plant director, says we can do a "bang-up job" for \$10,000. Naturally, these will have to be private dollars donated for this particular project. If you have a common interest and would like to help with this idea, please contact me.

Thanks for your continued interest in Southwestern and your support of our future. You are our best ambassadors, and I greatly appreciate the efforts that you make on the part of Southwestern.

Dr. Leonard Campbell remembered

Just 4 1/2 years after retiring as SWOSU president at the relatively young age of 56, Dr. Leonard Campbell succumbed to cancer Feb. 15, 1995 at the University Hospital in Oklahoma City.

Campbell's death was a blow to two people who knew him extremely well, Mayor Gary Rader and SWOSU President Dr. Joe Anna Hibler.

"Leonard was a special person when you had a chance to get to know him," said Hibler who succeeded Campbell in July 1990.

"He had a delightful sense of humor and was just fun to be around. He had an uncanny knack of knowing what people were about."

Rader said his dad, Dean, and Campbell played dominoes every day for 13 years at the Rader agency.

Those two and quite often Joe Phillips, Steve Hilterbran and Cecil Perkins would play for two hours starting at 11:30 in the morning.

The "bones" sessions were sandwiched between two half-hour discussions on politics—one of Campbell's favorite subjects.

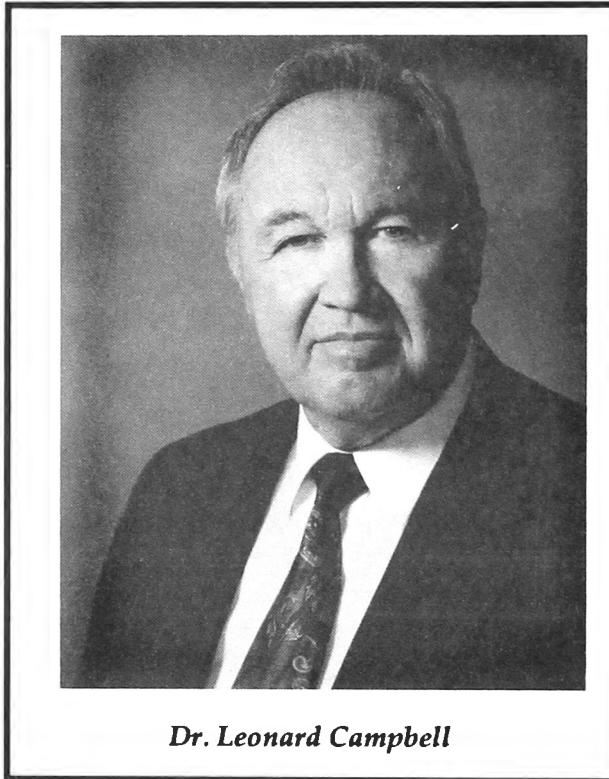
"You talk about a yellow-dog Democrat, he was it," Hibler said with a laugh.

Rader said Campbell's domino-playing talents bordered on the supernatural.

"We always accused Leonard of having the inside track with the domino gods," the mayor said. "We always joked about the 'six-ace.' Anytime he needed it, he had it."

More seriously, both Hibler and Rader agreed that aside from his wife and daughter, Southwestern Oklahoma State University was No. 1 in Leonard Campbell's heart.

"He loved this university," Rader said. "He always said 'my friends' are all right here." Hibler said. "He saw this university through some really tough

financial times. He provided a quiet style of leadership and gave us a sense of security."

Both recall the first time they met Campbell.

Rader was at a Steak and Ale in Oklahoma City in 1975. He took the initiative to introduce himself to Leonard and Linda, because they were dining with Rader's former high school principal, Bill Ware, and his wife.

"He told me he had just accepted the position at Southwestern," Rader said.

Hibler said her first conversation with the new SWOSU President was over coffee. She became quickly acquainted with her boss's sense of humor.

"I was a faculty member and I introduced myself," she said. "He said, 'Yes, I've heard about you.' He allowed, 'Capable women sometimes scare me.'"

"I assured him I was no threat to him and would work with him."

Hibler said Campbell "was a take-charge type of guy. You always knew who would decide where you were going to eat."

She said her predecessor "was a good sounding board because of his wisdom" following his retirement.

"He was really a mentor for me. He was so supportive of women in professional capacities. He was the gentleman who gave me a chance to move through the ranks, first as a dean, then as a vice president."

Campbell was first diagnosed with melanoma two years ago and had some skin cancers removed, but was warned that it might return.

It did, and the cancer spread to his kidneys, heart and liver.

Campbell, a former coach, loved athletics. He always sat on the top row at basketball games in Rankin Williams gym.

"I regret that more people in the community didn't get to know him," Hibler said.

Campbell was born Oct. 15, 1933, at McAlester and graduated from McAlester High School in 1951.

He graduated from Southeastern Oklahoma State University in Durant in 1958. He received master's and doctor's degrees from the University of Oklahoma in 1964 and 1970 respectively.

After teaching and coaching in Amarillo, Texas, and Moore schools, Campbell became principal at Moore High School. He was then assistant superintendent of Moore schools for five years.

For five years prior to being named Dr. Al Harris' replacement at SWOSU, Campbell was superintendent at Western Heights in far west Oklahoma City.

At-risk facility nears completion

University and DHS joint efforts benefit youth

Construction is underway on a new 9,000 square foot facility for at-risk teenagers at Foss Lake in western Oklahoma.

The project, Foss Lake Youth Project, is a joint effort between Southwestern Oklahoma State University and the Department of Human Services of Oklahoma. Young boys, ages 12 through 16 who have been identified by the court system as at-risk teenagers, will be housed at the facility which is expected to be completed in April 1995. The year-round program with active supervision on a 24-hour basis should be operational by July 1, 1995.

Dr. Ken Rose, chairman of the Health, Physical Education and Recreation Department at SWOSU and a proponent of the facility, said the project has been in the works for over four years. Rose said strong support by western Oklahoma legislators, area schools, Foss Lake Association and area residents has been very instrumental in the project becoming a reality. Site of the facility is approximately 16 miles west of Clinton in the southwest area of Foss Lake.

The DHS is building the facility, while SWOSU will be running the day-to-day operations. SWOSU students in several areas will be actively involved in the program through various internships. Such areas as special

education, HPE & R and psychology will have students becoming immediately involved. In the future, other disciplines such as music therapy, nursing and arts and sciences could become involved in the program.

"This will be a unique learning environment for our students which will allow them to experience an early intervention program which has been successful in redirecting at-risk youth," said Dr. Dan Dill, dean of the School of Arts and Sciences at SWOSU and another backer of the project.

The project came as a result of the Tenkiller Lake project which was built in eastern Oklahoma for young boys in that area. That project has been quite successful.

Dill pointed out the Lake Tenkiller project has an incredible 94% success rate compared to a national average of only 5% for other types of juvenile correction programs. The boys in the program will

be non-violent offenders and will not necessarily have had criminal charges filed against them. The courts will refer many of the participants, but schools or parents will also be able to recommend youngsters. The DHS will screen the candidates.

There are three main components to the program. One is to build self-esteem and self-worth in the youngsters plus develop their communication skills. Another intent is to improve academic skills, while the final component is consultation with parents. There will be living units on site where parents can stay for a short period of time.

Maximum occupancy rate for the Foss Lake Youth Project will be 12. Stu-

dents will stay 60 days. A total of 6 boys will start the program and, after 30 days, six more boys will be brought to the program. The rotation will continue year-round. After leaving the program, the boys will be monitored daily for another 60 days by a state juvenile justice worker. Then after that 60 days, the teenagers will be monitored occasionally for another year.

The FLYP and surrounding area includes 17 acres. Rose said the project is an economic benefit to the area. Construction of the facility is around \$600,000, while the annual operating budget will be around \$500,000.

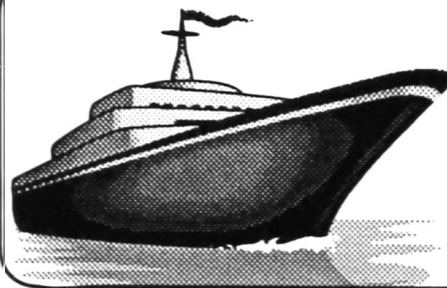
A memorial scholarship has been established in Dr. Campbell's name.

Hibler inducted into Oklahoma Higher Education Hall of Fame

Southwestern President Dr. Joe Anna Hibler is one of 10 Oklahomans who have been chosen as the first inductees into the Oklahoma Higher Education Hall of Fame.

Dr. Hibler is in her fifth year as president of Southwestern. The Leedey native graduated from SWOSU in 1960. She received her master's degree in 1961 from Oklahoma State University and earned her doctorate in 1971 from the University of Oklahoma.

She started work at SWOSU in 1965 when she joined the School of Business faculty. She served as chairman of the Office Administration and Business Education Department from 1978-82 and

then served as Dean of the School of Business from 1982-86. Later in 1986, she was named Executive Vice President for Academic Affairs, a position she held until 1990 when she was named Southwestern's 15th president.

Dr. Hibler is Oklahoma's first woman college president in 56 years. She is well-respected across Oklahoma and is very active in state and community civic affairs.

Assistant principal's dissertation named outstanding in national competition

The award was presented to Dr. Mouse at the mid-February NASSP convention held in San Antonio, Texas. Her dissertation, "The Effect of Gender on the Perceptions of

Collegiality Between Principals and Assistant Principals," to complete her doctorate was named the best paper among all assistant principals in the United States.

Dr. Mouse earned her undergraduate degree at SWOSU in 1985 and completed her master's degree, also from SWOSU, in 1987. She completed her doctorate at the University of Oklahoma in 1994.

Dr. Mouse was also named NASSP Assistant Principal of the Year for Oklahoma in 1994. She currently works in the Mustang School district.

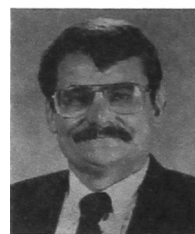

Exchange students enrolled in courses

Thirteen students represent France and Belarus

Southwestern has 13 foreign exchange students on the Weatherford campus during the 1994-95 academic year.

The students are participating in the SWOSU student exchange program directed by faculty member Dr. John Ludrick. Southwestern has two students, Rochelle Dodoo of Moore and Kevin Benoit of Lawton, who are currently in Paris, France, this year as part of the exchange program.

The foreign exchange students on the SWOSU campus this year are from Belarus and Paris. Each of them enroll in a minimum of 12 hours of course work. One of the students, Inna Maslenitsyna of Tuva, Russia, is serving as a teaching assistant assigned to the School of Education, language arts and social sciences. She is taking courses as well as teaching two courses.

Anna Vikulova, Andrey Kalashnik and Irina Metslushko are returning for a second year, while Olga Lenskaya, Yekaterina Zayash, Igor Strelkov, Ivan Lapuka and Veronica Luzkova are first-time exchange students from Belarus. Zayash and Strelkov were host families for SWOSU students who were in Minsk, Belarus last year.

Claire Blin, Vanessa Fiaud, Helene Racine and Florence Colzy are all from Paris are attending as part of the exchange contract with Sorbonne Nouvelle in Paris.

The following are brief tidbits of information on the foreign exchange students at SWOSU:

Claire Blin of Paris, France—speaks Russian, Belarussian, English, German and French; major is English; work experience includes technical translator, interpreter and librarian.

Florence Colzy of Palaiseau, France—speaks French, English and Spanish; major is English; work experience includes taking care of children and teenagers and being a theatre hostess.

Vanessa Fiaud of St. Remy les Chevreuse, France—speaks French, English and German; major is American sociology;

work experience includes hostess and tutoring children.

Andrey Kalashnik of Minsk, Belarus speaks Russian and German; major is English and German; work experience includes translating and interpreting for foreign visitors.

Ivan Lapuka of Minsk, Belarus—speaks Russian, Belarussian, English and German; major is international relations; work experience includes counselor and sports organizer at a children's camp.

Olga Lenskaya of Minsk, Belarus speaks Russian, Belarussian, English and French; major is English; work experience includes working with children and secretarial.

Veronica Luzkova of Minsk, Belarus—speaks Russian, Belarussian, English, Italian and German; major is English; work experience includes secretary, interpreter and nurse.

Irina Metslushko of Gomel, Belarus—speaks Russian, Belarussian, English, German and Italian; major is English; work experience includes secretary, teacher, interpreter and tutor of English.

Helene Racine of Bois, France—speaks French, English and Spanish; major is English and Spanish; work experience includes a summer job at an American attraction park as a clerk in Paris.

Igor Strelkov of Minsk, Belarus—speaks Russian, English and German; major is English and German; work experience includes summer camp counselor.

Anna Vikulova of Minsk, Belarus—speaks English, Russian, Belarussian,

Eleven gridsters honored by OIC

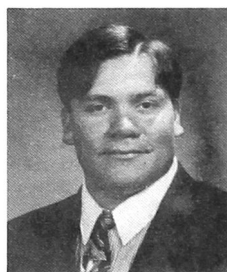
Two Southwestern Oklahoma State University football players have been named to the 1994 Oklahoma Intercollegiate Conference first team, while three players were named to the second team and six honorable mention.

Tight end Junior Lowden of Tecumseh and linebacker Yohance Brown of Altus were the Bulldogs honored on the first team.

Lowden was an NAIA All-American in 1992 but missed the 1993 season because of a knee injury. The 6-4, 259 pound junior was the Bulldogs' second-leading receiver this past season. He caught 36 passes for 431 yards and 4 touchdowns. His longest reception of the season came in the final game against Langston on a 65-yard touchdown pass from quarter-

back Grant Pitt. Lowden was also an OIC first-teamer in 1992.

Brown was the Bulldogs' leading tackler for the second straight season. The 5-11, 235 pound sophomore has been a

dominating force on the Bulldog defense. He led the team this season with 110 total tackles, 66 of them being solo tackles. Brown had 1 quarterback sack, 3 pass

breakups and 1 fumble recovery. Brown was also an OIC first-teamer last season.

Honored on the OIC second team were senior offensive lineman Shane Ellick of Welch, sophomore wide receiver Craig Schlessman of Oklahoma City (PC North) and senior defensive lineman Garrett Davis of Midwest City (Carl Albert).

Southwestern's honorable mention selections included defensive back Michael Walker of Oklahoma City (PC North); linebacker David Wells of Ponca City; tight end Tim Martin of Weatherford; offensive lineman Jay Buck of Midwest City (Carl Albert); wide receiver Mark Folks of Midwest City (Carl Albert) and quarterback Grant Pitt of Oklahoma City (PC North). All are seniors.

Women's inaugural cross country team formed, two placed in national meet

Southwestern Oklahoma State University had a women's cross country team for the first time ever in 1994, and two of the team members headed to the NAIA women's national meet after qualifying in the top ten at the Oklahoma Intercollegiate Conference meet in late October 1994.

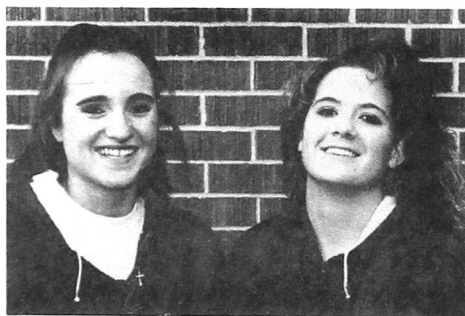
Coach Kevin Lawler and runners Alisha Williams of Burns Flat and Kendra Errington of Amarillo, Texas participated in the 15th annual national meet held at the University of Wisconsin-Parkside on Nov. 19, 1994. Williams placed 268th and Errington 316th out of 329. Williams had

a time of 22:03, while Errington finished at 24:45.

Lawler said he is extremely proud of Williams and Errington as well as the entire team. Since this was the inaugural year of the program and the final decision to start the program was not made until late this summer, Lawler was unable to

spend much time recruiting. All of the team members this year had been out of cross country for at least one year.

Puget Sound University of Washington won the team title, while Cari Rampersand of Simon Fraser University turned in the best time of 17:51.

NAIA standing in transition, moving to NCAA Division II

SWOSU Athletic Director Cecil Perkins announced that the Weatherford university will be applying for membership in the National Collegiate Athletic Association (NCAA) Division II.

Southwestern has been a long-time member of the National Association of Intercollegiate Athletics (NAIA).

Perkins said SWOSU began the process in Dec. 1994. The university will go through a three-year "probationary" period starting in the fall of 1995 with full membership expected sometime in 1998. Until then, it is expected that SWOSU will maintain dual membership in the NAIA and NCAA.

The thrust for the move, according to Perkins, was the status of NAIA Division I football. Only 35 schools played in that division in 1994, and that number will drop in 1995. At the recent NAIA annual meeting, the organization voted to maintain its two divisions of football instead of combining into one. Scheduling had become a problem for the Bulldogs.

Basketball teams qualify for playoffs

It's always nice when one of the SWOSU basketball teams qualifies for the NAIA national tournament, but this year was great because both the men's and women's squads qualified for their respective national tournaments.

George Hauser's Bulldogs qualified for the tourney for the first time since 1977. Things started out great for the Bulldogs as they led their first-round opponent, The Master's College, by three points at half-time. But, the California school shot 65% in the second half and rallied to defeat the Bulldogs, 86-72.

Southwestern had advanced to the NAIA tourney in Tulsa by winning the Oklahoma Intercollegiate Conference post-season tourney. The Bulldogs thrashed USAO, 76-56, in the finals. SWOSU had finished in second place during the regular season.

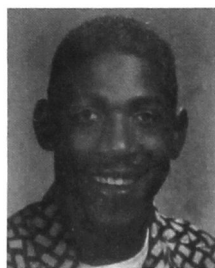
Cal Clinton of Oklahoma City (Northeast) was named to the men's first team, while Ronnie Boyce of Oklahoma City (Douglas) was honored on the second team. Damion Porter of Chicago, Ill. and Keson Coney of East St. Louis, Ill. were honorable mention selections.

Clinton was named OIC Player of the Week once this season. He averaged 12.9 points, 5.6 rebounds and 3.6 assists. Clin-

ton has been a player his teammates have depended on all season in clutch situations.

Boyce led the Bulldogs with 13.9 points a game, 3.6 rebounds, 2.9 assists and 2.0 steals a game.

represented SWOSU as they advanced to the NAIA Final Four. Southwestern defeated St. Vincent PA (78-52), Xavier LA (70-46) and Simon Fraser BC (67-61) to advance to the semifinals.

This year's tourney was a special one for Oklahoma because three of the Final Four teams were from the Sooner state. The Lady Bulldogs met Southern Nazarene OK in one semifinals matchup while SWOSU's sister school Southeastern met Lipscomb TN in the other contest. The Lady Bulldogs led most of the game but

SNU rallied and came up with several key plays in the final two minutes to defeat SWOSU, 54-48. SNU then won the national title the following night by defeating Southeastern.

Southwestern's women advanced to the national tourney with an impressive 73-55 road victory over Southeastern in the OIC championship. The Lady Bulldogs shared the regular season conference crown with Southeastern. This was the 5th straight year that SWOSU has either won or shared the OIC title and is also the only school to have appeared in all six national tourneys which have been hosted by the city of Jackson, Tenn.

Southwestern can also boast about another first team All-American as Lisa McMullen received the honor during the 1994-95 year. Her teammates Shirley Harmon of Jennings, La. and Yumecca White of Dallas, Texas were named on the second team. Honorable mention selections were Andreana Robinson of Ottawa, Canada and Vivian Johnson of Long Beach, Calif.

McMullen led the Lady Bulldogs by averaging 22.6 points a game. She also hit 94 three-point shots in only 24 games and set the school's record with nine three's in the OIC title game versus Southeastern. She averaged 4.9 rebounds and assists along with three steals a game.

This 5'6" senior was named OIC Player of the Week three times this season along with becoming the first Southwestern player to be named NAIA National Player of the Week.

Harmon, a 6'3" senior, was third on the team in scoring with 11.5 points and second in rebounding at 6.3 and led the team in blocked shots with 25.

White tore up a knee in the second-to-last regular season game. The guard was leading the team in assists with 5.3. She was averaging 7.6 points a game and 3.3 rebounds and was an OIC honorable mention selection last season.

All-America Scholar-Athletes named

Two football players have been named to the 1994 NAIA Division I Football All-America Scholar-Athlete team.

Quarterback Grant Pitt of Oklahoma City (PC North) and strong safety Brad Owen of Burkburnett, Texas, were the two Bulldogs named to the nine-member squad. Honorees must be a junior or senior starter during the season and must have at least a cumulative grade point average of 3.50 on a 4.00 scale.

Both Pitt and Owen were repeat selections from the 1993 honor squad. Pitt was also on the 1992 All-America Scholar-

Athlete team. Pitt has a 3.63 GPA with a major in biology, while Owen's GPA is 3.60 with a major in pre-physical therapy.

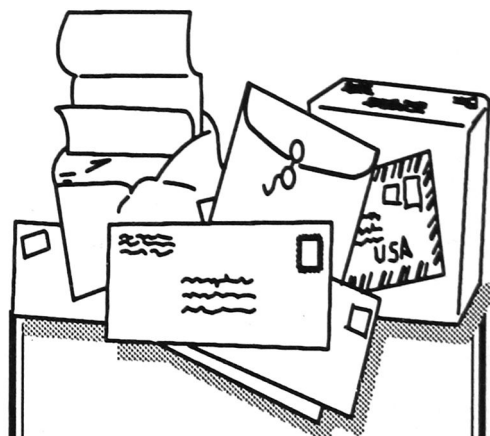

"We feel our service will be a lot quicker plus we have a variety of items to offer," Taylor said.

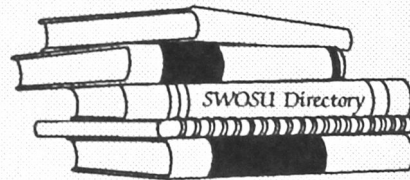
The traditional cafeteria line does remain but three other lines have been added. A specialty line features rotating foods, while a deli line offers light foods using 95% fat-free meats. A grill

Formerly a partial depository

Al Harris Library qualifies as 15th government publications depository

Southwestern Oklahoma State University's Al Harris Library on the Weatherford campus is now an Oklahoma Government Publications Depository.

According to library director Beverly Jones, Southwestern recently became the 15th depository in the state of Oklahoma. The depositories are located in libraries around the state including both public and academic libraries.

Created by legislation in 1978, the Oklahoma Publications Clearinghouse of the Oklahoma Department of Libraries was charged with the responsibility to establish an Oklahoma government publications depository library system for use by the citizens of the state of Oklahoma, to collect state publications from every agency and to retain and preserve permanent copies of all such publications.

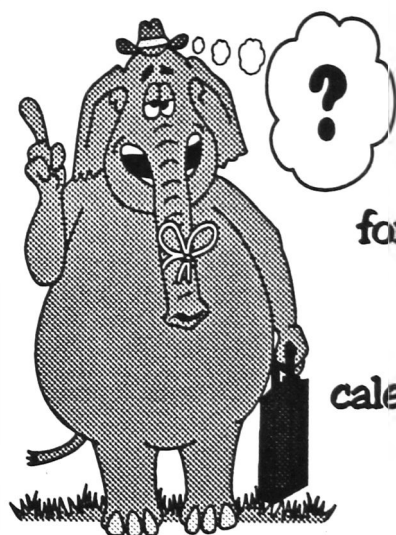
Publications received by the Clearinghouse from state government agencies are then distributed to the network of 15 depository libraries as well as the U.S. Library of Congress. Some examples of state publications

include maps of Oklahoma, Oklahoma Almanac, Oklahoma Directory of Manufacturers and Processors, "Oklahoma Today" magazine, Oklahoma Statutes, Oklahoma Water Atlas and Who is Who in the Oklahoma Legislature.

The library has also been a partial depository library for federal publications since 1958. According to Reference Librarian Carolyn Torrence, the library currently subscribes to approximately 20% of the materials offered for selection.

A few of the better known items received through the program are Index Medicus, U.S. Code, Congressional Record, U.S. Reports and Census materials.

Torrence said electronic databases are fast becoming the format of choice for information generated by the U.S. Government. Eighteen titles in CD-ROM format will be loaded on the library network during the fall of 1995. The library has received over 50 titles in floppy and CD-ROM format.

"Building on Our Heritage" campaign completed

It started in late 1991 with a goal of \$1.3 million and a challenge goal of \$2 million. Now some three and one-half years later, the "Building on Our Heritage" Foundation drive at Southwestern has been completed.

Alumni and Development Director Jim Waites said the successful drive ended with a final tally of \$2,767,163. Of that amount, 73% of the gifts were cash gifts.

Weatherford resident Ed Berrong, who serves as the foundation's president for the University, is very pleased with the results.

"The foundation board believes this result indicates a strong loyalty, trust and faith of the alumni and friends of Southwestern in the administration of the university and its future as a meaningful and significant part of higher education in Oklahoma," Berrong said. "All of us intend to make the various foundation programs work in behalf of the benefactors, for recipients and for the university and its influence for good."

Southwestern's drive had four phases. The first phase centered on SWOSU Foundation board members, faculty and staff and resulted in gifts of \$820,260. The second portion was the Weatherford/Custer County area which resulted in \$309,799. The largest phase was the alumni and friends portion which amounted to over \$1 million. The fourth and final phase centered on corporations and foundations with results of \$177,564. Other various gifts resulted in \$276,303.

Serving as overall chairpersons of the various phases were Weatherford residents Dr. H.F. Timmons and Ken Reid, and Clinton residents Paul and Dottie Flick.

"We are so pleased with the generosity of our alumni and friends," Southwestern President Joe Anna Hibler said. "Considering this was our first-ever formal capital campaign, the response was almost overwhelming."

"This drive has built a foundation for the future growth of Southwestern," Dr. Hibler added. "The availability of external funding gives the university the flexibility we need to address needs that cannot be met with our state dollars."

Waites also expressed his apprecia-

tion to everyone who had a part in the successful drive. He said the Foundation has and will continue to be very supportive of various activities, services and endeavors at SWOSU.

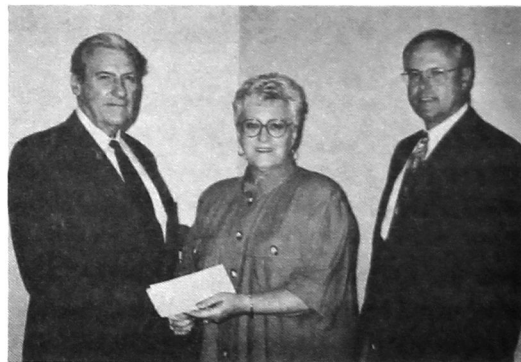
He said the Foundation awarded 191 scholarships and grants totaling \$102,654 and provided university support in the amount of \$188,920 in 1994. He said the Foundation has been very active in events

such as Higher Education Day at the State Capitol, the SWOSU Student research and Scholarly Activity Fair, the Bernhardt Academic Excellence Faculty Award and many other events on the Weatherford campus.

Waites said the "Building on Our Heritage" drive was not a one-time effort but just the beginning of continuous fund-raising efforts.

1994 contributions made to the Southwestern Foundation

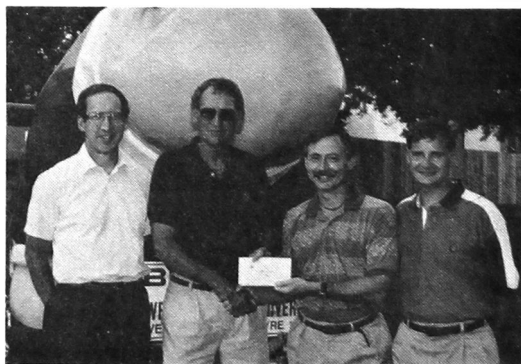

Chapman, Fry inducted into Hall of Fame

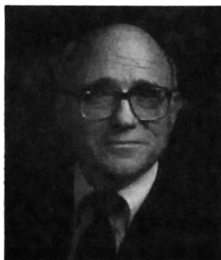
Dr. Charles Chapman, professor of music and the chair of the Department of Music at Southwestern Oklahoma State University and Paul Fry, professor emeritus of music at SWOSU, are two of the three music educators named to the 1995 Oklahoma Music Educators Association Hall of Fame.

The OMEA Hall of Fame was established in 1987 to honor persons who have achieved prominence in Oklahoma music education through exemplary teaching and service to the profession. A total of 40 persons have previously been selected for this honor. The OMEA numbers some 1300 music teachers.

Chapman taught in the Vinita public schools before joining the faculty at Southwestern in 1962. For the past seven years he has served as chair of the Department of Music.

During his 32 years at SWOSU, he has served as president of the Oklahoma Music Educators Association, presi-

dent of the Oklahoma Choral Director's Association and president of the seven-state Southwestern Division of the Music Educators National Conference.

He is presently editor of *Oklahoma Music*, OMEA's professional journal; Church Music Representative for the Oklahoma Choral Directors Association, Oklahoma District Governor of the National Association of Teachers of Singing and Governor of the Texoma Region (Texas, Okla. and N.M.) of the National Association of Teachers of Singing.

In 1980 he was named Director of Distinction by the Oklahoma Choral Directors Association, and was chosen by OSSAA as Outstanding Oklahoma Music Educator in 1992. He is only the second active teacher to be honored by the association.

Paul Fry taught instrumental music in the Waukomis, Okeene and Clinton High Schools before joining the faculty of Oklahoma College for Women (Chickasha) in 1963.

Fry moved to SWOSU in the fall of 1966 and completed his teaching career there. At Southwestern he taught music theory and applied trombone for 19 years before retiring in 1985. He was recalled from retirement for two years to serve as adjunct professor of music theory.

He also is an active arranger, and was responsible for many arrangements performed by the Southwestern wind ensemble, marching band and concert band.

Adjunct professor holds strong ties to university

Southwestern adjunct instructor Marilyn Witcher of Oklahoma City is the new president of the South Central Division of the Music Teachers National Association.

Witcher is a graduate of SWOSU. She commutes 126 miles round-trip twice a week to teach piano at the university, although she still operates a large private piano studio in Oklahoma City and is still active in professional organizations.

The Geary High School graduate is a past president of the Oklahoma Music Teachers Association. She is a member of the MTNA House of Delegates and the OMTA Executive Board and Administrative Committee as well as other various professional organizations. Witcher holds OMTA and MTNA certification in piano and has been a workshop clinician

and adjudicator of auditions.

Witcher has a long affiliation with SWOSU. Her parents, Robert and Mildred Stegall of Geary, both had long careers as public school teachers after graduating from Southwestern. It also seemed natural that Witcher would attend Southwestern. She had witnessed her father's graduation from the Weatherford school and played saxophone in the college band at her mother's commencement. The opportunity to play in the Southwestern band while still in high school arose because she studied privately with the late SWOSU Professor E.E. Mason.

Witcher received her education degree from Southwestern when it was known as Southwestern State College. She has also received bachelor and mas-

ter of music degrees from another school.

"I remember having to get a Social Security number because I sometimes accompanied vocal and instrumental soloist and ensembles for 40 cents an hour (the prevailing wage for student labor at the time)," Witcher said.

Witcher said her career plans never included a return to Southwestern as a teacher—until the opportunity arose in the fall of 1993.

"It just seemed like the thing to do," Witcher said. "And I'm glad. I love it."

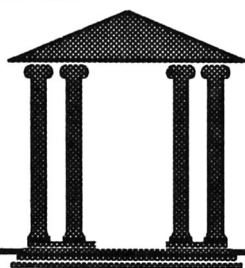
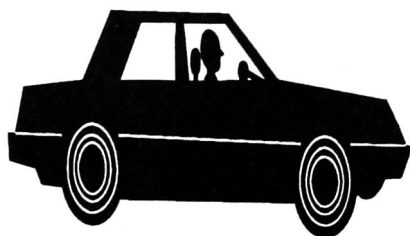

Southwestern maintains lowest administrative costs in Oklahoma

Southwestern, with campus locations in Weatherford and Sayre, has the lowest administrative costs of all colleges and universities in the state of Oklahoma, according to a recent study by the Oklahoma State Regents for Higher Education. Southwestern's 7.6 % of the total budget is the lowest figure among all higher education institutions. The University of Oklahoma and Oklahoma State University each had 7.9% figures.

Other administrative figures for Southwestern's five sister regional institutions are: Northeastern State 12.1%; University

of Central Oklahoma, 11.9%; East Central, 11.6%; Southeastern, 10.7%; and Northwestern, 10.5%.

"Southwestern has had a long history of devoting the majority of its state allocation to the instructional function of the university," SWOSU President Joe Anna Hibler said. "We continually strive to keep our administrative costs as low as possible, even with the additional federal mandates that we are currently facing.

On a state-wide level, administrative costs are 10.3% of the total 1994-95 Oklahoma college and university operating budgets.

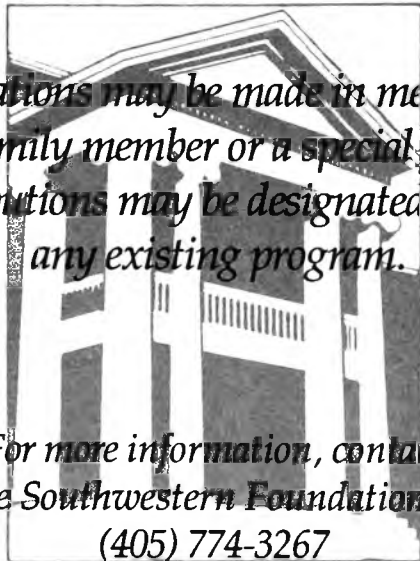

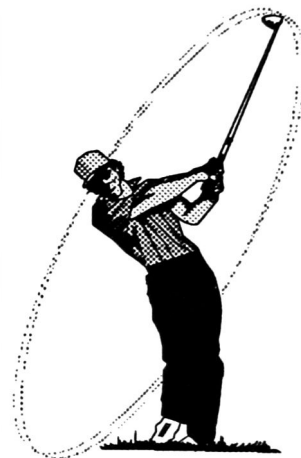

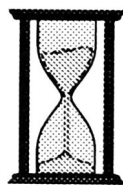
