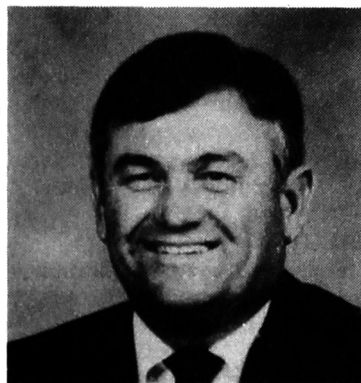

Two alumni from Southwestern Oklahoma State University at Weatherford will be inducted into the Distinguished Alumni Hall of Fame during Homecoming activities on Saturday, October 13, 1990.

The two alumni are Bill Brewster of Marietta, Okla., and Ronald Scott of Houston, Texas.

The two honorees will be recognized at the Southwestern Alumni Luncheon at 11:30 a.m. in the Student Union Ballroom with formal inductions scheduled at half-time of the 2 p.m. homecoming football game. Dr. Joe Anna Hibler, Southwestern Oklahoma State University President, will present each with a plaque.

A color portrait of each honoree will be displayed in the Distinguished Alumni Hall of Fame located in the Southwestern Oklahoma State University Stu-

dent Union.

In addition to honoring Brewster and Scott at the luncheon, Southwestern alumni blankets will again be presented to the alum who travels the longest distance, alum with the most children who graduated from SWOSU and the oldest alum.

Tickets for the luncheon are \$6 and must be purchased in advance. Tickets are available in the SWOSU Alumni Office located in the Public Relations Office in the Administration Building, Room 201.

Also, other activities scheduled during the homecoming weekend include reunions of the classes of 1920, 1930 and 1940.

uate, has had a rapid climb in the Oklahoma legislative ranks. He has served as chairman of the House's Economic Development and Business and Commerce Committees. He also served recently as head of the House's Tourism and Recreation Committee.

Brewster has also served on the state legislature's special joint committee on International development. The committee focuses on boosting Oklahoma's economy by focusing on increasing cultural and educational exchanges among Oklahoma and other nations.

On the national level, Brewster has played a significant role in energy industry issues as chairman of the South/West Energy Council. The council is an organization of state legislators from the energy-producing states whose activities include working with Congress to encourage domestic energy production and to ensure the nation's long-term energy security. Brewster is also the first Oklahoman to chair the Energy Committee of the National Conference of State Legislatures (NCSL). The NCSL is an organization of state legislators and legislative staff devoted to improving the state legislatures' effectiveness.

Representative Brewster's extensive business experience includes being president and chief executive of two small businesses. He also served 10 years on a bank's board of directors. He currently co-owns a real estate firm.

His agricultural background includes co-ownership of the Brewster Angus Farm since 1968. He is a past president of the Oklahoma Angus Association and is an Oklahoma FFA Honorary State Farmer.

The lawmaker's long list of civic activities includes service as a school board member and a hospital board member. He is also a member of the Lions Club and has served the American Cancer Society. The Brewsters attend the Baptist Church.

Brewster, a registered pharmacist, was graduated from Southwestern in 1965 with a bachelor's degree in pharmacy.

He and his wife, Suzie, are the parents of three children: Karel, their oldest daughter and her husband, Brent Howerton, live in

Marietta. Their other daughter, Kecia, and son, Kent, lost their lives in a tragic airplane accident earlier this year.

Bill is presently running for U.S. Congressman of the Third District which is presently held by Wes Watkins who is running for Governor of Oklahoma.

RON SCOTT was born in Strong City, OK, and is a graduate of Cheyenne (OK) High School. He received his degree in physics and mathematics in 1957. He received a master of science degree in engineering mechanics in 1968 from the University of Alabama. He also received a master's degree in science, technology and public policy from Indiana University in 1971.

Ron retired from NASA in 1983 after 25 years of dedicated and rewarding public service. During his tenure with the NASA program, he was a part of many outstanding projects.

From 1957-1960, he worked with the Army Ballistics Missile Agency in missile development. He was a project engineer responsible for trajectory analysis and final flight tapes for missile 50 and 51. He was also the project engineer for Pershing I, responsible for performance and flight dynamics.

He served as project engineer from 1961-68 at the Aero-Astrodynamicis Laboratory during the preliminary design, development and launch of the Saturn V. He received a sustained superior performance award for original work on Lunar Logistics System utilizing the Saturn V. He developed a rapid convergence/optimization program for lunar descent and landing, adapting the "new" interactive guidance mode for flight path optimization.

During the late 1960s and early 1970s, Scott served as Chief of Performance in the Flight Mechanics Division. They formed an Advanced Systems Development organization to focus on major news systems for NASA, following the Apollo program. He managed a staff of approximately 30 engineers and a support contractor effort of 50.

He served on and supported organizationally agency-wide task teams and boards such as Space Shuttle Task Group and Space Station Source Evaluation Board

Athletic Hall of Fame schedule

Four former Southwestern athletes will be inducted in the Southwestern Oklahoma State University Athletic Hall of Fame on Friday, October 12, on the Southwestern campus in Weatherford. The banquet-ceremony will be held in conjunction with other homecoming activities on October 12 and 13.

The four honorees are: Orville Long, former teacher and coach at Cordell and National AAU wrestling champion at Southwestern; Kelli Litsch, four-time All-American basketball player and current assistant women's basketball coach at SWOSU; the late Travis Rhodes, a former SWOSU athlete and outstanding football coach in Oklahoma and Texas; and Robert (Bob) Henry, a former basketball-baseball athlete at SWOSU and principal at Portales (N.M.) High School.

Tickets for the 6:30 p.m. banquet are \$6 and deadline to purchase tickets is Wednesday, October 10. Tickets are available at the Southwestern Business Office, Public Relations Office and Athletics Office.

Inducting Long in the Hall of Fame will be Jerry Burrows from Cordell; Litsch will be inducted by Dr. Joe Anna Hibler, SWOSU President; Rhodes will be inducted by Dean Wild of Oklahoma City; and inducting Henry in the Hall of Fame will be Deck Woldt.

Mike Brown, former SWOSU football player and a member of the 1977 SWOSU Apple Bowl team under coach Otis Delaporte, will be the master of ceremonies. He is currently the co-owner of American Insurance Group in Weatherford.

ORVILLE LONG enrolled at Southwestern State in 1946 (following three years in the Navy). Orville continued the

Ron is married to Pat Hughes Scott who is from Tulsa. They have three children and three step children. Ron's mother, Alta Scott, lives in Cheyenne as well as his sister Tillie.

sports tradition begun in his native Geary, where he was a three-sport letterman. His wrestling career began in the fourth grade under former Southwestern wrestler Glen Dill. In high school he was coached by another Southwestern grad, Bob Stegall, and he placed second in State at 120 pounds.

As a member of Southwestern State's outstanding post-war teams from 1946-1950, Long lettered one year in wrestling, and three years in football and baseball.

His single year of wrestling under Coach Ross Flood culminated with honors. He twice brought the gold home to Southwestern when he was crowned champion at 155 pounds at both the state and national AAU wrestling tournaments.

Long served as captain of the 1949 football team, was chosen to the second team as All-Conference end and received the Foreman Award as the team's most valuable player (voted by the team members).

During the 1948 season, he set a record as the recipient of the longest completed pass and run for a touchdown (95 yards). That record still stands for both Southwestern State and the Oklahoma Collegiate Conference.

At the conclusion of that season in May, he joined the Hobart semi-pro team for the summer.

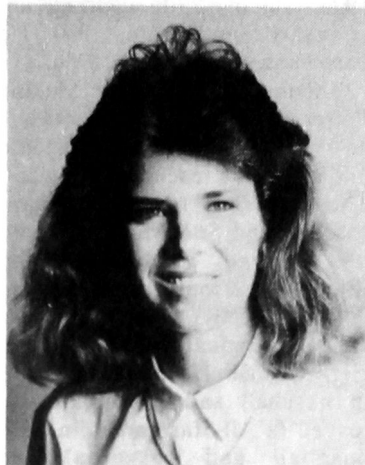
Long received his Bachelor of Science degree in 1950 and his Master of Teaching in 1962, both from Southwestern State University.

His teaching career began with one year at Caldwell, Kansas. During four years at Hinton, he was baseball coach, assistant football coach and industrial arts teacher from 1956-1960.

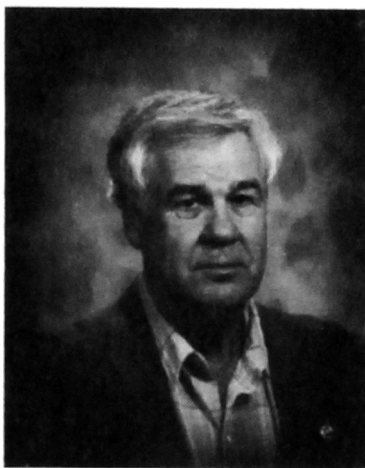
Teaching and coaching at Cordell from 1960-1988, he served as wrestling coach, assistant football coach and industrial arts teacher.

He established the all-grades wrestling program in the Cordell schools in 1963. (Cordell had not had a wrestling team since the early 30's). In 1970 he was honored as outstanding coach of the Western Oklahoma Wrestling Conference.

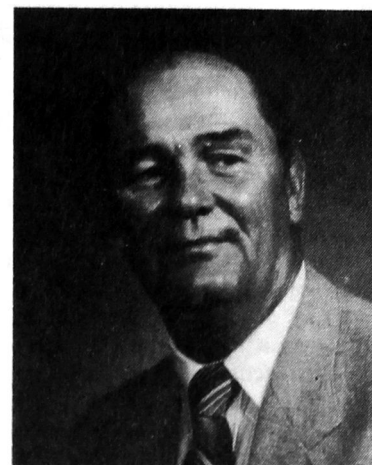
Long lives in Cordell, where he retired from teaching in 1988. His days are full with golfing, making



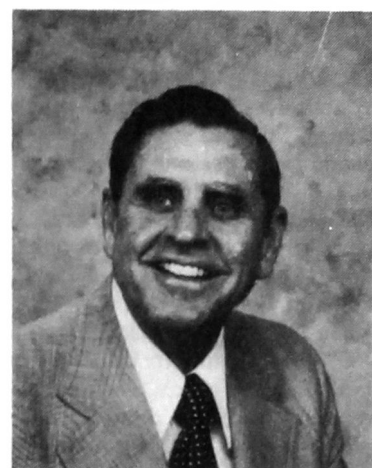

elaborate wooden bowls on the lathe and following his favorite sports teams.

His wife of 40 years, Joanne, is also a Southwestern graduate and a retired English teacher. They are the parents of three sons including Joe, the youngest, who is currently majoring in biology at Southwestern.

KELLI LITSCH is a graduate of Thomas High School where she was All-State and a member of the All-State girls basketball team.

Litsch is one of two females to be named to the NAIA All-American team four straight years. She played on three NAIA National Championship teams at SWOSU and has been SWOSU assistant coach on two others.

Southwestern records held by Litsch are: most points scored in season and career; highest point average in a season and career; rebounding records including most rebounds a season and career as well as highest rebounding average in a season and

career; most field goals scored in a career and highest field goal percentage in a season and career; and most free throws scored in a game, season, and career and highest free throw percentage in a season and career.

Litsch was a member of the president's honor roll each semester except one while working on her bachelor's and master's degrees. She was on the dean's honor roll that one semester. She is the daughter of Mr. & Mrs. Jim Litsch of Fay.

TRAVIS RHODES was born in Gould and graduated from Hollis High School in 1938. He was an All-State football and basketball player in high school and played on the 1937 state championship basketball team.

He played football at Louisiana State University his freshman year. He transferred to Southwestern in 1939 where he was first string and All-Conference tackle.

He was also captain of the SWOSU basketball team. He was also named to Who's Who in American Colleges and Universities.

He entered the United States Air Force in January, 1942, serving four years and eight months with 18 months European Theatre. He was discharged as a Major in 1946.

As a coach, Travis spent 17 years as a member of the Oklahoma Coaches Association, serving one term on the Board of Control. In 1946-1950, he was head football coach, basketball and track coach and served as interim principal at Hinton. In 1950-1951, he was assistant football coach under Dean Wild at Watonga. From 1951-1957 he was at Tonkawa as head football coach. During this time he won two state championships, one in 1952 and one in 1953. This was the first class B team to win "back to back" titles. In 1954 he was one of the Oil Bowl coaches for Oklahoma at Wichita Falls, TX.

He was at Blackwell from 1957-1961 as athletic director and head football coach. He won one regional and two district championships in 1958. His team was 4A Conference Runnerup for state championship in 1959. While in Blackwell he also received the Citizenship Award from the Blackwell Chamber of Commerce for outstanding service to the community.

He then moved to Sand Springs and was head football coach there from 1961-1963. In 1963 he had an undefeated season, received the Award of Appreciation for the athletic program, and was selected as Coach of the North All Star Football game.

Rhodes then moved to Grand Prairie, Texas, and was head football coach from 1963-1968. In 1963, his team was district champions for the first time ever. In 1968 he became the assistant principal at the high school until 1974.

In 1974, he moved to Garland, Texas, as director of Transportation and Media for the Garland Independent School District where he stayed until May, 1978, when he retired due to failing health.

Rhodes was inducted into the Oklahoma Coaches Hall of Fame in 1980. He moved to Clinton,

Okl., on his 39th wedding anniversary, on Nov. 6, 1980. He passed away on July 4, 1986.

Rhodes was married to Maxine Potter of Thomas. Mrs. Rhodes is a 1937 Southwestern graduate and she was a teacher of 37 years. They reared two daughters, Marilyn and Sue Ann, who both are college graduates. The Rhodes have four grandchildren.

BOB HENRY was born near Ada and graduated from Amarillo High School. He made All-State in baseball and basketball. He played in All-Star games in both baseball and basketball. In 1946-47 he played on the Amarillo high basketball team which played in the semi-finals of the state tourney both years. The 1947 team was the winningest team in AHS history until 1986 when AHS won their first state title.

He received a basketball-baseball scholarship to the University of Texas in 1947. He played semi-pro baseball at Elk

City during the summers of 1947-49. In 1949, he pitched Elk City to the National Semi-pro tournament in Wichita where he made All-Tournament. In 1948 he pitched for Sweeney, TX semi-pro team in the Houston Post Tournament where he pitched a no-hit game, the only no-hit game in the 25 year history of the tournament.

Henry transferred to SWOSU in 1948. He played basketball and baseball. His baseball career included a conference championship in 1949, All-Conference in 1949 and he pitched a no-hitter against Central State striking out 22 batters. He signed a professional baseball contract with the Chicago Cubs in 1950 and played with a Cubs triple A team.

He returned to SWOSU in 1950 to complete his education and play basketball. During his senior year, he was All-Conference and led the team in scoring and rebounding. The Bulldogs won the Sunshine Tournament at Eastern

New Mexico University in Portales, and he was named to the All-Tournament team.

He coached eight years in Oklahoma at Leedey, Putnam and Carnegie where his team won 20 or more games each season of his eight years. He moved to Clovis (N.M.) High School from 1960-68 where he had winning seasons and coached the New Mexico All-Star team in 1954.

Henry closed out his coaching career in Clovis in 1968 and moved to Plainview, Texas, as assistant principal and later high principal. He moved to Carlsbad (N.M.) High School as principal from 1979-84. Carlsbad was chosen as one of the two outstanding high schools in 1982-83. He became high school principal in Portales, N.M., in 1984 where he still holds the position.

Henry has two daughters, Kathy Strong of Weatherford and Susan Huckleberry of Phoenix, Arizona, both SWOSU graduates.

Alum retires at Central State

Dr. Gene D. McPhail, professor of administration, vocational, adult and higher education at CSU retired after 21 years in the classroom at CSU.

McPhail had been a member of the CSU faculty since 1969 and taught for 38 years in Oklahoma.

As director of the CSU College of Education's program of school administration, McPhail worked primarily in teacher and administrator preparation.

McPhail, a native Oklahoman from Mountain Park, in Kiowa County, spent two years in the service in Germany from 1950-1952. He had been teaching ever since.

He received his bachelor's degree in biology education from Southwestern Oklahoma State University in Weatherford and received his master's degree in school administration and his doc-

torate in general administration from the University of Oklahoma.

McPhail plans to return to his 80 acre farm in Crescent after retiring and help his son in a

repair shop.
"I have owned a farming/cattle raising operation for 18 years now and hope to spend my retirement years there," he said.

O'Hara takes Ardmore job

Richard O'Hara, superintendent of Weatherford Public Schools for nearly a decade, has accepted the position as superintendent of schools in Ardmore effective July 1, 1990.

O'Hara said the move to Ardmore was a career move and that he was getting to the age that if he was going to make a move, now was the time.

Ardmore is a town of about 25,000 people with about 3,500 students and a staff of 224. The Class 4A school system has a budget of more than \$10 million. Weatherford's 3A system has about 2,000 students and a budget of \$5.3 million.

O'Hara completed nine years as superintendent in Weatherford. He had previously served one year each as assistant principal and principal at the high school.

A graduate of Elk City High School, he graduated from Southwestern Oklahoma State University in 1968 with a bachelor's degree and in 1971 with a master's degree.

O'Hara said he appreciated the opportunity the school district had given him to serve as superintendent of Weatherford schools. He said he also appreciated the support the community and personnel of the system gave him.

"The Weatherford School District is one of the most progressive 3A schools," he said. "I hope there are some things better since we've been here," O'Hara said. "I think all areas get along better than they did."

He also listed the addition of several programs to the school system and the building programs as accomplishments during his tenure with the Weatherford Public Schools.

Three lady bulldogs named to academic squad

Three of nine players on the 1990 NAIA national champion Southwestern Oklahoma State University Lady Bulldog basketball team were named to the 1989-90 Academic All-District 9 Women's Basketball Team.

Representing the Weatherford university on the list were Shelly Mooter of Oney, Jackie Snodgrass of Ames and Kris Lorenz of Lomega.

Mooter, a 5-7 sophomore guard, played in all but two games this season. Mooter has a 3.51 grade point average and she is majoring in business education. Mooter averaged 5.3 points for the Lady Bulldogs. Mooter was a player who made very few mistakes as evidenced by her team-low 18 turnovers in 32 games played.

Snodgrass is a 6-0 sophomore forward. The Ames product played in all 34 games. She averaged 9.9 points and 4.6 rebounds per contest. Snodgrass was the team's leading field goal shooter as she connected on 135 of 204 shots for an impressive 66.2%. Snodgrass has a 3.37 grade point average and is majoring in physical education.

Also making the honor list was Kris Lorenz, a 5-10 junior forward. Lorenz averaged 8.3 points and 3.2 rebounds for the Lady Bulldogs. She was a 50% field goal shooter and a 78% shooter at the free-throw line. Lorenz has a 3.21 grade point average with a major in physical education.

Southwestern finished the season with a 30-4 record.

SWOSU 'Greeks' struggling to maintain identity

The system of social, Greek-named fraternities and sororities, once strong on the campus of Southwestern Oklahoma State University, has been struggling for most of the 1980s, say those in the dean of students office.

When classes open this year, two nationally chartered traditional fraternities on campus will carry on the tradition.

Two other fraternities, which have lost their national recognition, have been encouraged to continue as local organizations and try to rebuild to the point they can regain their charter.

The last two of sororities, Sigma Kappa and Alpha Gamma Delta, lost their charters from their national organizations during the last school year.

Dr. Kay Williams, dean of women, said the problems leading up to the charter cancellations were multiple. They were short of members and particularly of older members to provide leadership. She said they also had financial difficulties.

University officials have given many possible reasons for the decline in membership from expenses, to academic overload to competition with the service and professional organizations.

One even mentioned the 44-percent dropout rate between the freshman and sophomore years that cuts down on the number of fraternity pledges retained in the chapters to help provide leadership.

A recent sorority member commented that lack of belief in the system on the part of some administrators has not helped.

But officials also have indicated an interest in facilitating the rebuilding of the social fraternity chapters.

Williams said the university has no official role in promoting the organizations other than to see they meet the guidelines required of any recognized organization but that she and Steve Hilterbran, dean of men have been acting as faculty sponsors for the umbrella organizations for the men's and women's fraternities.

Dr. Fred Janzen, dean of student personnel services, said that

SWOSU is not alone among the regional universities to have a declining membership among the traditional "Greek" organizations.

"It's almost like there's a magic number of about 10,000 or so when there is a large enough pool of students for several fraternities to draw membership and compete with each other in the 'rah rah' atmosphere," Janzen said.

"We'd like to see a revival. Historically, the Greeks have provided a great deal of our leadership and a lot of our volunteers."

East Central State University in Ada, Oklahoma, has five fraternities and three sororities. Three of their fraternities, Phi Kappa Alpha, Sigma Tau Gamma and Phi Kappa Tau, are national fraternities. Zeta Pi Lambda is a local fraternity and Alpha Phi Alpha is a black fraternity. The three sororities are all national and they are Alpha Gamma Delta, Chi Omega, and Zeta Tau Alpha.

East Central officials stated that the sorority and fraternity system is an active part of the campus life. They have one rush week for sororities the week before the fall semester begins and rush week for fraternities after the fall semester begins.

Nevertheless, university officials are taking some steps to assist with a revival of the fraternities, officials in the dean of students office have said.

Janzen said he has directed Williams and Hilterbran to try to interest alumni of the organizations to take an interest in rebuilding them and acting as sponsors. Club sponsors usually must be full-time faculty members, he said, but these faculty members sponsor 60 to 80 organizations in any given year and may have unlimited time.

One sorority alumna who has been to some of the meetings declined to comment on the subject.

Hilterbran said that allowing the two men's groups without national charters to remain as local organizations is an innovation designed to "help them out". The office also is providing mailing lists and speaking opportunities, he said.

Only recently, Phi Delta Theta, now the strongest of the fraternities with about 30 members, lost its charter and had to rebuild, Hilterbran said.

"They worked real hard and they got it back."

But the men's dean said that in the six years he has been on the campus, membership for such organizations has been 10 to 15 students.

He attributed some of the problem to costs of the national organizations, and said that may be why some of the local service and professional fraternities have been doing so well.

One recent local sorority member commented that the costs were high and brought few additional activities.

Another said the decline is not due to lack of interest, "I know the students are interested. I hear it every day."

She indicated she felt there had been some lack of belief in such organizations from the university administration that may have hurt the organizations in the past.

"We'd like to see a revival," said Dr. Joe Anna Hibler, new president of the college. "Historically, the Greeks have provid-

ed a great deal of our leadership and a lot of our volunteers."

"I think they are important to the campus. They give students a way to develop social skills and build friendships," she said, adding that it has been proven that students who become part of the social fabric of a university are more likely to stay in school.

Mike Brown, local insurance agent and a member of Phi Delta Theta for four years in the 1970s, said four fraternities and three sororities were active when he was a student. The fraternities had up to 45 members each and he said he thinks the sororities averaged 25 to 30 members.

A large number of those members were class officers or representing one organization or the other in the student council.

"It was definitely worth it," Brown said. "We had lots of activities and we made lots of friends. It wasn't just social. We helped with a lot of things like Special Olympics."

At that time, Brown said he felt that the administration of the school neither helped nor hindered the fraternities and he felt the dean of women at the time (the late Freda Johnson) "probably helped them (sororities) a lot."

Janzen said that in recent years, it has been a "real struggle" for the organizations to maintain sufficient membership to remain viable organizations.

Hibler becomes fifteenth president

Dr. Joe Anna Hibler became the 15th president of Southwestern Oklahoma State University on July 1, 1990.

Hibler, SWOSU executive vice president for academic affairs and of the university since 1986, became the first woman college president in Oklahoma in some 55 years. Kate Galt Zaneis served as president at Southeastern in Durant during the 1930's.

Hibler's appointment was made April 20 and she was formally introduced on April 23 at a community-campus reception held in the Student Union on the

Weatherford campus. Oklahoma College Regent Wayne Salisbury of Clinton introduced Hibler to a huge crowd of well-wishers.

The 1957 Leedey High School graduate earned her bachelor degree in business education from Southwestern State College in Weatherford in 1960. She then received her master degree in business education in 1961 from Oklahoma State University at Stillwater. Then, in 1971, she completed her doctorate, also in business education, at the University of Oklahoma in Norman.

Before becoming EVP at South-

western, Hibler served as Dean of the School of Business at Southwestern from 1982-86. She was chairman of the office administration and business education department at Southwestern from 1978-82. She was a professor in that department from 1965-78.

Before coming to Southwestern, Hibler was a business teacher for Altus Public Schools and Altus Junior College from 1961-65.

Hibler replaces Dr. Leonard Campbell who retired from Southwestern on June 30, 1990.

Morrison was nominated for the award by Brenda Williams, Chamber of Commerce executive vice president. About Morrison, Williams has only good to say. "Pat has the ability to pull people together in service to others by using her quick wit and sense of humor," Williams said.

"All who know her immediately perceive her zest for quality of life and her deep concern for the well-being of all people, especially children. Pat is a prime mover in Weatherford's fight against drugs," Williams said.

As director of special programs for the Weatherford school system, Morrison has her activity calendar full long in advance, yet she finds extra time to put in as a volunteer for countless community projects.

Merritt High School principal to retire

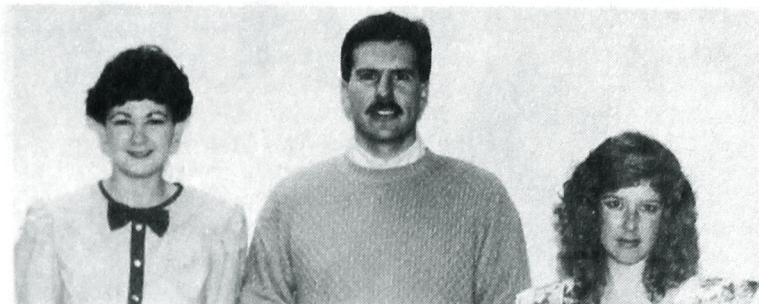
A reception was held honoring Royce Thompson, retiring Merritt High School principal.

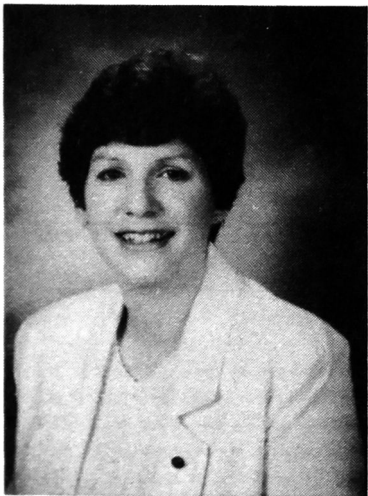

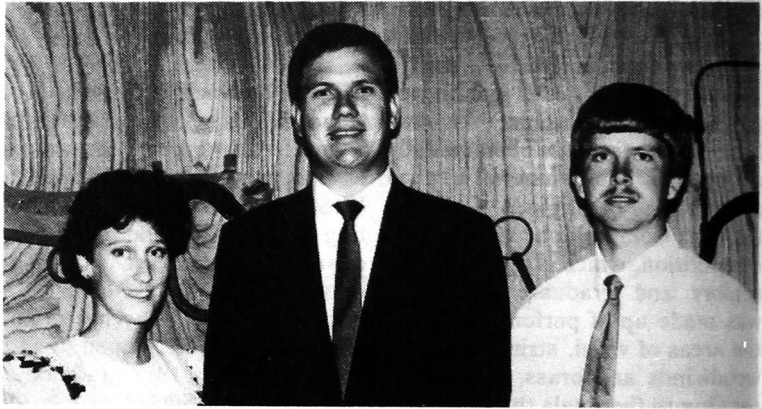

Alum named outstanding military pharmacist

Air Force officials selected Capt. Allan D. Stowers as the Air Force Company Grad Officer Pharmacist of the Year for 1989. Allan is a 1979 pharmacy graduate from SWOSU.

"It's quite an honor to have been selected, but I still can't believe it's true," said Capt. Allan D. Stowers, 325th Medical Group, recipient of the award.

As chief of Tyndall's satellite pharmacy, Captain Stowers supervises a staff of six active-duty Air Force members and more than 10 American Red Cross volunteers. According to 325th Med Gp statistics, the satellite pharmacy staff handles slightly less than 2,000 daily medication procedures.

Shortly after his arrival, the captain was tasked with bringing

the newly established satellite pharmacy on-line.

Since that time, the satellite pharmacy has become a "highly efficient, well-managed, patient-oriented service," according to Col. Claude H. Chan, 325th Med Gp commander. The pharmacy has become a model TAC satellite facility.

Under Captain Stowers' guidance, the satellite pharmacy's telephone refill call-in system climbed from 5 to 95 percent usage and has remained at this level the highest in TAC. Additionally, the satellite pharmacy accounts for 65 percent of the total production of both 325th Med Gp pharmacies, making it the busiest in the command.

In addition to his duties as chief of the satellite pharmacy, the cap-

tain oversees and governs the distribution of all medications within the base hospital.

His therapeutic drug monitoring programs along with the standardization of the clinically significant drug and intravenous instructional aids throughout the hospital, brought him praise and respect not only from the entire medical staff, but from Health Services Management Inspection team members said Colonel Chan.

Captain Stowers' method for checking the daily cart exchanges with the nurses' medication cardex reduced the number of missing doses, and intravenous consultative services, usually seen at larger Air Force medical centers were instituted here.

"Captain Stowers sustains a

magnificent record as a leader and innovator for both the 325th Med Gp and the Air Force," said Colonel Chan. "His dedication and superlative efforts have helped make our pharmacy services the best in TAC. Even with all of these accomplishments it is still his attention to detail in the day-to-day little things that make Captain Stowers stand out above his peers."

"It may sound like a cliché, but none of this would have been possible without the tremendous amount of support I've received from my entire staff. Their dedication and professionalism have really made my job easier and I owe this award to each of them," concluded Captain Stowers.

Pharmacy student participated in summer internship program

The National Pharmaceutical Council selected Southwestern Oklahoma State University student Kien Chau of Yukon to participate in the NPC 1990 summer internship program.

This national program competitively selects second-year pharmacy students to spend a summer obtaining hands-on experience in the areas of research and manufacturing with a large pharmaceutical company.

Chau interned with Abbott Laboratories in North Chicago, Ill.

Chau has an interesting background in that he has survived by accepting challenges. He escaped from Vietnam by boat in 1984 after living for 10 years under Communist ruling. He left with no possessions and unable to speak English. He managed to make his way to Singapore where he served as a World Vision volunteer in a refugee camp.

After three months in Singapore, Chau joined a half-brother in Yukon, Okla. He entered a refugee teaching center in Oklahoma City to learn English. 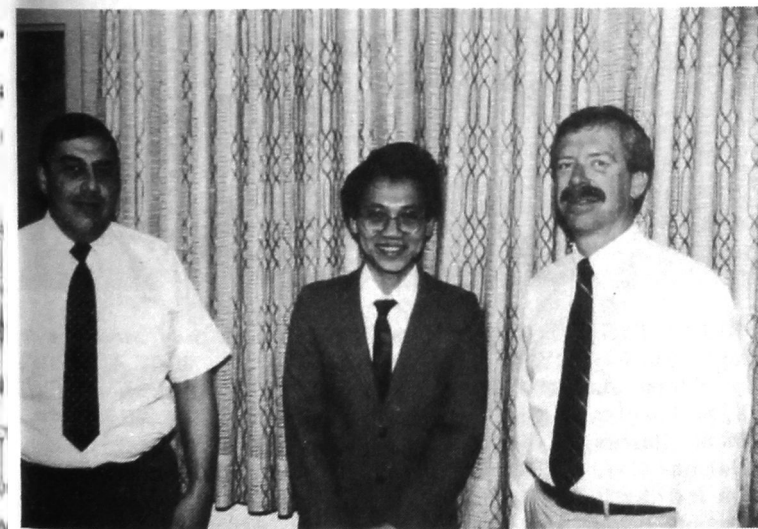
Dr. James and his wife Pam, who majored in math from 1971 to

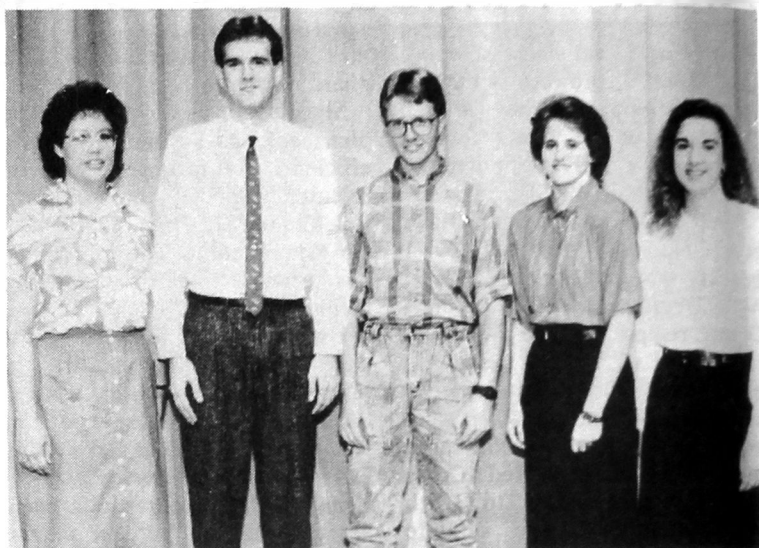

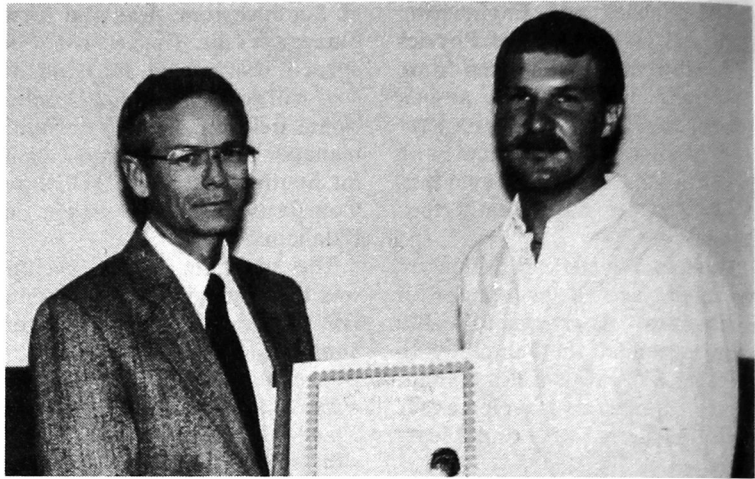

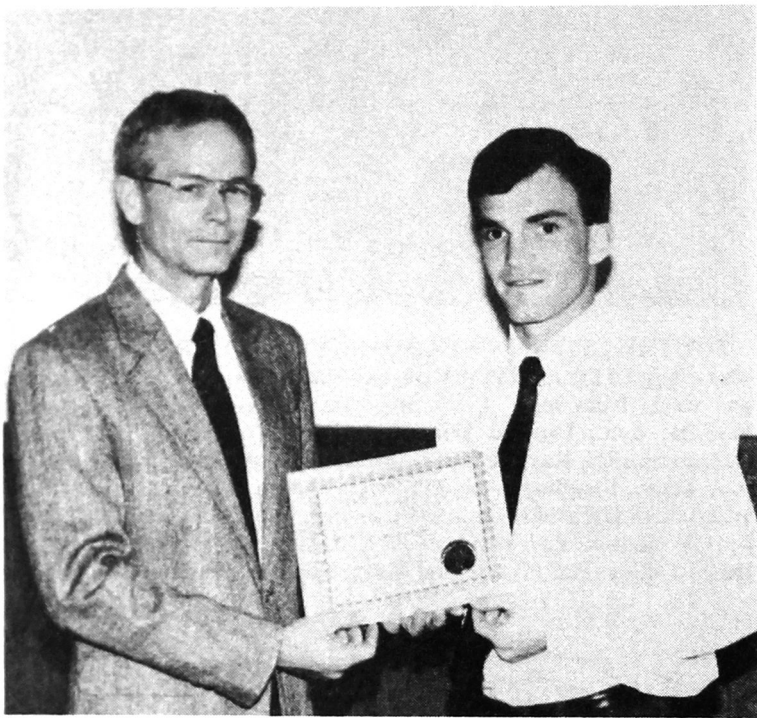

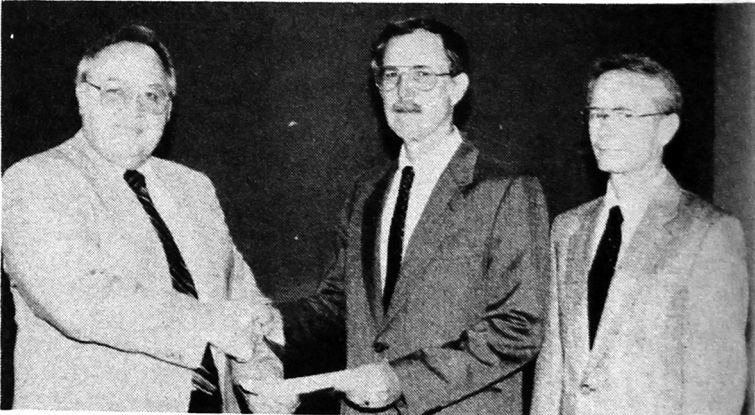

The cash awards are funded through the Ex-Students' Association's Foundation for Texas Excellence, the vehicle for Texas Exes to contribute directly to the Association's programs of academic support for the University.

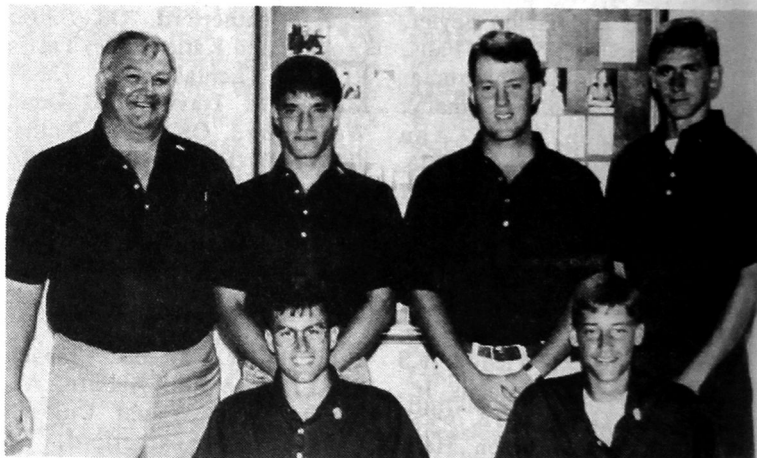
Stokes and his Southwestern counterparts qualified for the 1990 national tourney by winning the NAIA District 9 tourney held in late April in Oklahoma City.

Alum selected all-state coach

Hollis High School basketball coach Larry Taylor was selected to coach the Small West All-State basketball team July 22 through 27 in Oklahoma City.

Taylor and Skip Ashworth from Mount St. Mary's received the coaching honor for the Small West team which includes all-staters from Class 2A, A and B schools.

With Taylor's coaching experience, the 1989-90 Hollis Tigers completed the season with a 24-4 record, losing in the semi-finals of the area tournament at Anadarko. This was Taylor's fifth season as head basketball coach, taking the

reins in 1985. Since taking the head basketball coaching position, Taylor has continued to build the program and produce winning teams.

While coaching junior high basketball, Taylor had four undefeated seasons, 1974, 1980, 1982, and 1988.

Taylor graduated from Hollis in 1967, and received a bachelor's degree in 1972 from Southwestern Oklahoma State University, Weatherford. He came to Hollis in the fall of that year and resumed the responsibilities of Hollis junior high boys basketball coach, assistant football coach for both

junior and senior high and junior high and senior high boys track coach.

In 1978, Taylor became head junior high football coach and assistant high school boys basket-

ball coach in addition to his other coaching responsibilities. Then in 1979, Taylor was relieved of senior high track coaching duties when another coach was added to the staff.

Baseball players honored

Two Southwestern Oklahoma State University baseball players were named to the 1990 NAIA District Nine All-District 1st team and the 1990 Oklahoma Inter-collegiate Conference 1st team while two others were named to the OIC 2nd team.

Southwestern third baseman Rick Castaneda of Midland, Texas and catcher Shawn Paulk of Oklahoma City Putnam City were first-teamers on both the district and OIC teams, while leftfielder Shawn Nunley of Sterling and pitcher Tony James of Blanchard were OIC second team selections.

Castaneda, who was also a first-teamer on both squads in 1989, was a .301 hitter for the Bulldogs in 1990. He led Southwestern in doubles, triples and home runs with 11, 5 and 4, respectively. The senior also had 29 RBIs.

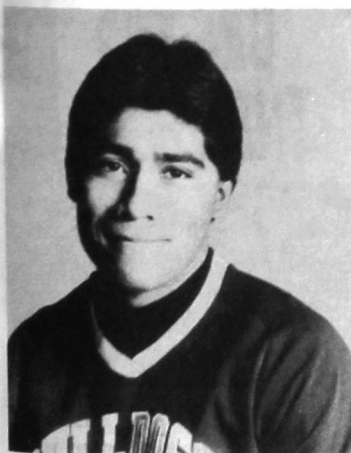
Paulk was the Bulldogs' start-

ing catcher who did an outstanding job behind the plate. Paulk batted .336 in 1990 which was second best on the team. The senior also was second on the team in RBIs with 31.

A pleasant surprise for Southwestern head coach Larry Geurkink this past season was Nunley, a freshman from Sterling. Nunley ended up being the leading hitter for Southwestern with his .339 average. He drew a team-leading 31 walks and also had 27 RBIs.

James, a sophomore, ended up the season with a 6-0 record. He pitched 59.3 innings for the Bulldogs in 1990 and finished with a 4.37 ERA. He also had 36 strikeouts.

Southwestern ended up with a 23-21 record in 1990. The Bulldogs qualified for the NAIA District Nine playoffs where they finished fourth.

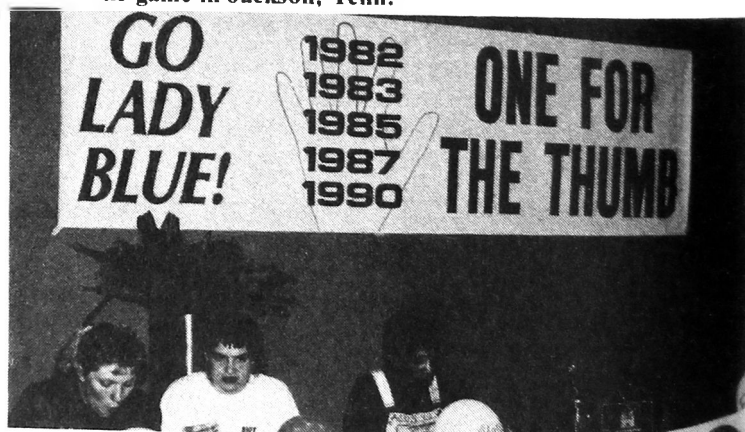

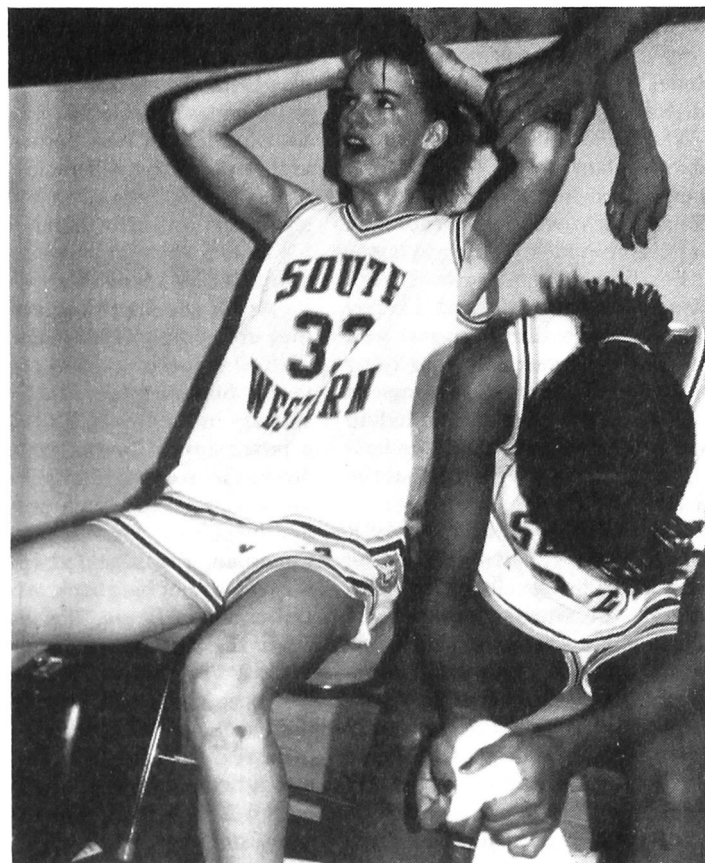

Rodeo teams place in top ten at CNFR

Southwestern Oklahoma State University rodeo teams at Weatherford fared well at the 1990 College National Finals Rodeo held in June at Bozeman, Montana.

The SWOSU women ended up in 5th place while the SWOSU men placed 10th. Winning the national titles were the Montana State men and Wyoming women.

Leading the Southwestern women at nationals was Leedey senior Jackie Barnard who won the short go round in goat tying and placed 2nd in the average of goat tying. Barnard also ended up 8th in the national standings based on performance throughout the year.

Also doing well at the CNFR was Kim Stamps of Norman who placed 3rd in the all-around competition and finished 6th in the average of barrel racing. She also placed 14th in the national standings of goat tying for the entire year. Stamps was the winner of the 1989-90 Central Plains Regional individual championship title in goat tying. The CPR is comprised of all schools in Oklahoma and Kansas.

Lesla Arnold-Morrison of Pryor ended up the year as 6th best in the nation in barrel racing, while teammate Staci Baber of Devol was 17th, also in the barrels. Morrison had a successful season for SWOSU as she won both the all-around and barrel racing CPR titles in 1989-90. She was instrumental this year in helping the SWOSU women win its 7th straight CPR team title.

As for the Southwestern men, they ended up in 10th place at the CNFR for the second straight year. Southwestern had three starters in the finals. Phil Clifton, a junior from Clinton, wound up 4th in the average of steer wrestling which earned team points for Southwestern. Shawn Wright of Canadian, Texas, ended up 6th in the average of bareback, while Ed Dufurrena of Denio, Nevada, was 7th in the average of bronc riding. Wright was also a CPR champion this year as he was co-winner of the bareback riding title.

Based on performance throughout the season, Wright placed 20th in the national standing of steer wrestlers, while Clyde Himes of Beulah, Colo., earned

the 14th spot, also in steer wrestling. Himes was winner of the 1989-90 CPR individual championship title in bareback riding.

SWOSU graduate inducted into Hall of Honor

Steve Graham, Weatherford High School head football coach from 1947-58, was inducted into the New Mexico High School Coaches Association Hall of Honor on August 2 at the NMHSCA 3rd Annual Awards Luncheon in Las Cruces, N.M. He was introduced prior to the tip-off of the all-star basketball game at the Panhandle American Center on the New Mexico State University campus.

Born near Henrietta, Texas, Graham moved with his family to Walters, Okla., where he attended grade school and high school. He earned a football and basketball scholarship to Southwestern Oklahoma State University.

In 1941-42 he lettered in football and basketball, then in the spring of 1942 entered the Navy Air Force and served as a pilot for three and a half years during World War II, 17 months of which were in the South Pacific.

In October of 1945 Graham returned to SWOSU to complete his athletic career and obtain his bachelor's degree in 1947.

In the fall of that year he was hired as athletic director and head coach of all sports at WHS. Under his tutelage, the program

blossomed quickly, with championships in football as well as other sports.

As Eagles head coach, Graham had only two losing seasons in his 12 years in the Weatherford school system, compiling a record of 76-60-4. In 1952 the Eagles won their first 11 games. That year Graham was selected to coach the South All-State team, which defeated the North 32-0.

In 1959 he moved to New Mexico to become athletic director and head football coach at Clovis High School. The Wildcats won their first football championship under the playoff system in 1960.

Since that time, the Clovis athletic program has proved quite competitive in all sports, winning nine state football titles, including one stretch of five in a row.

In October of 1987, Graham was inducted into the Southwestern Oklahoma State University Athletic Hall of Fame.

He retired in 1985 from Clovis High School after a 38-year career in education.

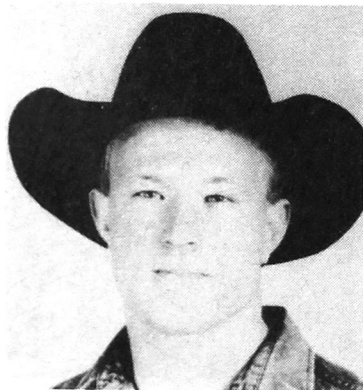
He and his wife Carmen have three sons, Don, Bob and Jack; one daughter, Jill; and 12 grandchildren.

Walcher still swinging

Rocky Walcher, a Southwestern golfer from 1982-85, recently set a course record at Boiling Springs Golf Course in his hometown of Woodward.

Walcher was in Woodward for a visit with family in late July-early August. He currently lives in Orlando, Fla., with his wife, Tracy. He is a professional golfer having played five years on the Florida Mini-Tour and two years on the Canadian Tour. He has three career victories in Florida including the two last spring.

Walcher has been using the Canadian tour to prepare for the possibility of joining the lucrative PGA circuit in America. He is planning to make an attempt at a

PGA card at a qualifying school.

While in Woodward this past summer, Walcher toured the 6,050 yard (distance from the championship tees) par-71 Boiling Springs course in a record of six-under 65, eclipsing the old record of 66, which he shared with Delmar Scoville.

Walcher, a 1980 Woodward High School graduate, helped lead Southwestern to four straight Oklahoma Intercollegiate Conference golf championship titles from 1982-85. He was a three-time OIC champion and also an NAIA District Nine champion one year. He played at Southwestern for athletic director and golf coach Cecil Perkins.
