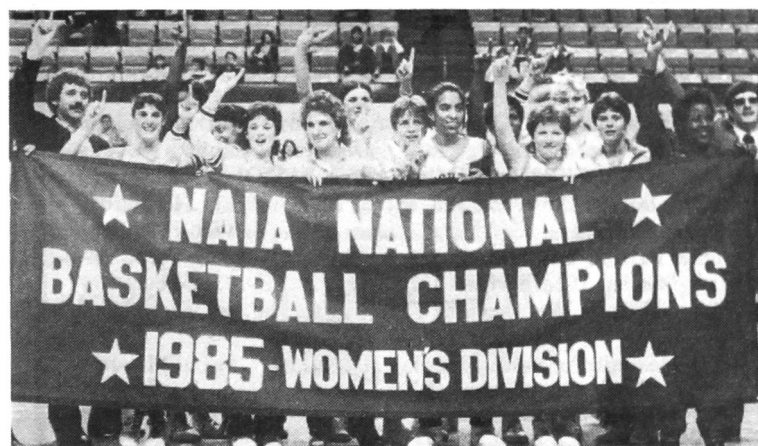
## Lady Bulldogs Win 3rd National Title

It was the last shot that Southwestern Oklahoma State University senior Kelli Litsch would make as a Lady Bulldog and, as she shot, there was a silent moment of indecision as it made its way toward the goal. As the shot dropped good, the Southwestern Oklahoma State University Lady Bulldogs, with 18 seconds remaining in the NAIA National Championship Game, pulled ahead of Saginaw Valley, MI.

55-54 and continued on to win their third NAIA National Championship in four years.

Litsch, a 6-0 post player from Thomas/Fay, was named the "Most Valuable Player" for the tournament, as she had done when the Lady Bulldogs won the national title in 1982 and 1983, and Coach John Loftin was named the NAIA "Coach of the Year" as he had done those two champion-

# Third NAIA National Championship Won

ship years. Shelly Brown, a 6-1 junior post from Holdenville, was named, along with Litsch, to the All-Tournament Team.

The Lady Bulldogs went into the tournament with a perfect 30-0 record, after winning both the NAIA District Nine tournament, by defeating Northwestern Oklahoma in the finals 73-52 and the NAIA Bi-District game, where they defeated St. Mary of the Plains, KS, 74-53.

The Lady Bulldogs won their opening game of the NAIA National Tournament by defeating

Southern Maine University 68-49. In that game, Litsch and Brown each scored 18 points; sophomore Donna Beed, a forward from McAlester, scored 13; Marilu Dunard, a junior forward from Troy, MO, scored eight; Lisa Segard, junior forward from Springdale, AR, have five; and Delisa Stroud, a junior guard from Snyder, Jan Cheadle, a senior guard from Carnegie, and Pendra Hamar, a freshman forward from Hydro, each had two points.

After the opening round, the Lady Bulldogs stopped the University of Missouri at Kansas City

65-60 in the quarter finals and Wayland Baptist, TX, 63-49 in the semi-finals.

The finals, played on Saturday evening, March 16, featured two undefeated teams, as Saginaw Valley came into the National Tournament with a 32-0 record.

The Southwestern Oklahoma State University Lady Bulldogs, under Coach John Loftin and Kelli Litsch, have amassed an impres-

sive 129-5 record during the past four years and have not lost a single home game. The team won back-to-back National Championships in 1982 and 1983, while the tournament was held in Kansas City. Last season, the first for the Nationals to be held at the Five Seasons Center in Cedar Rapids, Iowa, the Lady Bulldogs dropped out at the quarter-finals, losing to the University of South Carolina-Asheville 57-54.

## Alumni on New Board

The new American National Bank recently opened in Elk City, and two members of the Board of Directors are Southwestern alumni.

Herb Weil, Chairman of the Board, received his SWOSU degree in industrial arts education and taught school in the Merritt School System from 1957-73. He

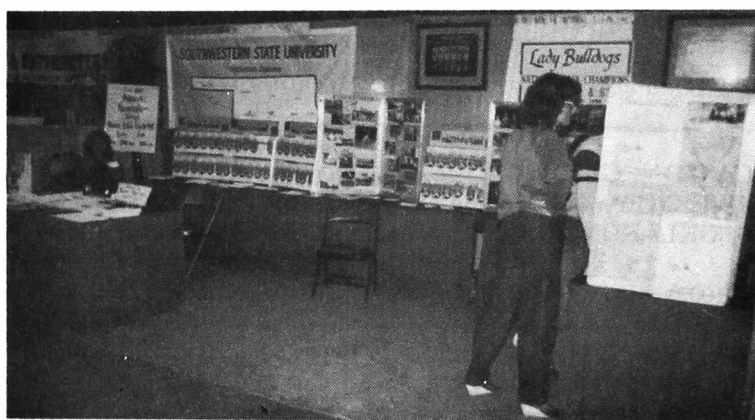
The Alumni Association will help in every way to set up a satellite chapter. We have many addresses we can furnish, and we will help you make contacts. We will also meet with you.

# Board of Directors Meeting

## MINUTES

MARCH 2, 1985

### SOUTHWESTERN OKLAHOMA STATE UNIVERSITY ALUMNI ASSOCIATION

The Board of Directors held their March meeting in the Student Center TV Lounge at 11:30 a.m. with Joe Anna Hibler presiding. The following board members were present: Larry Evans, Bill Ware, Jim Litsch, Glenn Wright, Lucille Patton, Millie Thomas, Carl Bogdahn, Larry Claxton, Mike North, Ed Berrong, Tom Libby, Otis Sanders, and Mark Mouse.

Dr. Leonard Campbell, President of Southwestern Oklahoma State University, spoke to the group about the new admission policies for higher education. He also reported on the plans to remodel the Student Center, build a new press box at Milam Stadium, and construction of a new chemical storage building.

Dr. Hibler reported the recommendation of the Executive Committee: the offices of president and president-elect be changed to a two-year term. That Johnny Beech be held over for one more year and that this present year would be served by Joe Anna Hibler since Johnny Beech was away for graduate school. Also that Richard O'Hara be appointed as president-elect and that Joe Anna Hibler be appointed to fill the vacancy on the Board of Directors created by the death of E. H. (Hack) McDonald. The Executive Committee also recommended that Otis Sanders secure nominations for the five vacancies that will expire this year. Motion was made by Larry Claxton and seconded by Bill Ware that the recommendations of the Executive Committee be accepted. Motion carried.

Following lunch in the Student Center Cafeteria, Millie Thomas presented the financial report showing a balance in banks and investments of \$50,551.31. Otis Sanders reported on the following alumni activities: the Foundation Banquet will be March 23, 1985. Over 200 invitations have been mailed out to donors. Also Homecoming 1985 activities have been scheduled whereby athletes graduating from 1959-64 would be honored. Otis also reported that last year's honorees (1950-58) are planning another reunion. Otis stated that the next "Echoes from The Hill" would be mailed in June, 1985. The Satellite Chapter in Lawton is working on a \$1,000 scholarship for fall term.

A motion was made by Bill Ware that Otis Sanders be given authority to spend up to \$1,500 for purchasing new files and a typewriter to aid his office in carrying out alumni activities. Motion seconded by Ed Berrong. Motion carried.

Larry Evans made a motion that the Executive Committee survey the campus for specific needs of the University to determine ways the alumni could assist financially. The motion was seconded by Larry Claxton. Motion carried.

The fall meeting of the Alumni Board of Directors was set for Saturday, September 14, 1985, at 11:30 a.m. in the Student Union.

The meeting adjourned after a motion by Larry Evans and seconded by Ed Berrong.

# Alumni Nominee for Kansas Award

The Kansas Teachers Association's nominee for the coveted award is Al Jackson, mathematics teacher at Eureka Junior-Senior High School. He and other nominees from throughout Kansas will be considered for the seven awards to be handed out later this spring by Emporia State University.

Al, a graduate of Southwestern Oklahoma State University in Weatherford, OK, began his teaching career in the fall of 1966 when he accepted a position in the Eureka school system. Al taught seventh- and eighth-graders at the Piedmont School that first year and pulled double duty as the building's head teacher.

Al's first experience in the coaching ranks was with junior high school boys. Through it he had an opportunity to work with boys who were out for football, basketball, and track. He was the assistant coach of the basketball team, which won the Tri-Valley league championship.

When Unified School District 389 decided to transfer the sixth-grade students to Tonovay School for the 1969-70 term, Al went there with them and for the second time in his career found himself teaching at a country school. But with the move came an additional responsibility, that of assuming the position of the building principal. Al enrolled at Emporia State University and set out to obtain a principal's certificate, earning one in 1973. For the next five years he remained at Tonovay in the dual capacity of teacher and principal.

In the fall of 1978 Al joined the staff at Eureka Junior High School, filling an opening in the math department. He requested the transfer, and in his new position was able to help develop the mathematic skills of seventh- and eighth-graders. He now teaches seventh-grade math and advanced general math on the high school level.

Al has remained a coach all the

while, although he is no longer coaching junior high boy's teams but instead is working with girl's teams. He made the switch when girl's basketball was introduced at the junior high a few years ago.

Born in Oklahoma, Al spent the first 12 years of his life on the family farm near Putnam. The family moved to the big city, Denver, CO, in the mid-1950's, but Al left his heart in Oklahoma and returned there for the summer during his school years to help harvest crops on the farm.

After graduating from Sheridan Union High School in 1962, Al came back to Oklahoma to enter SWOSU. He worked his way through college, dividing his time between his studies, the farm, a grocery store, and his new bride, Kathy, whom he married in 1965.

Al, who did his student teaching in Hinton, OK, graduated from Southwestern in May, 1966, receiving a B.A. degree in math and history. Four months later he was teaching in Piedmont.

In the summer of 1969 Al returned to Weatherford to begin work on a M.Ed. degree, his major being elementary education. He attended classes and helped with the harvest for three summers, but by July, 1971, that degree and a certificate to teach in grades K-12 were his.

In 1982 Al was the Teachers Association's nominee for the prestigious Kansas Teacher of The Year Award.

Over the years Al has derived

much enjoyment from the interaction between himself and his students. He places a lot of emphasis on the way he treats his students and strives to treat them as well as he would want other parents to treat his children--18-year-old Larry and 16-year-old Linda.

Al's interest in children extends to his service of the Church of the Nazarene, the church he joined in 1966 and attends regularly. Al has helped children of the church mature spiritually and morally in his role as Sunday School teacher. He has taught classes at all age levels but this year is teaching the senior adult class. Al also has held several official positions within the church.

Al has influenced a great many children through his involvement in the Eureka Recreation Department's flag football program, Saturday morning basketball program, and summer ball programs. He also supports youth as a member of the Eureka Booster Club.

Al belonged to the Eureka Jaycees in the '60s and was the recipient of the chapter's Young Educator of The Year Award in 1968.

A good neighbor to the elderly in the community, Al spends much of his spare time raking their leaves and cleaning their yards in the fall and helps with the Meals-on-Wheels program on weekends. He also frequently drops by the homes of shut-ins to make sure all is well with them.

Steven Graham, former Weatherford High School head football coach and athletic director, is retiring as athletic director and head football coach in Clovis, NM, after the school year.

Graham, born in Bowie, TX, was reared in Walters. After graduation he received a scholarship from Southwestern Teachers College, which he attended during his freshman and sophomore years.

He left college temporarily to attend Navy Flight School, then married Carmen Miller.

# Burcham Nominated to Hall of Fame

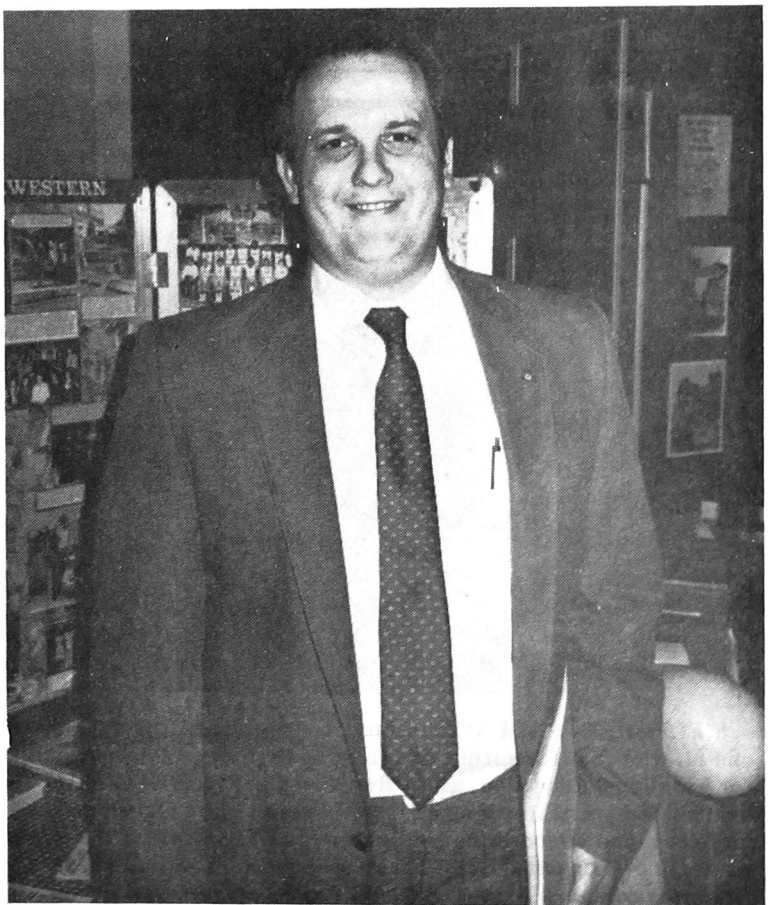

# Lucille Patton Retires; Awarded Top Medal

Capping a 38-year career in Oklahoma education by being awarded the highest honor a military person or civilian can receive except for valor, Dr. Lucille Patton retired June 30 after 13 years of service to Central State University.

Patton, who for the past eight years has been dean of the School of Special Arts and Sciences, received the Oklahoma Distinguished Service Medal "for unusually distinguished and meritorious service as a career educator, culminating her career as dean of the School of Special Arts and Sciences.

"During this period of dedicated service. . . Dean Patton contributed immeasurably to the simultaneous membership program and the Oklahoma Army National Guard through her unfaltering support of the military science department and the Oklahoma Army National Guard."

The award was presented to Patton at a retirement reception and was signed by Gov. Nigh and by Maj. Gen. Robert Morgan, Adjutant General of the State of Oklahoma.

"The cadets and the officers of the military science department felt the best thing they could do for me was to recommend me for this award," Patton said.

"When they did that and I received the award, I was totally overwhelmed."

Patton was instrumental in forming the vocational teacher education program at CSU. "This is probably one of the achievements that I am most proud of," Patton said.

"In the spring of 1971 I came here as the first vocational teacher

education teacher here on campus. I think that being instrumental in getting the vocational teacher education program started here was one of my major achievements."

Another achievement that Patton is rather proud of was being named Dean of the School of Special Arts and Sciences.

"That has been my most challenging work," Patton said. "You're dealing mostly with people, and an educator gets mostly instant gratification when you are working with the students and you can see how they can progress."

"As an administrator you work with the faculty and try to help them to progress and become better instructors and reach their potential."

Patton worked under four academic vice-presidents in her career as dean and says that is the toughest part of being a dean because of the different leadership styles of each vice-president.

Lucille Patton is the past president of the SWOSU Alumni Association and is working on a chapter for the Oklahoma City area. She is a native of Hollis.

## Students Work on Prehistoric Bison

Several Southwestern Oklahoma State University biology students are currently at work at a project that refuses to act its age.

The students, under the direction of Dr. Henry Kirkland, assistant professor of biology at Southwestern, are in the process of cleaning and preparing the fossil of a prehistoric bison, found some three miles south of Weatherford, that is some 11,130 years old.

The fossil, a female with the scientific name "Bison Occidentalis," was discovered in late July, 1984, by Weatherford city employee George Deffenbaugh. From there, the Southwestern Biology Technique class spent five days preparing the fossil for its trip to the Southwestern laboratory by using plaster parts to help stabilize the bones.

"The bones are in very good condition," Dr. Kirkland said, "the teeth were also good, and there was still enamel present on the teeth." Dr. Kirkland also mentioned that only one horn and a mammoth tooth were also recovered.

Krueger Enterprises Inc., who dated the sample of bones by the Radio Carbon Method, said their

11,130 guess could be off by plus/minus 350 years.

The fossil will eventually be on display in the Southwestern biology department.

Marshall Space Flight Center is

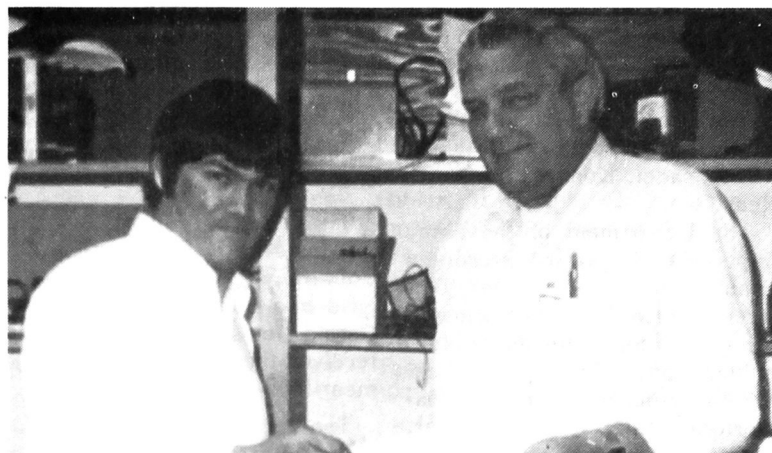

They are responsible for selling ideas to NASA's chief administrator, James Beggs. After Program Development projects are approved for more extensive design and development, Science and Engineering takes over a project and spends years doing detailed design and engineering studies on those projects.

Other 1985 graduates of the Department of Physics are looking forward to interesting careers. Those finishing their physics or engineering physics degrees in December included David Hart, graduate of Weatherford High School, and Russell Smith of Weatherford and formerly of Colorado. Hart is now doing graduate study in physics at Oklahoma State University. Smith is now employed by BDM Corporation, a defense contractor in Albuquerque, NM. Among those finishing physics degrees in May are Douglas Miller of Fairview, Gary Unap of Carnegie, Douglas Willowby of

commissioned as a Reserve Officer in the Field Artillery branch, who will also serve in the Oklahoma National Guard.

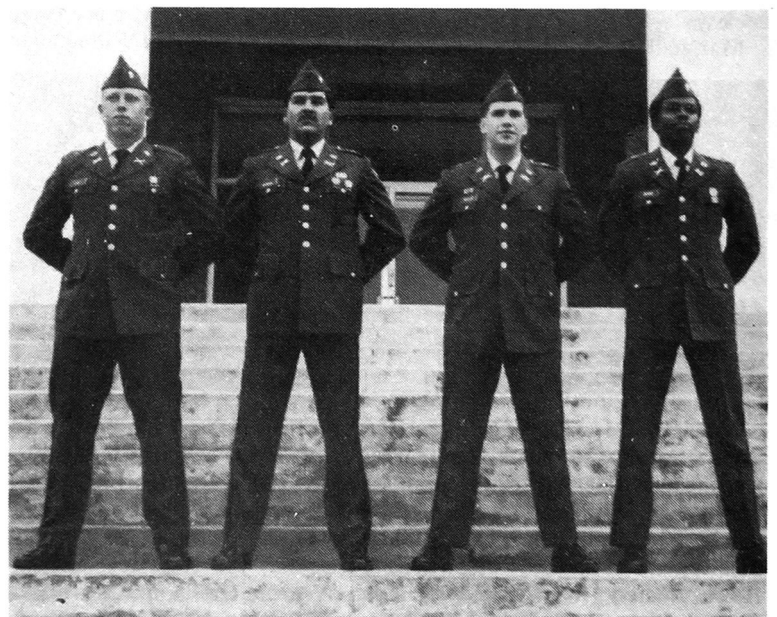

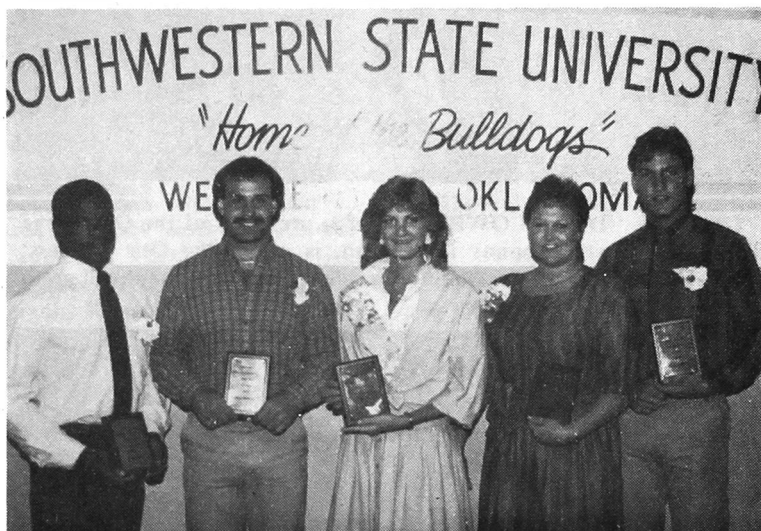

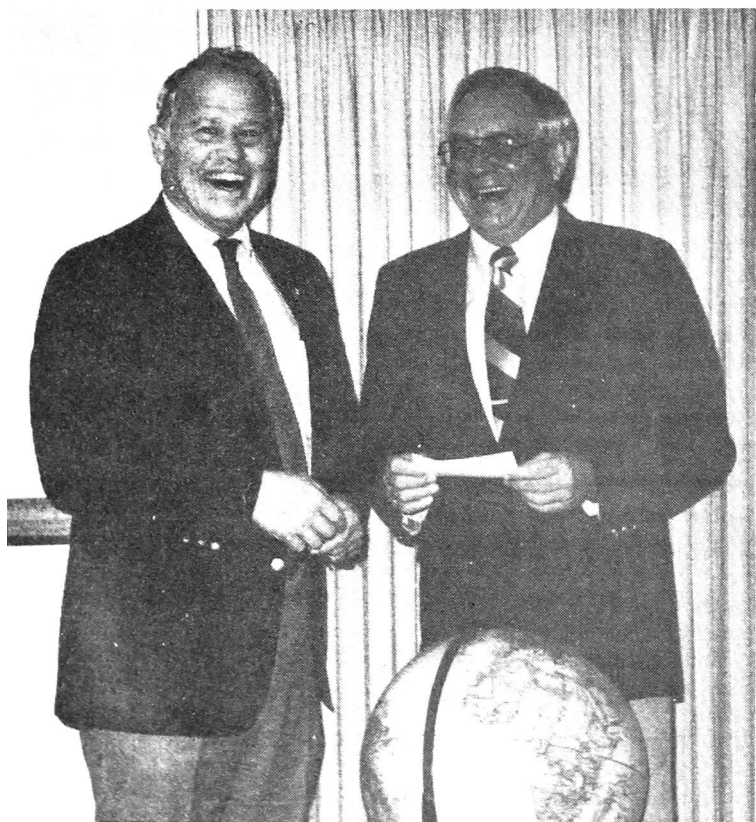


# Bankers' Scholarship Program Growing

Four area banks and bankers have joined the Southwestern Oklahoma State University Scholarship Program. The scholarships are awarded to high school seniors in their town or area.



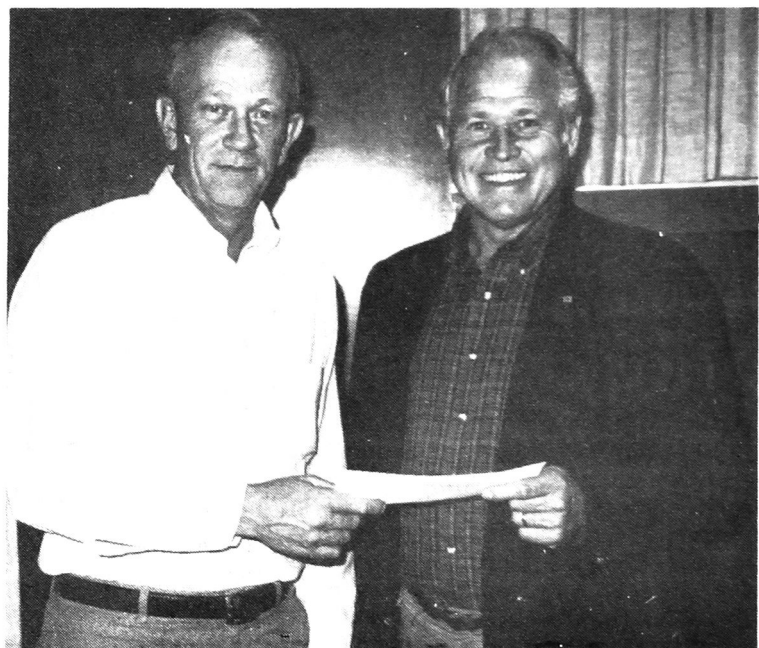

# SWOSU Offers New Internship Program

The Office Administration/Business Education Department at Southwestern Oklahoma State University, in cooperation with several area businesses, is now offering a popular office internship program where university students can earn university credit and gain valuable on-the-job experience at the same time.

Dr. Amanda Copeland, chairman of the OA/BE department at Southwestern, says the course was piloted this summer with area business teachers. That proved so successful that this semester it is being piloted for secretarial/clerical/office administration students. The program is designed so that those who enroll in it work a total of 120 hours at a business office in the area. Enrollment is by signature only to insure that established criteria/qualifications are met. It will remain a relatively small, but very important program, Dr. Copeland predicted.

"The office internship program has a two-fold purpose," Dr. Copeland said. "One purpose is

to provide new insights to the business teacher who has been away from actual office experience for a number of years and give insight into what specific skills and knowledge needs to be taught and emphasized in the classroom. It also gives teachers the opportunity to gain experience on new, modern equipment which they often do not have in the classroom.

"The second purpose is to give practical experience to the OA/BE majors--'hands-on' experience using the skills and knowledge obtained in the classroom. Such practical experience is very difficult, if not impossible, to stimulate. We will also be using the internships to help us improve our programs."

Dr. Copeland says that skills and requirements needed for success on-the-job are changing rapidly, and the internship program is one of the ways School of Business is using to stay abreast of current competency needs.

## Small Business Development Center Established on SWOSU Campus

A small Business Development Center (SBDC) has been established at Southwestern Oklahoma State University. The Center will provide free counseling, training, and technical assistance to current and prospective business owners in 15 southwestern Oklahoma counties. The SBDC service area includes Beckham, Caddo, Comanche, Cotton, Custer, Grady, Greer, Harmon, Jackson, Jefferson, Kiowa, Roger Mills, Stephens, Tillman, and Washita counties. The SBDC is a joint effort of Southwestern Oklahoma State University and the Small Business Administration. The director of the Weatherford-based center is Dr. Clint Roush.

The Small Business Development Center will provide management assistance to small businesses who need help with selected managerial problems such as getting started in business, finan-

cial analysis, cash flow planning, marketing, accounting, investment feasibility, small business computer, and other identified management areas. The center will also offer training seminars covering selected business management topics and provide a link to major data banks in the United States.

The Small Business Development Center office is located in Room 219 of the Student Center Building on the SWOSU campus in Weatherford. 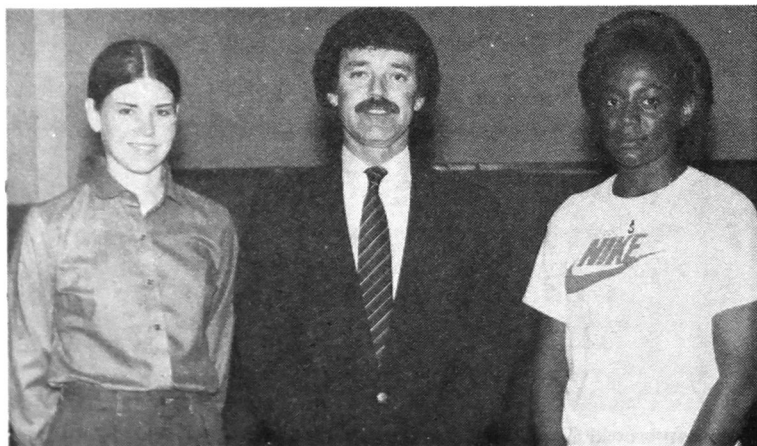

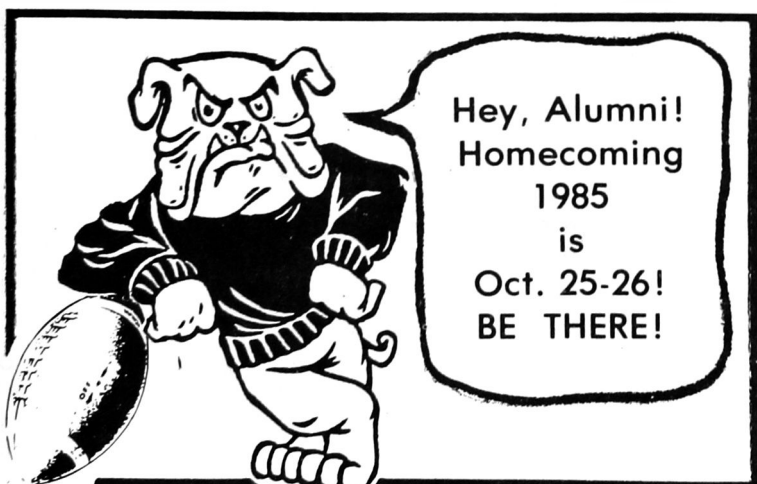

The cowboys and the cowgirls that are members of the Southwestern Oklahoma State University men's and women's rodeo teams have finished their 1984-85 season as champions of the Central Plains Rodeo Region, insuring both teams berths in the National Finals Collegiate Rodeo, to be held in Bozeman, MT, June 17-21. The first and second place teams, as well as the first and second placing in individual events, are allowed to participate in the National Finals.

The women, with 1737½ points, finished in front of Panhandle, 904½.
