Two alumni from Southwestern Oklahoma State University will be inducted into the Distinguished Alumni Hall of Fame during homecoming, Saturday, October 26, 1985. These two alumni are Dr. Grace M. Burcham, Weatherford, and Dr. Rollin D. Reimer, Cheyenne.

The two honorees will be recognized at the Southwestern Alumni Luncheon at 11:45 a.m., in the Student Union Ballroom, with formal inductions scheduled at half-time of the 2:00 p.m. homecoming football game.

Dr. Leonard Campbell, Southwestern Oklahoma State University president, will present each a plaque which will read in part: "Presented with pride the achievement of eminence in his/her community and to his/her

nation." A color portrait of each honoree will be displayed in the Distinguished Alumni Hall of Fame located in the Southwestern Room at the Al Harris Library.

Southwestern Alumni Blankets will again be presented to the alumni that traveled the longest distance, alumni with the most children that graduated from SWOSU, and the oldest alumni. The athletes that played from 1950-58 and 1959-64 will hold a reunion.

Dr. Grace M. Burcham received a degree in English from Southwestern in 1937. She received her master's degree in 1952 and a doctorate degree from Northern Colorado State University in 1961 in elementary education. (Continued on Page 2)

tion and reading.

Her teaching career began in Hinton where she taught in 1934-36; Centralvue (Greer County) in 1936-42, and Lone Wolf in 1942-52. She taught at Central State University in 1952-53, and in Weatherford in 1953-55. She joined the Southwestern faculty in 1956, teaching until retirement in 1980. She was professor and chairman of Elementary Education. She was counselor of Kappa Delta Pi, member of the Teacher Education Selection and Retention Committee; Member, Teach-

er Education Council; Member, Graduate Council; Director, Reading Program, and Advisor, Undergraduate and Graduate Students.

Dr. Burcham's professional and academic association memberships include: National Education Association, Oklahoma Education Association, International Reading Association, Oklahoma Reading Council, Association of Childhood Education International, Southwest Reading Council, Custer County Classroom Teachers, Kappa Delta Pi, Delta Kappa Gamma, and Higher Education Alumni Association of Oklahoma.

Although retired from teaching, Dr. Burcham remains active as a member of the Weatherford Chamber of Commerce, president of the Weatherford Library Board, member and officer in PEO, president and officer of United Methodist Women, president and officer in Wesleyan Service Guild, chairman of the Methodist Church Evangelism Commission, and a member of the Oklahoma and American Association of Retired Teachers and Persons.

Dr. Burcham has written numerous publications and has served as a member and consultant of many state and national organizations.

Dr. Rollin D. Reimer is the owner and publisher of the *Cheyenne Star* and *Leedey Star* newspapers. He is also a member of the House of Representatives, where he served as chairman of the Rules Committee and was a member of the Appropriations and Budget, Agriculture, County and Municipal Government, Public Health, and House Administration Committees.

Rollin received his bachelor's degree from Southwestern in 1961 with a major in biology. He received his master's degree from the University of Arkansas in 1963

and his doctorate degree from Tulsa University in 1968. He taught biology at Northeast Louisiana State University in 1963-64 and Stephen F. Austin State University in 1964-65. He was a member of the Texas A & M University, working with the College of Agriculture in the Research Division and the Department of Wildlife and Fisheries Sciences, and College of Marine Sciences.

Rollin taught school in Cheyenne in 1975-76 and was principal of the Crawford Public Schools in 1976-78. He was elected to the House of Representatives in 1979. He was the Legislative Representative to the State Department of Education on the Professional Standards Board; National Legislative Representative to the Advisory Board for ERIC Clearinghouse on Rural Education and Small Schools; and Legislative Liaison and Founder of Communities United for Rural Education, a statewide organization to support and improve rural education in Oklahoma.

Rollin is active in the local, area, and state Historical Societies. He is a member of the Masonic Lodge, Cheyenne Chamber of Commerce, and Kiwanis Club. Rollin and his wife, Linda, have four children.

RAY BURRIS

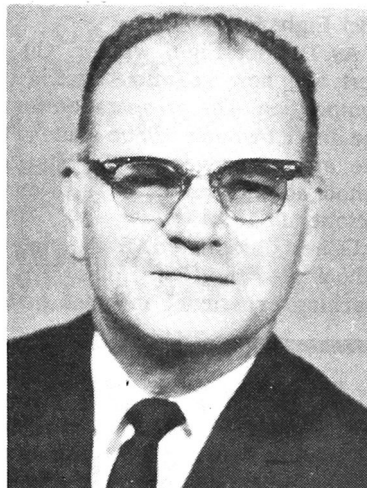
Ray Burris will be inducted by Cecil Devine; Lloyd Graham will be inducted by Allan Long; Ernie Stout will be inducted by Karl Kitt; Arthur Sweet will be inducted by Allen Sweet, and Dean Wild will be inducted by Gerald Daugherty.

Ray Burris is a professional baseball pitcher for the Milwaukee Brewers. He is a 1968 graduate of Duke High School, Duke, Oklahoma. Ray received his Recreational Leadership degree in 1972. He earned four letters in both baseball and basketball. He won 25 games during his junior and senior years at SWOSU. He was selected by the Chicago Cubs in 1972 in the 17th draft. He won 15 games in 1975, 1976, and 14 games in 1977. He played for the New York Yankees part of the 1979 year, before finishing the season with the New York Mets. In 1981, he was traded to the Montreal Expos. In 1984, he was traded to the Oakland A's where his record was 13-10. During Ray's baseball career, he led the league in 1976 with 25 straight scoreless innings. He passed the 1,000 strike-outs in the middle of the 1985 season. In 1984, he was ranked ninth in the American League with a 3.15 ERA. Ray is married and has three sons, Djemal, and twins Ramon and Damon. He resides in Arlington, Texas, during the off season.



LLOYD GRAHAM

Lloyd Graham is a graduate of Walters High School, Walters, Oklahoma, and served in the service during World War II in the European Theatre. He started to college at Southwestern in January, 1946. He completed his degree in 1949. While at Southwestern, he lettered in football, basketball and track in 1946, 47, and 48. He was football and basketball captain in 1948. He was voted by his teammates to receive the Foreman Award as Most Valuable Football Player in 1948. He coached basketball and baseball at Independence High School in 1949-51; and Butler High School in 1951-52. He coached football, basketball, and baseball at Roosevelt High School in 1952-54 and Anadarko High School in 1954-55. Lloyd coached football, basketball, and baseball at Crooked Oak High School in 1955-59. He was high school principal for the next four years at Crooked Oak and then served ten years as superintendent. He has served the past 14 years as Deputy State Superintendent of Schools for the State of Oklahoma, State Department of Education in Oklahoma City.



ERNIE L. STOUT

Ernie Stout was a two-time National Wrestling Champion in 1933 and 1934 in the National AAU tournament. He placed first in 1933 in the National NCAA tournament. After graduation from Southwestern in 1934, Ernie and his brother wrestled one season with the Los Angeles Athletic Club. They both won Pacific Coast titles.

Ernie began teaching school in 1935. He coached wrestling, taught math and science, and he has served as a junior high and senior high principal. The last ten years of his thirty-seven years in education were spent in the Wetumka Public Schools as superintendent. He served two years as an instructor with the War Training Service training Navy pilots. He has served as president of the Wetumka Chamber of Commerce. He is a charter member and past president of the Wetumka Kiwanis Club with thirty-one years membership.

Ernie and his wife, Beulah, have two sons, Vernon and Tommy. Vernon is the high school principal at Wetumka, and Tommy is an assistant principal at Enid High School. They are active in the first Christian Church.



ARTHUR SWEET

Arthur Sweet, now deceased, was born in Chamal, Mexico. He grew up in Mangum, Oklahoma. Arthur received his degree from Southwestern in 1933 with the highest grade point average for any male in the history of the school at that time.

During his wrestling years at Southwestern he won the AAU National Wrestling Championship at 175 pounds. He was captain of the Southwestern undefeated football team and was president of his junior and senior classes. He served as captain of the American Wrestling Team at the

Pan-American games in 1937. He won a gold medal in the 190 pound class.

He has taught and coached in the Walters, Duncan, and Bixby Public Schools. He served as superintendent at Prairie Grove, Arkansas. In 1948 he became head of the English Department at Northern Oklahoma College in Tonkawa. He taught English, Speech and Spanish. In the mid 1950s he started coaching that school's first wrestling program.

After his retirement from teaching, he coached pee-wee wrestling in Tonkawa, helping to organize the program and serving as one of the first coaches. According to a "Tonkawa News" article in 1978, "Sweet's contribution to the program is a major reason wrestling has blossomed into a competitive sport here." The Tonkawa School Board approved the naming of the new athletic building after Arthur Sweet.

Arthur was married to Alyne Edmondson of Watler, Oklahoma. They had two children, Carla (Mrs. Dale Chlouber), and Allen. Carla is an editor with the Cooperative Extension Service at Oklahoma State University. Dr. Allen Sweet is a Clinical Psychologist in Tulsa.



DEAN WILD

Dean Wild is a graduate of Granite High School. He received his degree from Southwestern Oklahoma State University in 1935. He lettered three years in football and baseball. He was discharged with rank of Captain. Dean was a high school coach for 27 years and had 21 winning seasons. His first coaching job (Continued on page 4)

Bottom To Retire After 40 Years In Education

Herman Bottom, Cordell, a veteran Oklahoma educator, retired August 31, John Folks, State Superintendent of Education, announced. Bottom has been with the Education Department 18½ years and has served a total of 40 years in education as a teacher, principal, superintendent, and area supervisor for the State Department.

Bottom has served under five superintendents--Dr. Oliver Hodge, Dr. Dale Creech, Dr. Scott Tunhorn, Dr. Leslie Fisher, and Dr. John Folks.

When asked about his long tenure, Bottom said he hopes he has made some significant contribution to education of youth in Oklahoma. "My one and only objective in the past 40 years has been service to the boys and girls in this state. I have always wanted the best--good quality education--for them. My retirement certainly does not mean that I will stop pushing for progress in Oklahoma education."

Bottom was born in the Lake Valley community of Washita County. He is a graduate of Crawford High School in Roger Mills County. He earned a bachelor's degree from Southwestern and a

master's degree in School Administration from Oklahoma University. He served four years in the U.S. Navy during World War II. He entered the Navy in 1942 as a seaman, second class, and was discharged in 1946 as a Lieutenant, jg. While in service he attended the University of North Carolina in Chapel Hill, NC, and the University of Notre Dame in South Bend, IN. He received his commission at Notre Dame in 1944.

Except for two years spent as high school principal and coach at Warner, Oklahoma, Bottom has lived in western Oklahoma all his life. He was principal, coach, and superintendent at Colony and was superintendent at Mangum before going with the State Education Department in 1967.

Bottom was heard to remark this summer, after hearing people from Colorado and Texas brag about their states, "Yep, I like your states. I love to travel and visit you for about two weeks--a month at the most--then I want to go back to western Oklahoma--God's country. That's my home and the best place in the world to live."

Educating "Whole Child"

Don Harris, new Hennessey elementary school principal, said he believes in educating "the whole child."

"Whatever their abilities, I believe in educating all children to their highest potential," said the new elementary school educator.

Harris has served as the elementary school principal in Hobart for the past nine years.

The new administrator has also been the principal at Canute Elementary School and at Erick Junior and Senior High.

He has had 18 years of experience in the education field, beginning his career in Kansas City, Kansas.

Harris, 41, is a graduate of Hobart High School and Southwestern Oklahoma State University. He has a bachelor's degree in ele-

mentary education with a minor in social studies.

He also has a master's degree in administration and physical education and a counselor's certificate and a standard elementary certificate.

Born in Waurika, Harris has lived in Oklahoma his entire life with the exception of a short period of time spent teaching in Kansas City.

The field of education is not new to Harris--his mother is a retired school teacher. His parents are retired and live in Hobart. He has four brothers and a twin sister.

Harris' wife, Deanna, will be teaching in the language lab at the middle school this year. They have two daughters: Dena, 13, and Dana, 9.

Roy L. Goddard Jr. was one of 124 students to receive his Doctor of Osteopathy degree from Michigan State University.

Graduating physicians from the MSU College of Osteopathic Medicine completed four years of medical training, including education in basic and behavioral

Roy received his chemistry and pharmacy degrees from Southwestern Oklahoma State University in 1979. He is doing his residency training at Enid Memorial Hospital.

Bottom and his wife, Geneva, have three children and five grandchildren: Grayson and Rita Bottom of Cordell and their children, Brian and Lindsey; Ann La-

rue and Gary Morgan of Mustang and their sons, Garrett and Aaron; and Monty and Harriette Bottom of Oklahoma City and their son, Kyle.

A Gift To You From The Ratcliffe's

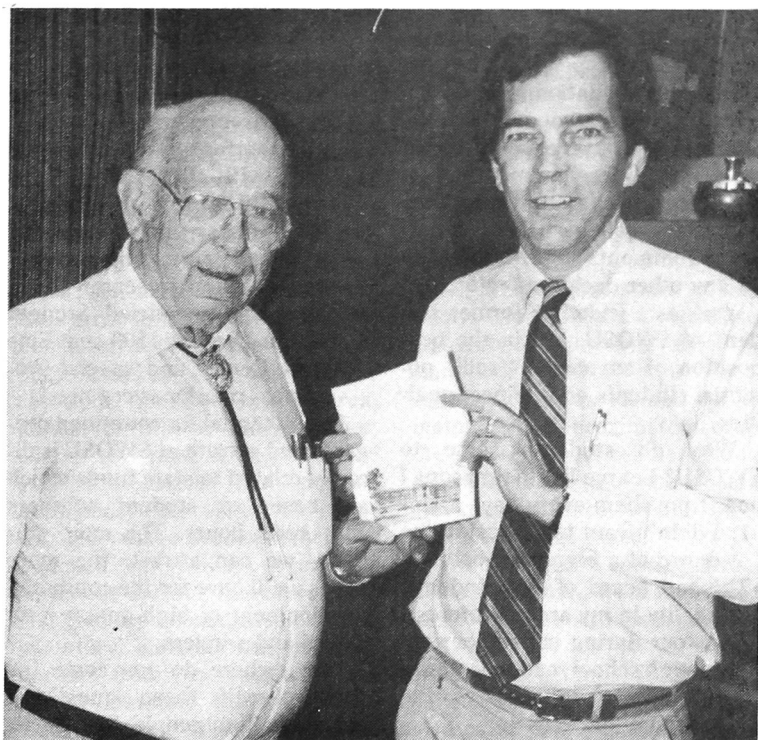

Stas Speaks On Computers

Raymond D. Stas spoke on managing computer information at the OSPE/Auxiliary joint meeting at the Community Center. The title of his talk was "Introducing Users to Automated Information Management" according to Program Chairman Bill McClintock.

Stas discussed significant improvements in software programs and equipment cost reductions resulting in direct use of computer-based information management technologies for personal productivity. This is a viable alternative for many office and production workers.

The Automated Information Management (AIM) program is being used within Phillips to acquaint all employees with the

available computer-based technologies.

Stas is Director, Desktop Computer Support for Phillips Petroleum Company. He is responsible for setting corporate desktop computer policies and standards, volume acquisition agreements, and direct support for desktop computer user in Bartlesville. Prior to his present job, he was Manager, Development Services, and responsible for computer operating systems planning and development and hardware planning for Phillips central computing center. He joined Phillips after earning a B.S. degree in mathematics and physics from Southwestern Oklahoma State University at Weatherford in 1958.

Alumni Releases First Album

Betsy and Kimio Young are about to release their first personal album "Got To Get Out." Betsy Lynn Young, a Weatherford High School graduate, and her husband, Kimio, a Southwestern Oklahoma State University graduate, moved to Atlanta, Georgia, in 1979, where they bought part interest in Devotion Sound Studios.

Betsy has spent her time writing lyrics for several Atlanta recording artists and is getting her feet wet in post album production. Kimio is most noted for his premier avant garde saxophone playing, the likes of which have not been seen since the cool jazz era of Sonny Rollins and John Coltrane, receiving rave reviews in

Europe as well as the South for his appearance on the 1984 "JAZZ" release "Volcano."

Kimio has spent the last three years developing new techniques in sound development and computer composing. Together the pair has over 300 compositions to their credit. Rodeo Arena Renamed

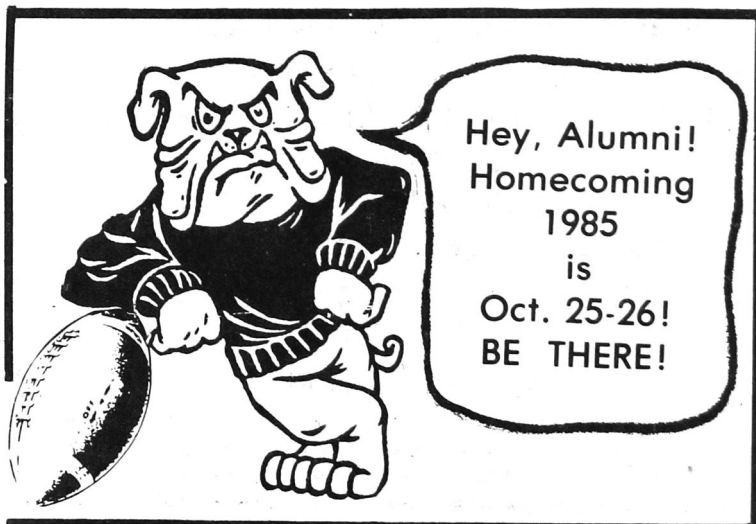

Memorial Student Center Renovation

Southwestern Oklahoma State University students will have, for the 1985 fall semester, a completely renovated Student Center, a building that has had only two minor extensions since its erection in 1956. The work done on the structure, by Delco Construction of Del City, should be complete by August 15 making it, at this writing, some 85% finished.

Before going into a description of what students, faculty, alumni, and townspeople will see when the hammering stops, it should be noted that the renovation of the Southwestern Student Center was accomplished by men employing some 24 crafts. Those crafts will become apparent as we proceed on a tour through both floors of the building.

We begin our tour as we enter the west door of the building, the one facing the Library. The single door has been replaced by two glass double-doors, which open into a foyer and two more sets of glass doors beyond. Past this

comes the shock--the lobby, usually cluttered with students and faculty, has been broadened, by eliminating the glassed-in office space to the right of the entrance as well as the gentlemen's and ladies'.

Upon entering the building, we will first look over the student cafeteria and we immediately see that the one small entrance has been replaced with a nice set of double-doors for an entrance and another set for an exit. Once inside, the room has a new look, thanks to some paint, lowered ceilings and new florescent lights. Diners will also notice that the space where used trays are delivered has been enclosed, which will help the general looks and noise level of the room.

After leaving the cafeteria, one might want to go into the Student Lounge, the room formerly called the "Television Lounge" and now occupied by the Student Bookstore. This lounge will contain the long-lost video games and pool

tables and even possibly a television.

Next to the Student Lounge is the Student Bookstore and perhaps the biggest change in the Center occurs here. The entrance has been enlarged and, as one peers inside, one notices that the bookstore has almost doubled its size since last semester. For the most part, the area around the entrance remains the same, but the northeast wall at the back has been knocked out, moving the rest of the bookstore into the area, almost to the far eastern door, where the pool tables rumbled and the snack bar patrons munched. This space obviously will give those students formally bunched up whilst purchasing textbooks and the like more room and give the bookstore itself more inventory. Keeping this in mind, the exit from the store will have two or possibly three checkout lanes, which will also help the general mood of both the bookstore workers and their customers. It will, our course, also provide better access for those handicapped.

The Snack Bar, still in the same old place, is now separated from the newly terrazzo-tiled floored lobby by two double doors. The "serve yourself" approach of the old snack bar is gone and, instead, two windows have been installed, each with a cash register and menu, which will give the Snack Bar a "fast food" atmosphere. The tables and chairs will still be there, as will a new lounge-type area, separated from the main floor by a wall, located in the space previously held by the video/arcade games. The north-eastern corner of the Snack Bar will hold a storeroom for the Bookstore, and it will probably be from there that caps and gowns will be delivered and used textbooks purchased.

The eastern entrance into the Student Center has been enclosed with large glass windows and will certainly spare those already inside from the upcoming cold spells.

Keep in mind that the entire downstairs will be painted anew, that new fire preventatives have been installed and that all windows have been covered with a film-like substance to keep the sun's rays to a minimum.

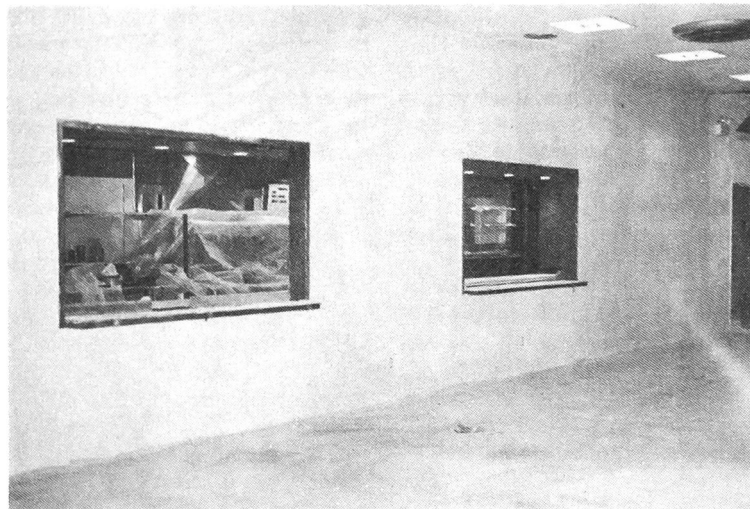
Now for the upstairs. There are now two ways to get there--first, by way of those good old stairs, which are the same stairs we have always used but are now enclosed or, second, by riding from the main floor upwards on the new elevator, which is located on the main floor, approximately where the glassed-in offices used to be. It would follow that the upstairs elevator entrance would be at about the same place.

The Student Center Ballroom hosts everything from music recitals to banquets to class activities and will now do so with much style. The ceilings in the room have been lowered, and there is a nice paint job. The entrance into the ballroom has been de-glassed, in order to protect the privacy of whatever gathering is in there, and new lights have been installed. Some work has also been done on the stage.

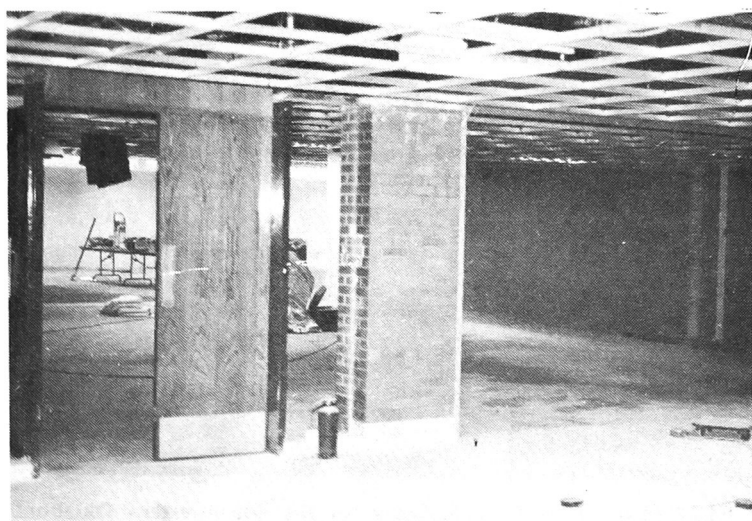
In case you wondered, both the gentlemen's and the ladies' will be upstairs and, yes, both have been remodeled.

According to Jack Watson who, as Auxiliary Services Director oversees the Center, said the new Student Center was built for the comfort and convenience of Southwestern students. "We hope that the Center will be the place for our students," Watson said. "We have designed our Student Center with them in mind."

The Student Center renovation is one of four projects underway on Southwestern's campus: there is also the new Chemical Building, located on the north side of the Chemistry-Pharmacy-Physics Building; the Margaret Replogle Music Center, located in front of the new Fine Arts Center; and the upgrading of Milam Field, which includes the new Press Box and new aluminum seats on the west side.

Harper brings experience to her new position. For the past three years, she has worked in all areas of the CE department. She is familiar with dealing with prac-

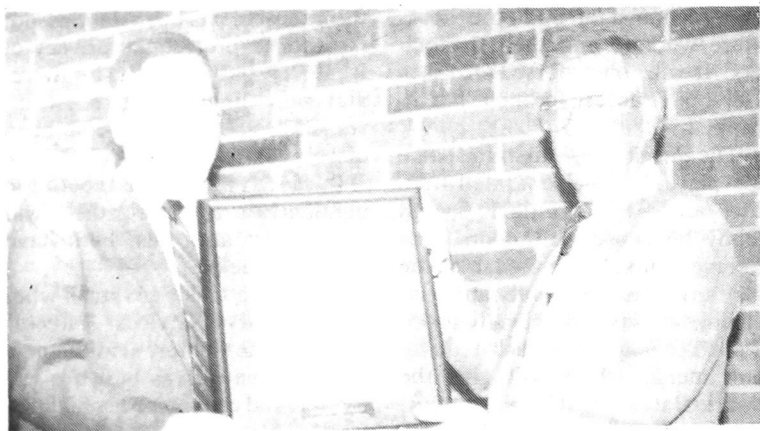

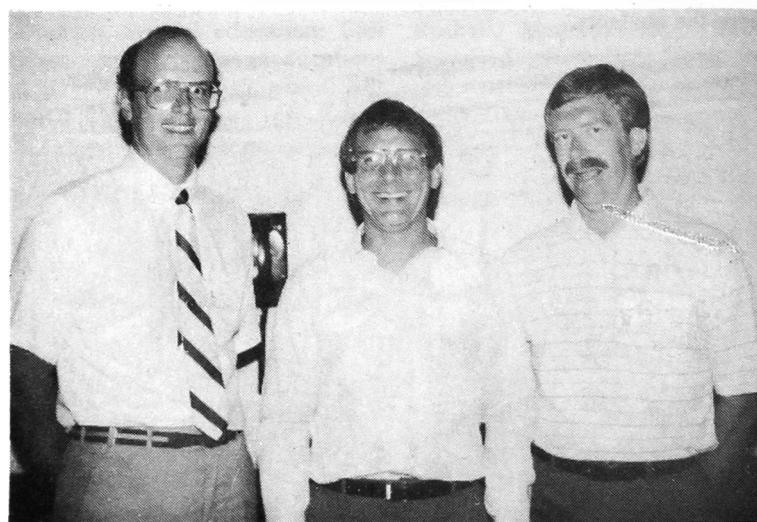

Norma Hamburger Reception Held in August

Norma Hamburger, sixth grade teacher at Nance Elementary School these past 18 years, has announced her retirement following 35 years in the teaching profession. She was honored by faculty members with a reception August 18 in the parlor of the First United Methodist Church of Clinton.

Mrs. Hamburger's parents were Ike and Viola Rymer of Cheyenne. Ike was a farmer/rancher and well-known auctioneer. She has three brothers and one sister. All three brothers were in the teaching field at one time.

The veteran educator graduated

from Cheyenne High School and earned a Bachelor of Science in Education degree from Southwestern Teachers College at Weatherford. During her college years, she worked at the college library and in the cafeteria. Later, she received a master's degree in English and was also certified in vocational home economics.

In September of 1946, she and Alvin Hamburger were married and moved to the farm seven and three-fourths miles south of Weatherford where she still resides. Alvin died in March of 1983.

Her son, Terry, his wife, Denise, and their son, Jacob, live

nearby where Terry farms extensively. Denise is an instructor in the Business Department at Southwestern Oklahoma State University.

Mrs. Hamburger's first teaching position was in the fall of 1941 at Berlin School northwest of Elk City. It was not the traditional starting time for a young teacher as she was hired to replace the regular teacher that married during cotton-picking vacation. Therefore, she launched her teaching career in October. Recently, she was a special guest at a reunion of the Berlin Class of 1946. They reminisced about her sponsoring their senior trip to Colorado Springs, Colorado, in the back of a cattle truck with built-in benches and covered with a tarp.

From Berlin, she did extension work from Oklahoma State University in Garfield County in 1944 and 1945.

Following this, she taught at Friesen Rural School southwest of Weatherford. There, she had grades one through eight. The school closed in 1949, due to a lack of the required enrollment after two of her students died in a flood east of Hydro when a dam burst. Their pre-school age younger brother also perished in the flood.

She later taught either English or home economics in high schools at Hydro, Cowden, Colony and Eakly, commuting daily from the Hamburger farm. It was between these tenures that their son, Terry, was born and she took time out for his early rearing, although she was frequently called to substitute in the Weatherford and Corn schools.

She was hired in August of 1966 to teach sixth grade at Nance School in Clinton, temporarily. That temporary position has stretched to 18 years.

Redinger Named Cashier

SPORTS SPOTLIGHT

1985 Bulldog Football Outlook Positive

As coach Bob Mazie enters his eighth year as head coach of the Southwestern Oklahoma State University football Bulldogs, he finds that he will have to rely on the capabilities of a record number of freshman recruits to get the Bulldogs back on a winning track, after a disappointing 4-6 season in 1984.

Among those freshmen will be James Hicks, a 6-0, 190 lb. running back from Burkburnett, Texas, whose brother, Charles Hicks, played for the Bulldogs in the early 70s and still holds several rushing records. Joining Hicks will be James Ward, a 6-0, 185 lb. All-State running back from Dibble; Duncan product Tommy Bomkamp, a 6-0, 185 lb. wide receiver, and some 45 other freshman recruits. It is no wonder that Mazie states "We will be a young ball club."

Mazie mentions that the 1985 spring football drills were positive in their outcome. "Although the weather hampered our progress," Mazie said, "I feel that our spring practice helped us in our struggle to bring a team together." Mazie also mentioned that spring practices were completed without several positions filled, including defensive end, cornerback, and the all-important quarterback.

The 1985 edition of the Southwestern Bulldog football team will include some 21 lettermen, with nine starters returning on offense and five on defense and, although that is usually a positive statement, Mazie doesn't see it as

such. "Although we have a number of athletes returning, we are moving many of them to different playing areas," he said. Mazie mentions that one of those changes will involve Simmy Cooley, who transferred to Southwestern last season as a quarterback and who now owns a starting defensive corner position.

The Bulldogs' 1985 schedule will be as tough as they come, and Coach Mazie is well aware of that fact, stating that "I think our whole season could depend on how well we fare in our first several games." The Bulldogs will open the season with two home games, first against NCAA Division II power Eastern New Mexico on September 14 and, on September 21, against Missouri Southern, a perennial NAIA top-ten team. The Bulldogs will also face Cameron at Lawton and Howard Payne at home before entering their Oklahoma Intercollegiate Conference play.

Coach Mazie recently went over possible starters for each position on the 1985 edition of the Bulldogs:

Quarterback

Although sophomore Marion Brown (6-1, 190 lbs.) started the last four games for the Bulldogs in 1984, rushing for 125 yards and passing for 176 and was the leading candidate for the job after spring drills, he does not have the position locked up. "We have several candidates for the job," Mazie said. Those candidates would have to include Greg Covalt, a product of Woodward and

a transfer from Kansas University, and Derek Hudson, a transfer from Wichita State who, in his senior year at Wynnewood, led his team to the state play-offs. Mazie said that his 1985 quarterback will have equal passing and running abilities and will have to be "a team leader."

Backfield

It is in his backfield that Mazie has the most confidence as the 1985 season becomes reality, and most of that confidence rests on Lonnie May, a 6-2, 205 lb. senior from Tuscaloosa, Alabama, who Mazie states should "carry the ball 30 times a game." May had almost 450 yards for the Bulldogs in 1984. The fullback position will either be filled by William "Speedy" Hicks, a 5-8, 184 lb. sophomore from Guthrie, who led the Bulldogs in rushing last season with 478 yards and six touchdowns, and Lamar Mina, also a Guthrie product who is a 5-7, 200 lb. senior who saw little action in 1984. Mazie hopes that both Ward and Hicks will help with any depth problems.

Receivers

Mike Kroeker, a senior wide receiver from Jenks who caught 15 passes for 160 yds. and a touchdown in 1984, will start again in 1985. Coach Mazie is pleased with Kroeker, calling him "one of our finest players." Also returning this year will be Brad Cox, a 5-11, 175 lb. split end from Tulsa who, in his freshman season, caught four passes for 53 yards, and Teddy Weathersby, a senior wide receiver from Gulfport, Mississippi, who caught three passes for 18 yards during 1984. Mazie will also rely on the abilities of freshman Bomkamp in this area.

Offensive Line

Another area that looks promising to Mazie. It is no wonder that he claims to have "the biggest offensive line ever" with Dave Storm at 260 lbs., Dud Robertson at 280 lbs., Brad Farrow at 240 lbs., Butch Phillips at 285 lbs., and David Plumlee at 283 lbs. all returning. If that was not enough, Mazie will include transfers Bill Fitch, from North Texas at 260 lbs., and Danny Walker, from Gulfcoast Mississippi Junior College, at 265 lbs.

Defensive Line

The shining light here belongs to one Randall Webster who, in his first season as a defensive end

for the Bulldogs, was an Honorable Mention All-American. Last season Webster had 89 tackles, 48 of the solo, had six quarterback sacks for minus 46 yards, and was named the NAIA National Defensive Player of the Week once and the District Nine Player of the Week twice. The other end position, belonging to Greg Hinkle who was in on some 62 tackles last season with four fumble recoveries, could either go to seniors Don Glenn or Sam Woodfork, a receiver transferred to defense. The tackle positions will go to Bryan Cooper, a 6-2, 269 lb. senior from Columbus, Ohio, and Mark Beisel, a 6-2, 248 lb. senior from Perry. Mazie does worry about the defensive line's depth.

Linebackers

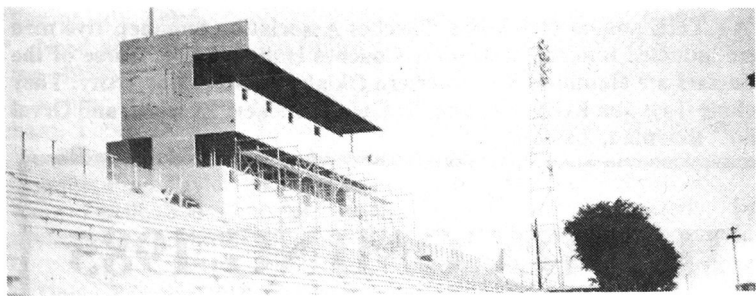
Mazie is also worried about depth here. The middle linebacker position will probably go to Marty Irland, a 6-1, 226 lb. sophomore from Grapevine, Texas, who saw action in 1984 with some 70 tackles. The other two positions will go to either Cliff Ice, a 6-0, 226 lb. sophomore from Watonga; Darrell Manigo, a 6-2, 205 lb. senior from Marlin, Texas; or newcomer Barrett Lewis, a 6-0, 227 lb. transfer from Gulfcoast Junior College. Mazie hopes to have freshmen available to help out in this area by the beginning of the season.

Defensive Backs

Joe Don Litsch, in his senior year, will have the strong safety position, and Cooley will have one corner. The other cornerback will be selected from John Dill, a Weatherford sophomore who has grown to 6-2, 175 lbs.; Ricky Gross, with some 48 tackles last season, and newcomer, P. W. Thompson, a 5-11, 180 lb. transfer from Oklahoma State University.

Kicking Game

Kiourmars "Fred" Rezaie is gone from the Bulldogs this year, after two highly successful seasons as the Bulldogs placekicker. Rezaie, who broke the school's field goal length record last season, will be replaced by his brother, Ardeshir, who Mazie adds, "has a quicker foot than Fred." Devin Cross will hold down the punting position. Cross, a sophomore from Pampa, Texas, led the District several times during the 1984 season, averaging 41 yards per punt.



THE SOUTHWESTERN Oklahoma State University Milam Football Field will sport a new look for the fall 1985 season. Alumni Named To Coaches Hall of Fame

Three of the five men recently inducted into the Oklahoma Coaches Association Hall of Fame are graduates of Southwestern Oklahoma State University. They were: Orval "Bo" Bowman of Lawton, George Dickey of El Reno, and Jim Keith of Claremore.

Bowman, a graduate of Butler High School and Southwestern, coached Lawton to the state baseball finals five times, winning championships in 1961, 1962, and 1964, and coached the Wolverines to a 13-0 football record and the state title in 1970.

Dickey, from White Deer, Texas, and Southwestern, coached football 25 years at Watonga, Crescent, Buffalo, and El Reno, winning 12 conference and eight district titles and posting a record of 115-76-12. He also coached basketball and track.

Keith attended Geary, OU, and Southwestern and has devoted most of his coaching energies to girls' basketball. His teams at Sayre, Elk City, Custer City, Oologah, and Claremore have won 598 games, 13 conference and 18 district titles. Keith also has coached boys' basketball and baseball and logged another 16 district crowns with those teams.

JIM KEITH

Jim Keith is a graduate of Geary High School and Southwestern Oklahoma State University.

Coach Keith began his career at Sayre High School where he was the head basketball and baseball coach as well as an assistant football coach. He also coached the Jr. College baseball team during his 12 years at Sayre. He followed this with seven years service at Elk City where he coached girl's basketball, baseball, and assisted in football. The Elk City girls made four trips to the State Tournament and were State Runners-up two out of the four trips. His Elk City baseball teams were State Semi-Finalists twice. He coached the Custer City High School girl's basketball team and served as the Athletic Director for a three-year period prior to moving to Oologah High School for an eight-year stay as the Athletic Director and girl's basketball coach. His Oologah girl's basketball teams went to the State Tournament twice. He is presently in his third year as the girl's basketball coach at Claremore High School. He is in hard pursuit of 600 wins with 598 wins to his credit at the end of the 1984-85 season. His girl's basketball teams have won

13 Conference Championships and 18 District Championships to go with his boy's teams winning 10 Conference and six District Championships. His baseball teams were Conference Champion four times and District Champions 10 times.

Coach Keith has been honored as the 1968 Oklahoma Girl's Basketball "Coach of the Year" as well as being selected to coach the 1965 Oklahoma Girl's All-State Basketball Game, the 1968 Oklahoma Coaches Association All-State Baseball Game, and the 1973 Oklahoma Coach in the Oklahoma-Texas All-Star Girl's Basketball Game.

Jim Keith has coached teams in every class sponsored by the Oklahoma Secondary School Activities Association.

He is an active member of the Oklahoma Girl's Basketball Coaches Association, having served as its president, vice-president and as a board member several times. He has been an active member of the Oklahoma Coaches Association for 33 years.

Jim and his wife, Jorene, reside in Claremore where he continues to coach and teach.

ORVAL "BO" BOWMAN

Orval "Bo" Bowman is a graduate of Butler High School and Southwestern Oklahoma State University. Orval started as a freshman on the Bulldog football and baseball teams. He was elected co-captain of the baseball team his junior and senior years as he completed his college career on teams that won the Oklahoma Collegiate Conference Championship four consecutive years.

Coach Bowman began his coaching career at Lawton High School as head baseball coach and an assistant football coach in 1955. A call into service in 1957 interrupted his coaching career until 1958 when he returned to assist in baseball and football. He assumed the duties as head baseball coach in 1960. The Wolverine baseball teams preceded to win State Championships in 1961, 1962, and 1964 and were State Runners-up in 1963 and 1965. Coach Bowman was elevated to the head football coaching job in 1966 and led the team to the 1970 State Championship with a 13-0 record.

Coach Bowman was selected to coach the victorious 1962 South All-State Baseball Team as well as the victorious 1971 Oklahoma Oil Bowl Football Squad.

After his retirement from

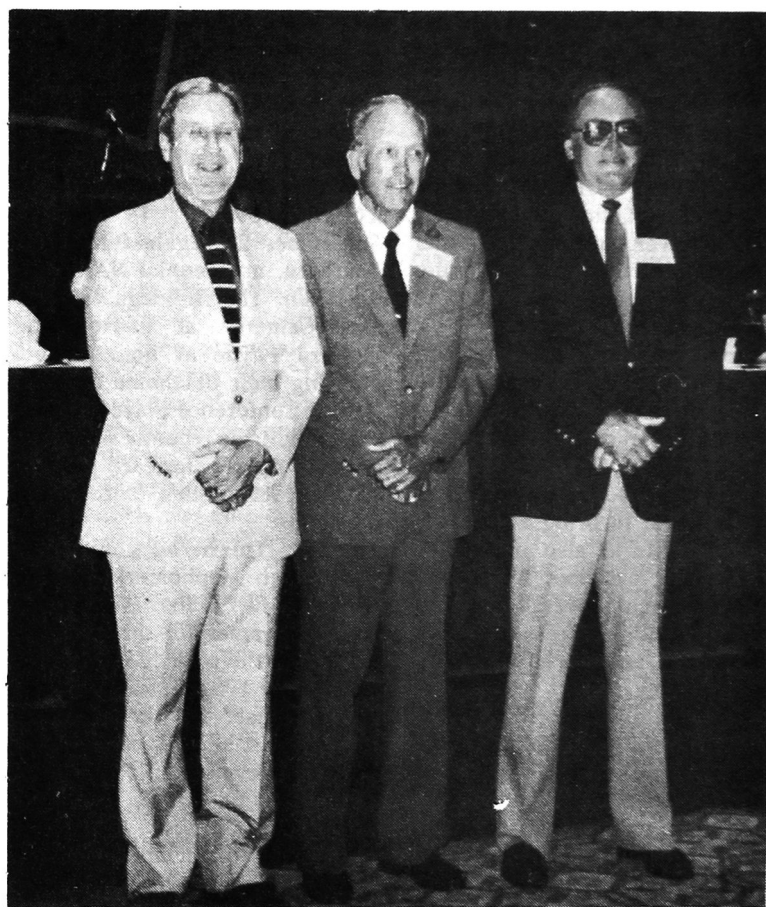
coaching, Orval and wife, Peggy, reside in Lawton where he operates an insurance and real estate company.

Fans of the Southwestern Bulldogs and Lady Bulldogs basketball teams will see new looks on each as the teams begin their 1985-86 seasons of play.

For George Hauser, coach of the Bulldogs, a group of transfer students, combined with several freshmen, are on tap to help overcome a disappointing 12-15 season last year. "If we can improve our offense, rebounding and guard play," Hauser said, "we'll be better. Last year we didn't have any shooters."

Hauser also added that "this year we should be a much stronger rebounding team. We've got bigger kids."

Hauser concluded by saying that "if everybody works out, we'll be better, although our opponents have all improved themselves, too. District Nine will be much stronger than last year."

Coach John Loftin begins his fifth season as coach of the Lady

Bulldogs and, in case you have been on Mars, has compiled a 129-5 record and three NAIA National Championships. "She is a fine addition," Loftin said. "Kelli's played four years, knows the system, and has a 3.97 G.P.A. It won't be like having a graduate assistant but rather like having a real assistant. She will also be valuable with recruiting."

The Lady Bulldogs will have one major style change for the beginning of the 1985 season--their slow, deliberate play will be history, and now, they will move to a faster-paced running game.

"Although we have several returning players," Loftin said, "we only have one starter return-

ing--Shelly Brown." Brown was named an NAIA All-American last season.

Joining Brown as starters for the Lady Bulldogs will be Lisa Freeman, a redshirt shooting guard from Abilene Christian, and Donna Douglas, a transfer from Oral Roberts, both NCAA Division I schools.

"If all goes well during prac-

tice, we will be a competitor in District Nine," Loftin said.

The Southwestern Oklahoma State University Bulldogs begin their 1985-86 season of play against Arkansas Baptist on November 8 in Weatherford, while the Lady Bulldogs begin on November 12 in Langston, before returning to Weatherford on November 20 to face Panhandle.

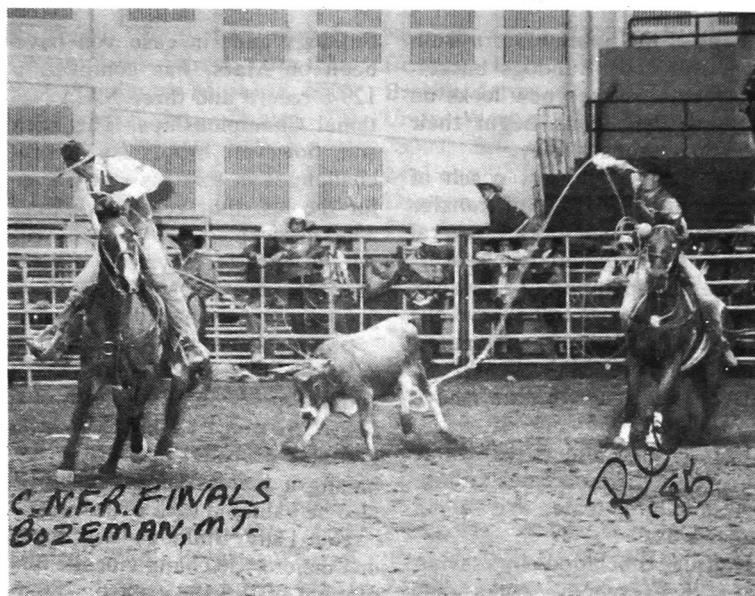

SAM WILLIS (left) Southwestern's National All Around Cowboy.

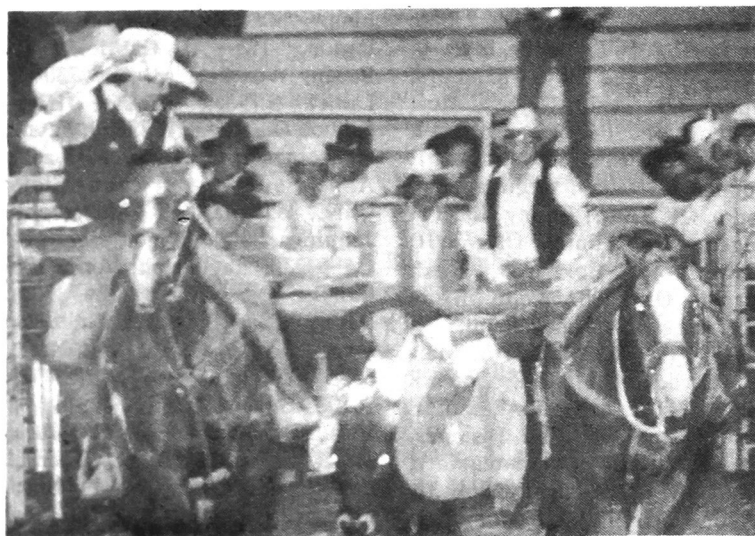
Rader Signs with SWOSU
