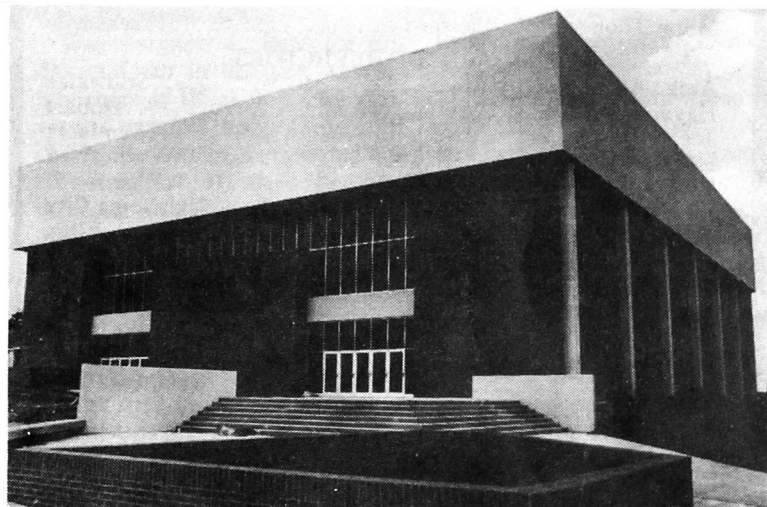

Governor Appoints SWOSU Graduate To Serve On State Supreme Court

A Southwestern Oklahoma State University graduate and former Colony resident who has spent 12 years drafting opinions for the State Supreme Court now is becoming the second woman to sit on that high bench.

Gov. George Nigh appointed Yvonne Kauger, daughter of John and Alice Kauger of Colony, to the State Supreme Court over Joseph Young Jr. of Woodward and Holland Meacham of Elk City.

She is the second woman Nigh has appointed to the high court, joining Alma Wilson, appointed to the Supreme Court in 1982.

For the last 12 years, 46-year-

old Kauger has worked as a judicial assistant to Supreme Court Justice Ralph B. Hodges. She graduated from SWOSU in the mid-1960s and from Oklahoma City University Law School in 1969.

Kauger graduated magna cum laude from Southwestern and finished first in her graduating class at Oklahoma City University Law School. She is also a member of the board of directors of Lyric Theatre and founded an art gallery for Indian artists at Colony.

At 46, Kauger will be the

youngest of the 11 justices.

"I believe in women's issues, but I think so many times we can do more by not being quite so militant and being a little more effective," she added.

Kauger indicated that her grandfather built Main Street in Colony. "He is a Russian immigrant who floated down the Volga River to escape no telling what," she said. "The last judge in the family was my uncle David Kauger who was a judge under the czar, so it has been a long time for the Kauger's."

Alumni Donate Lake Front

Dr. Ken Rose, professor of health and physical education at Southwestern Oklahoma State University, has announced that Dale and Mary Beth Crowder, both of Weatherford and both graduates of Southwestern State, have donated two acres of land to the University, for use as an outdoor education laboratory.

The land, located on the east end of Crowder Lake which is south of Weatherford, will be adjacent to the new Crowder Lake State Park project and will be used for such University interests as outdoor seminars, sailing classes, camp counseling seminars, biology classes, art classes, and teacher education courses.

Dale Crowder is a 1956 industrial arts and history graduate of Southwestern and has worked as a foot mail carrier for the past 28 years. He has also been involved in Boy Scouts as well as the Masons and Eastern Star. Mrs. Crowder went back to school and

graduated from Southwestern with her son, Mark, after devoting her energies to raising a family and doing much community work, including Girl and Cub Scouts and the Contact Crisis Intervention program. She has worked for the Weatherford Head Start Program before encountering a life-threatening battle with cancer.

Both Crowder offspring are Southwestern graduates. Mark, already mentioned, is employed at Texas Instruments in Dallas; and Linda Kay, a business education graduate, is married to another Southwestern graduate, David Smith, and lives and works in Tecumseh. Linda Kay and David provided a big thrill to the Crowder family in the form of a new addition, Catherine Renee, born December 21, 1983.

Dr. Rose commented that "The Crowder's gift of those two acres shows their belief and faith in young people. We are very thankful for this donation."

Margaret Renz Replogle Donates \$250,000.00 to Southwestern University

Margaret Renz Replogle, a Southwestern Oklahoma State University alumni and recently inducted into the Distinguished Alumni Hall of Fame at Southwestern Oklahoma State University, has given \$250,000.00 toward the construction of the music building on the new Fine Arts Auditorium, the largest single gift given in the history of the University and one-half of the building's construction cost.

When state funds for construction became short, the music wing on the Fine Arts Building had to be dropped. The donation by Mrs. Replogle brought to life a dying dream of the Southwestern State Music Department and her Alma Mater. The new facility contains a large practice room, percussion room, music library, 14 individual practice rooms, conference room, listening room, and three offices. The music hall will serve students for many years to come.

The donation will be made in two payments--the first payment of \$125,000.00 in February 1984 and the second payment of \$125,000.00 in February 1985. Upon completion of the facility, the University will officially name the building the "Margaret Renz Replogle Music Hall." Matching funds and private donations will be used to complete the building.

Mrs. Replogle has given \$38,400.00 to the Southwestern State Foundation for the purpose of establishing a permanent scholarship fund and named the "Margaret Renz Replogle Scholarship."

Mrs. Replogle recognizes that the need for new buildings and facilities go hand in hand in recruiting music students with outstanding abilities and a genuine desire to obtain a degree in higher education. The new music hall will give the Southwestern Oklahoma State University Music Department a facility that will compliment the fine instrumental and vocal programs offered at its University. Mrs. Replogle seeks to help deserving young Oklahomans. Her love for music has helped endow music scholarships at other universities.

The new music hall will be built on the southwest corner of the new Fine Arts Building facing Davis Road.

Margaret Renz Replogle was

born in Odessa, Russia, where her father was an Indo European telegrapher. When she was only a small child, her parents, Jacob and Marie Renz, decided to leave the wealth and prosperity of their heritage and move their young family of six away from Russia's increasing turmoil and impending bloody revolution. On August 15, 1911, they boarded the passenger ship Hanover for the 22-day trip to the United States.

After visiting with relatives for several weeks in Hillsboro, Kan., the Renz family settled on farmland at Weatherford. Mrs. Replogle remembers well the hours she spent helping bale hay, chop corn, milk cows, and wash the family laundry on scrub boards.

Determined and intensely interested in acquiring an education, she worked for the Ben Kramer's for her room and board while attending high school and college. Upon receiving her coveted bachelor of science degree, she began teaching school in Erick.

She later accepted a position as a laboratory technician in the University of Oklahoma Medical School Histology and Embryology Department, and still later became an X-ray technician in the Balyeat Hayfever and Asthma Clinic in Oklahoma City where she met her future husband, Dakotah Replogle. They were married in 1944.

Since the loss of Mr. Replogle in 1957, Margaret has kept an active volunteer involvement with a number of organizations.

The Replogle Chapel at the First Christian Church in Oklahoma City was funded in the amount of \$35,000.00 by Mrs. Replogle in 1978.

In 1982, Margaret presented Deaconess Hospital a gift for \$100,000.00 earmarked for equipment and furnishings for the hospital's center for newborn infants. The gift was one of the largest in the hospital's history. The center has been named the Margaret R. Replogle Neonatology Center.

Mrs. Replogle was involved in the organization of the Ladies Advisory Board of the Deaconess Home and served three terms as president. She also was active in planning the new home which was completed in 1971. She served on the executive committee and co-chaired the fund drive for the home, contributing \$40,000.00 to-

ward its construction.

The Margaret R. Replogle Endowed Chair in Religion was established at Oklahoma City University through the generous gift of \$250,000.00 in memory of her late husband, D. Replogle. She received an honorary doctor's degree from OCU at the commencement ceremonies in 1982. She also endowed \$200,000.00 for music scholarships at OCU in 1965 and 1967.

She serves on the Board of Directors and the Executive Board of the Salvation Army and Women's Auxiliary. She donated total funds (\$100,000.00) for the "Heart of The Hills" Salvation Army Chapel in Tahlequah and donated total funds of \$100,000.00 for a new Salvation Army Chapel being built in Oklahoma City.

She is on the Administrative Board of her church, St. Luke's United Methodist; the Ladies' Advisory Board of the Home of Redeeming Love; and a member

of the Board of the Willow View Psychiatric Treatment Center in Oklahoma City.

The Oklahoma City woman is a co-organizer of the Junior Auxiliary to the Salvation Army and has been its advisor for more than 10 years. She is an active participant in the Big Sisters organization, a staunch supporter of World Neighbors, the Oklahoma City Symphony, and the Oklahoma Art Center.

In 1970 she established and has since made sizeable contributions to a fund in the Oklahoma City Community Foundation with annual proceeds going to World Neighbors and the Salvation Army.

Accreditation Teams Visit

Dr. Leonard Campbell, President of Southwestern Oklahoma State University, announced that all undergraduate and graduate teacher education degree/certificate programs at the University have received maximum reaccreditation by state and national evaluation agencies. The Professional Standards Board of the Oklahoma State Department of Education and the National Council for the Accreditation of Teacher Education (NCATE) have approved Southwestern's teacher education programs through June 1989. These are maximum numbers of years possible in both state and national accreditation sequences. The notifications are the results of evaluation team visits to the Southwestern campus in October and November of the current academic year.

"The significance of these accreditations is indeed multiple

and has far-reaching effects with regard to recruitment, teaching excellence, and future developments," said Dr. Gary H. Gilliland, Dean, School of Education at Southwestern. It is especially positive to receive such recognition for achievement of established standards when you consider that, of approximately 1600 teacher preparation institutions in the United States, only 550-560 are accredited by the National Council. "Perhaps the most important factors involved in these successes are that they are the results of the concentrated effort by the University teacher education faculty, by the administration, and by students. Furthermore, the findings by these evaluation teams support the long-standing contention that Southwestern Oklahoma State University does have one of the best teacher education programs in the United States," said the Dean.

Thomas Receives Award

At an Awards Banquet held at the Lincoln Plaza Inn of Oklahoma City on April 28, 1984, Dr. Leroy Thomas became the fifteenth person to receive the annual Honorary Life Member award from the Oklahoma Writers' Federation, Inc. (OWFI). The banquet marked the end of the organization's sixteenth year.

The award includes a commemorative plaque and a waiving of organizational dues.

Criteria for the award are service to the state organization, assistance to other writers, overall interest in writing, and publications.

For the past five years, Thomas has served as editor of the official organ of the OWFI, the OWFI **REPORT** newsletter. Since 1981, he has been editor of **WESTVIEW**, a journal of Western Oklahoma published by Southwestern

Oklahoma State University. He is also available as a writer's consultant.

He has conducted workshops for writers and for teachers of writing at Moore High School and at the Sheerar Cultural Center for the Stillwater Arts and Humanities Council and the Stillwater Writer's Club. During the summer of 1984, he will conduct a workshop on writing for area junior-high students.

Thomas' own writing--including poetry, fiction, and non-fiction--has appeared in publications such as **HOME NEWS**, **POETS' FORUM**, **KALEIDOSCOPE**, **WEATHERFORD DAILY NEWS**, **WESTVIEW**, **WORLDWIDE CHALLENGE**, **HEALTHWAYS**, **STANDARD**, **GUIDEPOSTS**, **VOICES INTERNATIONAL**, and **THE EXPLICATOR**.

Blood Drives A Success

The Southwestern Oklahoma State University's Student Senate-sponsored Blood Drive was honored by the Oklahoma Blood Institute for the second consecutive year for donating the largest amount of blood in the college and university division.

Nine hundred and twenty-nine pints of blood were donated by Southwestern students during the 1983 Blood Drive. Kurt Winden, Student Association president, credits the success of the drive to Ed Parsley, Guymon senior, who had been in charge of the drive

over three years. Winden stated, "Ed has played an integral part in the coordination of the SWOSU spring and fall blood drives for the past three years. He is primarily responsible for the overwhelming success of our blood drives for 1982 and 1983."

Winden and Student Senate member, Ginger James, attended the Fourth Annual Awards Luncheon held by the Sylvan N. Goldman Center of the Oklahoma Blood Institute on Feb. 16 to receive the plaque honoring the drive's success.

Crink Keeps Busy

Who is more powerful than a locomotive? Able to leap tall buildings in a single bound? Faster than a speeding bullet? Although those first two questions may not apply here, the consensus vote for the third question would have to go to one Cedric Crink.

Crink, a Southwestern speech professor until retirement in the mid-70s, has been the director of the Southwestern Tours since 1959, spending some 752 days during that time enlightening his fellow travelers from Alaska to Hawaii; from the Pacific Northwest to Mexico; from Europe to Nassau. Need we say more? In his 42 outings, Mr. Crink has taken some 1390 people to some 84 foreign countries. His groups have stayed in 690 hotels/motels. The groups have traveled by rickshaws, camels, ox carts, gondolas, dog sleds, and sometimes airplanes, boats, and trains.

Currently, Mr. Crink is planning a New Orleans World's Fair trip from July 2-15 and, at this time, there are still open spaces in the group.

Aside from his tour-leader duties, Mr. Crink is quite the entertainer. At a recent breakfast in Clinton, Crink transformed himself into a Scotland Yard detective and proceeded to spend the entire program in character, explaining in an oh-so British accent the many differences between his country and the "colonists." Crink knew what he was doing--during World War II, he was stationed in London and, by the time he was through, could fool even the stoutest British official over the phone.

Another passion for Crink is his knowledge of and his ability to share parliamentary procedure. Crink is the **only** Certified Professional Parliamentarian in the state

of Oklahoma, a title he received after passing a rigorous test at a convention of the American Institute of Parliamentarians in 1965. At times, Crink hesitates to make it known that he is a parliamentarian; he tells of a friend who was awakened at all hours by different groups with parliamentary problems.

Alumni Receives Coaching Honor

Rene Huckaba, Southwestern alumni and currently the Yukon High School athletic director, was inducted into the Oklahoma Track Coaches Hall of Fame on May 5 at the Yukon school track. Huckaba was inducted prior to the finals of the Class A and Class B State Track and Field Championships.

Huckaba's induction was fitting since the long-time athletic di-

rector was instrumental in establishing the small school track and field championships. "I'm real honored. I feel there's a lot of guys who probably should have gone in before me," Huckaba said. "One of the reasons may have been that we had some success without a track."

Yukon did not have a track until the early 1970s. Workouts were

conducted at the football field, inside school buildings, and on school grounds. "If it rained, we didn't have a place to practice," said Huckaba.

Huckaba coached track at Sayre High School from 1961-62 before coming to Yukon as head football and track coach, as well as athletic director. In 12 years at Yukon, Huckaba-coached teams won 55 track meet titles, including nine regional titles and 10 conference championships. In 14 years, 13 of his teams won or finished second at a regional meet. He had 132 individuals qualify for the state meet, and his teams finished in the top 10 at six state meets.

Huckaba helped start the small school state track meet and the Oklahoma Track Coaches Association. He has been active in the Oklahoma Track Coaches Association, Oklahoma Athletic Directors Association, and served as a past-president of the Oklahoma Coaches Association.

Huckaba started the Meet of Champions, a track meet pitting state champions and record holders from all high school classes, and served as its meet director in 1967.

His coaching accomplishments in all sports were honored in 1979 when he was named to the Oklahoma Coaches Association Hall of Fame.

He left coaching in 1974 to become a full-time athletic director but will again take over the head football coaching job at Yukon High in the fall.

SWOSU Tours

The Southwestern Oklahoma State University-sponsored Southwestern Tours will be making a New Orleans World's Fair trip July 2-15.

The tour, under the supervision of Cedric Crink, Director of Southwestern Tours, will feature stops in Dallas and Houston before arriving for a two-day stay in New Orleans, one day of which will be spent at the 1984 World's Fair. After New Orleans, the tour will move on to Mobile, Ala.; Tallahassee, Tampa, Miami, and St. Augustine, Fla.; Charleston, S.C.; Asheville, N.C.; Nashville, Tenn., and Little Rock, Ark., before returning to Weatherford.

New Dean For Women, SWOSU

The Oklahoma Board of Regents for State Colleges has announced the appointment of Dr. Kay Scruggs to the position of Associate Dean of Student Personnel Services for Women at Southwestern Oklahoma State University in Weatherford, Okla.

He came to Yukon as an assistant football coach and head baseball coach. He also served as head football coach in 1978.

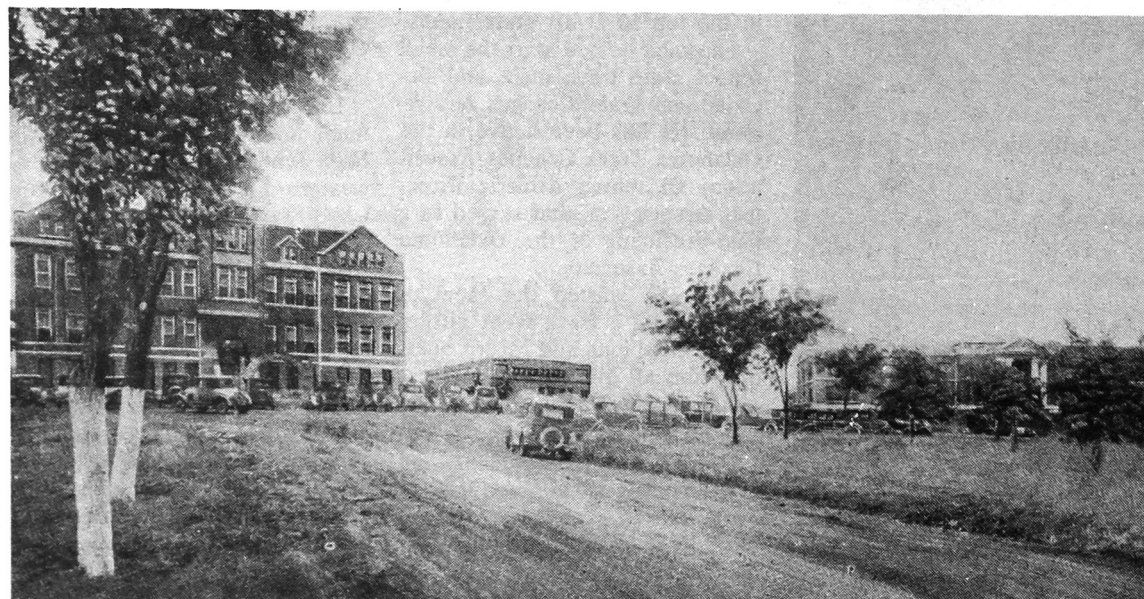
Yukon Hires SWOSU Alumni

A tragic two-car accident on Highway 84 just east of Loop 289 in Lubbock, Tex., sent shock waves through Post, Tex., with the death of Steve and Dianna Ladd.

Memorial services were held at Post in the new school auditorium.

Steve was the Post High School band director, and Dianna was PHS choir director.

Their two-year-old daughter, Stephanie, received a severe concussion.

The accident appears to have been caused when a vehicle veered off the right side of the west bound lane, then cut across the left, over the median and slammed into the east bound auto driven by Ladd.

Friends of the Ladd's reported that they had been to Petersburg, Tex., earlier in the day to hear a band concert directed by Ladd's brother, Clint.

After the concert, they went to Lubbock and were returning to Post at the time of the accident.

Investigating officers said Mrs.

Ladd was in the back seat of their sub-compact auto with the baby, and that Mrs. Ladd was killed on impact.

Ladd, who was rushed to Lubbock General Hospital, died at 8:48 p.m.

The accident, which happened around 7 p.m., was located just across from the Lubbock Power and Light generating plant on what is known as the Slaton Highway.

The Ladd's moved to Post, Tex., in the summer of 1981 from Oklahoma.

Hundreds of Post school students are affected by the deaths, as both Steve and Dianna worked with fifth grade through high school in band and choir.

Steve and Dianna were both SWOSU graduates.

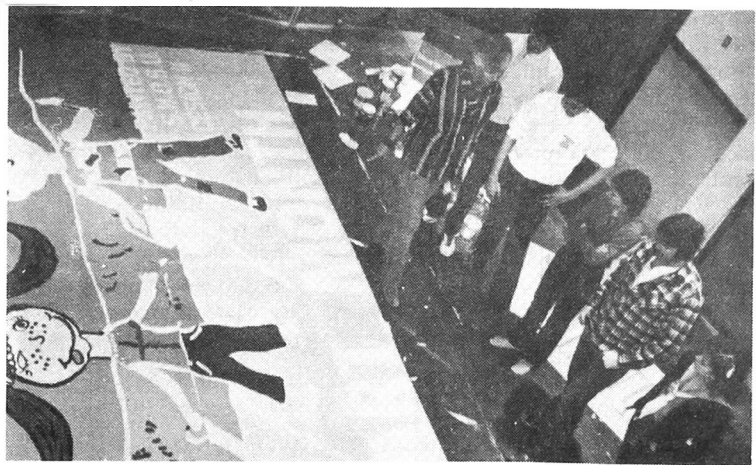

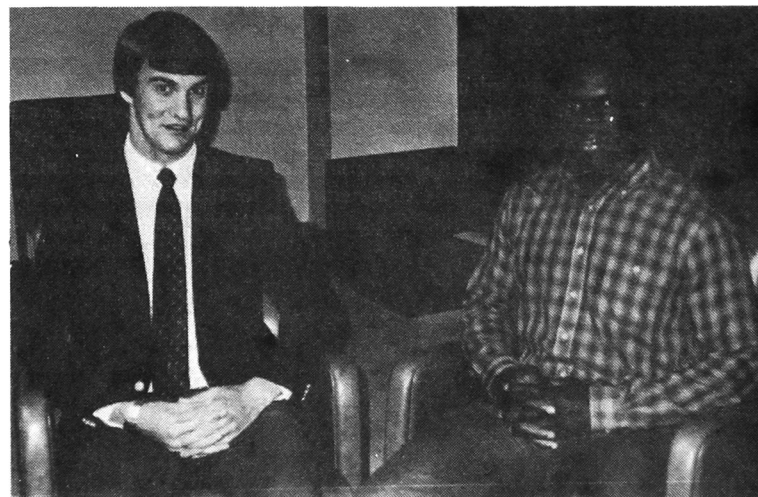

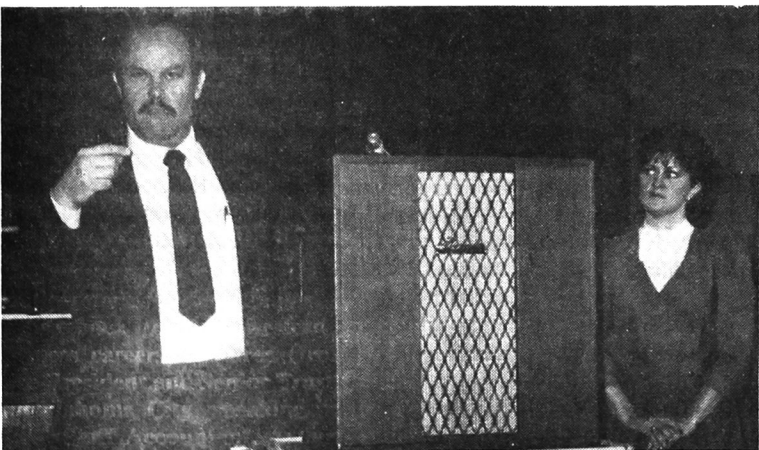

Schilling's career move was prodded by her love of aviation. "On my days off," Schilling said, "I'm sitting up there in the tower watching airplanes because I'm just so fascinated with what's going on."

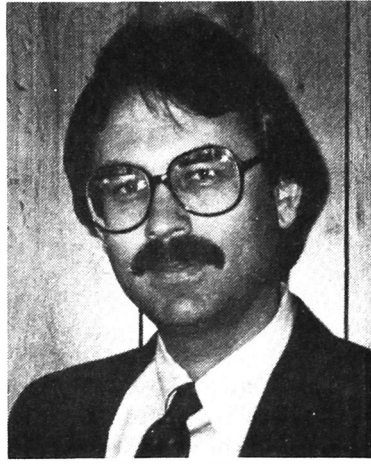
Although, as a woman, she constituted a mere 10 per cent of her training school's graduating class, Schilling insists that the field is wide-open for women. "Basically you need to have a logical brain. You need to be able to think on your feet, think quickly, and be able to communicate," she said.

Next on Schilling's agenda will be another move--this time to Wichita, Kan., where she will remain a traffic controller but with a larger airport with more traffic. She began the Wichita job on June 1.

Schilling says that with the rugged schedule that she must live by, it has worked well that she remains single. "In my case," she says, "the career is really the first priority and air traffic is a very demanding profession."

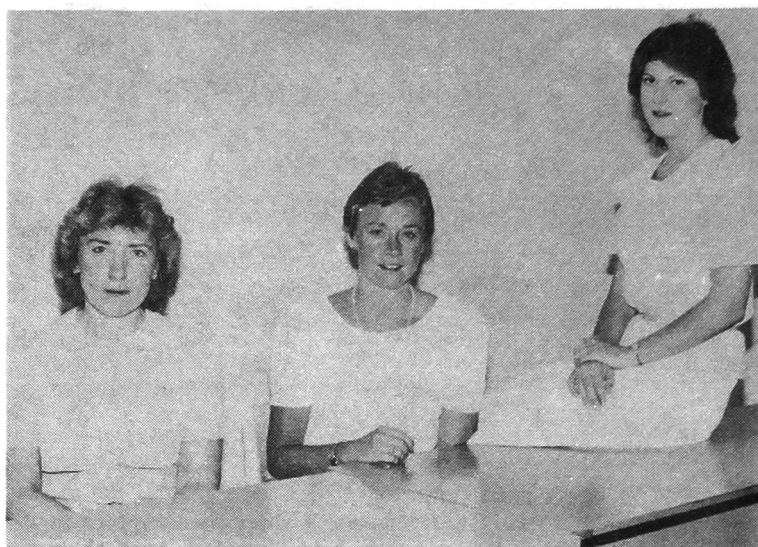

Even though many students who complete these programs choose to continue at the University and complete a four-year degree, the demand for qualified employees is usually heavy and a good choice of job opportunities is available for those finishing these studies.

"This feature makes the certificate programs very appealing to students who at the time of enrollment as freshmen do not know for sure if they wish to complete four full years of study."

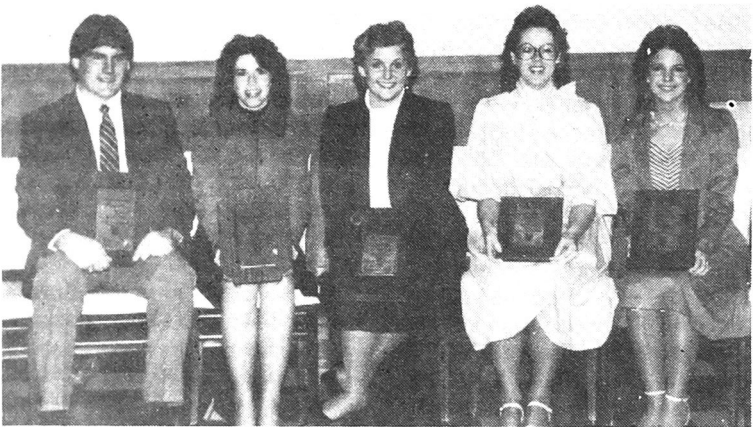

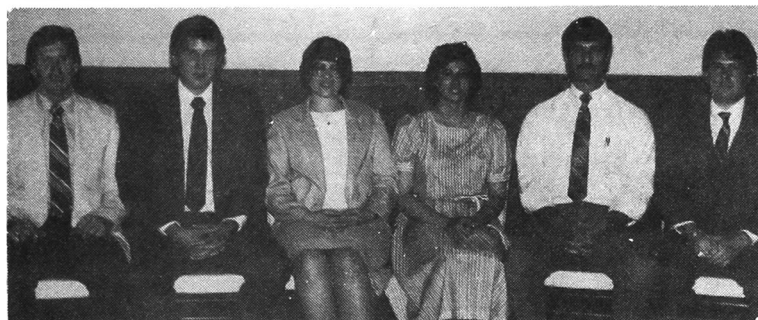

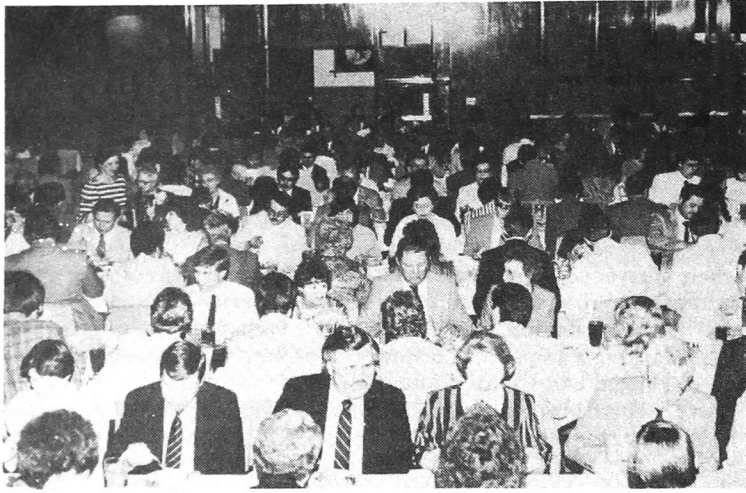

Board of Directors Meeting

MINUTES
FEBRUARY 25, 1984
SOUTHWESTERN OKLAHOMA STATE UNIVERSITY
ALUMNI ASSOCIATION

The Board of Directors held their regular meeting in the Student Center Cafeteria at 11:30 a.m. on February 25, 1984. After a steak luncheon, the group moved to the Southwestern Room of the Al Harris Library for the business meeting. Members present were: Haydon Battles, Dr. Joe Anna Hibler, Joe Battles, Helen Gossman, Ed Berrong, Carl Bogdahn, Millie Thomas, Frances Curb, Larry Claxton, Johnny Beech, Kenneth Leggett, Tom Libby, Dr. Bob Brown, Dr. Leonard Campbell, Otis Sanders, and Mark Mouse.

President Beech introduced Dr. Leonard Campbell, President of Southwestern Oklahoma State University, who talked about budget reduction and the general state of the University.

President Beech read a reply from Senator Wayne Winn in response to the letters sent by the Association to legislators supporting the increased sales tax.

Otis Sanders, Executive Secretary of the Association, reported to the group on the following: Satellite chapters in Lawton, OK, Anaheim, CA, and the most recent chapter, Central Oklahoma Alumni Association in Oklahoma City. Mr. Sanders reported that officers were elected and plans were being made for their regular meetings. Officers elected for the Central Oklahoma chapter were: Dr. Lucille Patton and Cotton Vickers, Co-Presidents; Larry Claxton, Treasurer; and Brenda Stacy, Secretary.

Mr. Sanders also reported that statements had been mailed to all members, using the updates of the Alumni files, that **Echoes from The Hill** would be mailed the third Friday of March, and Homecoming 1984 had been set on November 3, 1984. Among the many events planned for the upcoming event would be an athletic reunion for all athletes graduating between the years of 1950-58.

Chemistry Department Receives Donation

The Southwestern Oklahoma State University Chemistry Department has been notified that it has been awarded, from the Dow Chemical Company Foundation, \$6000 a year for four years.

The donation, which designates \$5000 for scholarships and \$1000 for discretionary use of the chemistry department, is a result of an effort by Dow Chemical to double the size of a program in which it has been providing four-year undergraduate scholarships to chemistry students. In 1982, Dow Chemical began with 20 schools, and Southwestern is now one of 40.

"We are vitally concerned with the quality and quantity of future graduate chemists," said Dr. David P. Sheetz, the vice-president and director of research and development of Dow. "It is our feeling that the smaller baccalaureate-granting schools of the country are the key to supplying the graduate schools with an adequate supply of well-qualified candidates."

Prior to 1982, the Dow Chemical Company Foundation's main emphasis was on providing grants for basic and fundamental research projects at universities. Most of the original research projects have been completed, and

the foundation is not now soliciting new research proposals. While the primary purpose of the foundation is still to support basic research and education in the chemical sciences, this is being done mainly through an aid-to-education program of which these special undergraduate scholarships in chemistry are a part. The foundation is entirely funded by the company, which has provided about \$5 million for the foundation's activities to this point.

The scholarship grants are administered by the chairman of the chemistry departments involved. They select the recipients, attempting to choose outstanding high school science students who are U.S. citizens with perceived goals of pursuing chemistry majors through four years of undergraduate work at the schools and continuing their education through the Ph.D. level.

The foundation stipulates that the scholarships be awarded solely on the basis of merit and commits to continue them for four years, provided that the student maintains a 'B' or 3.0 out of 4.0 point average in credited courses. The scholarships are granted to the schools and, should a student recipient elect to switch majors or transfer to another institution

(which has already happened), the foundation stipulates that the scholarship be transferred to another student at the institution at the same curriculum level.

One way in which several

schools have used the \$1000 in discretionary funds involves assistance to nearby high school science programs, which the foundation said it "applauds" but cited as only one example of appropriate use.

Alumni Awarded National Science Fellowship

Nancy S. Gettys of Hinton has been awarded a prestigious three-year National Science Foundation Graduate Fellowship valued at \$39,000.

She is a first-year graduate student in the chemistry department at Oklahoma State University.

The fellowship is based on demonstrated ability and aptitude for advanced training in science and engineering in a competition open to all science majors pursuing advanced degrees in the United States.

Only 42 such fellowships are awarded annually. The fellowship will provide for tuition, books, travel costs to scientific meetings, and some living expenses for the final three years of Ms. Gettys' graduate study.

Ms. Gettys is the daughter of Mr. and Mrs. Seth Gettys Jr., Hinton. She is a 1979 alumna of Hinton High School and received a B.S. degree in chemistry--summa cum laude--from Southwestern Oklahoma State University, Weatherford, in 1983.

At Southwestern, Ms. Gettys maintained a perfect 4.0 grade point average. In 1980, she was named Outstanding Freshman Chemist, and in 1982 she received the Analytical Chemistry Award

from the analytical division of the American Chemical Society.

She received a Conoco Scholarship for the 1982-83 academic year, and in her senior year was recognized as the Outstanding Senior Chemistry Major at Southwestern.

Outside of the classroom and laboratory, Ms. Gettys has served as treasurer of Gamma Delta Kappa, an honor society and service organization for women at her alma mater.

She also was president of the American Chemical Society Student Affiliates Chapter at Southwestern.

At Oklahoma State, Ms. Gettys is the recipient of a Skinner Fellowship.

She currently is doing research, under the direction of Dr. Lionel Raff and Dr. Donald Thompson in the area of theoretical chemical physics.

According to Raff, Ms. Gettys' research involves the theoretical study of the chemical effects of laser-induced excitation of complex gas-phase molecules.

Ms. Gettys expects to obtain her Ph.D. degree from OSU in 1987, after which she plans a career in basic scientific research.

He is an outdoorsman of note and has supported various conservation programs.

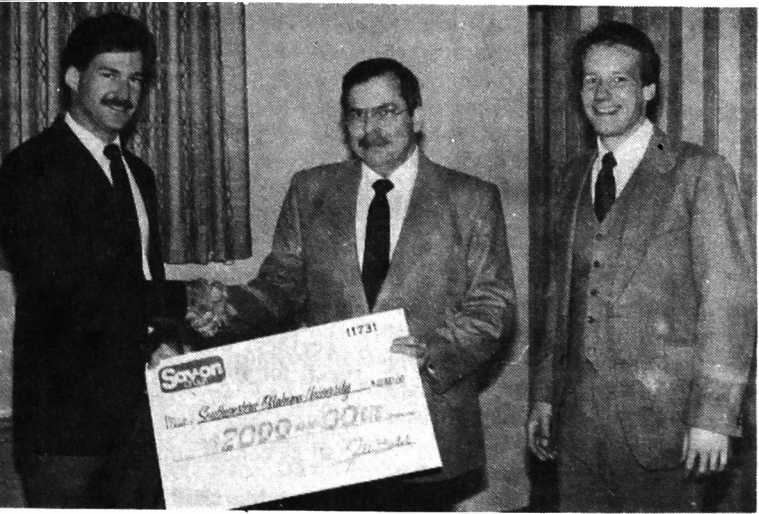
He is a person of multiple other interests and is a devoted husband and father.

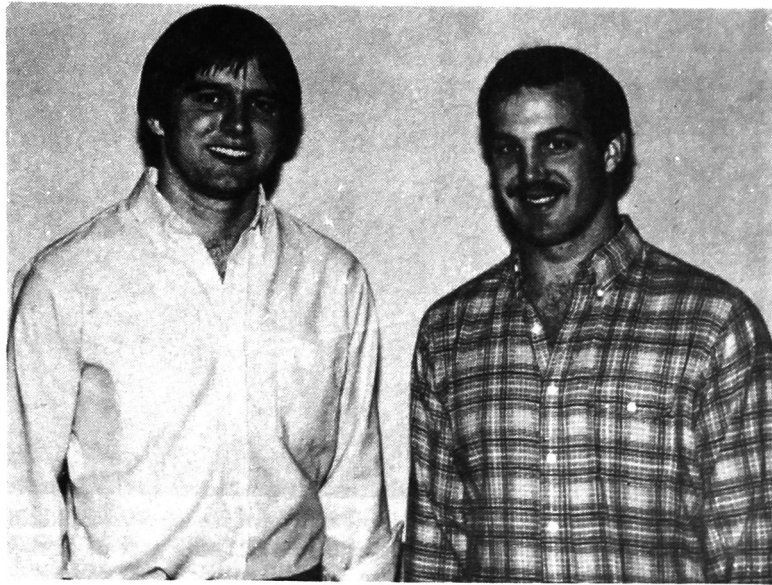

The association represents 45 member schools in southwestern Oklahoma.

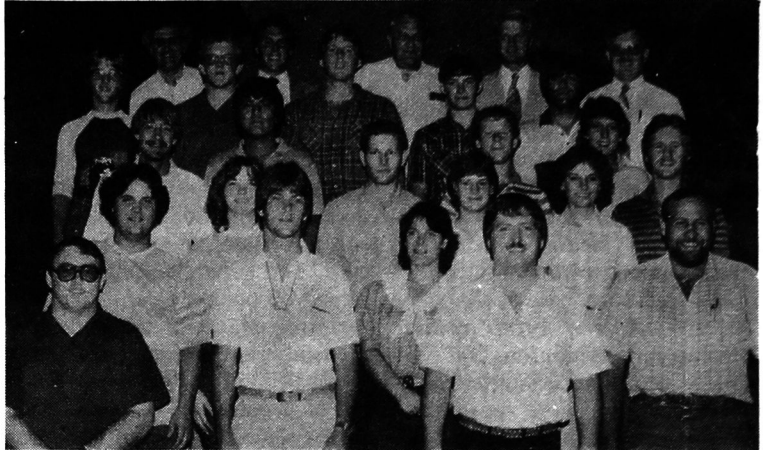
The award is awarded to a band director once each year to recognize one who has done an outstanding job at a particular school

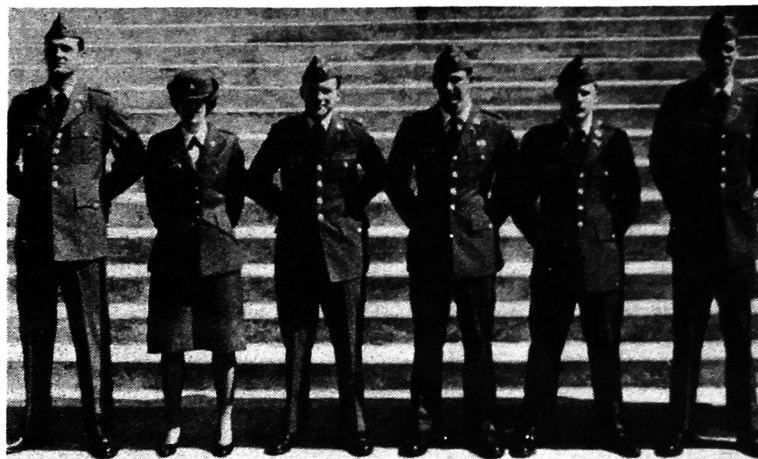

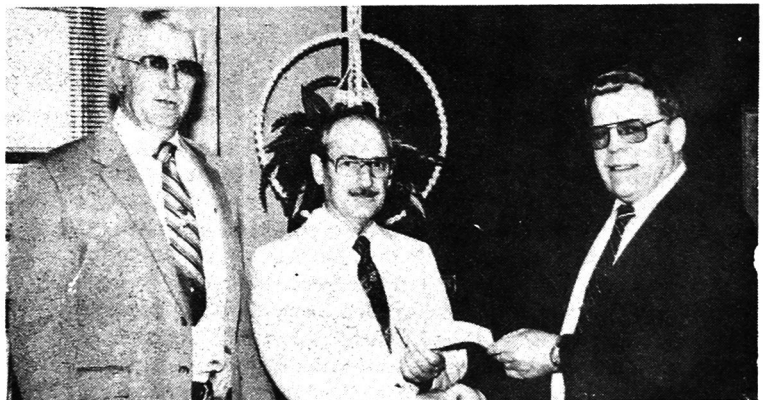

Bulldogs Have Shining Basketball Season

The Southwestern Oklahoma State University men's and women's basketball teams each had another banner season, as both teams finished with lopsided winning records. The men's final record of 23-6 combined with the women's 31-1 gave them a combined record of 54-7 for an 88% winning percentage--the first in the nation for both teams.

The Bulldogs, who led the NAIA District Nine ratings for the entire season, lost the District title in the second round of the play-offs, losing to Southeastern 81-64. The Lady Bulldogs did win District Nine with a perfect 29-0 record. The team went on to defeat Washburn, Kan., 64-57 in the bi-district play-offs. At the Ladies' next stop, the NAIA National Tournament in Cedar Rapids, Ia., however, their season was to come to an abrupt stop. Although the team won their first round against Georgian Court, N.J., 81-52, they dropped their next game, 57-54, against Asheville, S.C. The Lady Bulldogs had won the tournament the last two years, walking away with the National Championship. Their three-season record is 95-5.

Although both seasons ended in disappointment, post-season honors were piled on the Lady Bulldogs' individual team members:

Kelli Litsch, for the third time in her three-year college career,

and Anita Foster, for her first, were both named to the first NAIA All-America team. They were also both named to the first NAIA District Nine team, and Litsch received the "Most Valuable Player" in District Nine trophy.

Litsch was also a Kodak All-American and received the Champion Sports products "Player of the Year" for small colleges.

Southwestern Lady Bulldogs head coach John Loftin, along with his team, were honored at the annual Oklahoma Sports Headliners Banquet, held in Oklahoma City on Feb. 16. Loftin was also named the NAIA District Nine Women's Coach of the Year.

Foster, Mindy Mayfield, and Kim Fennelly represented Southwestern in the annual Oklahoma East/West senior All-Star Tournament, held April 14.

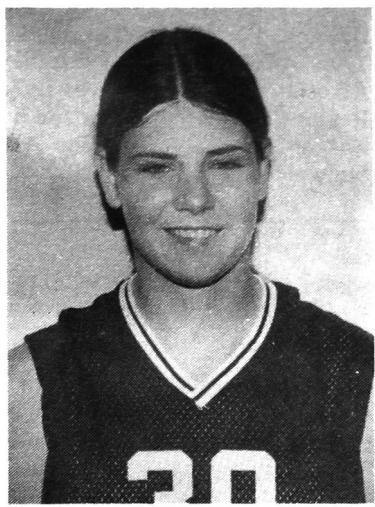

The team won the Oklahoma Intercollegiate Conference with a 5-3 record.

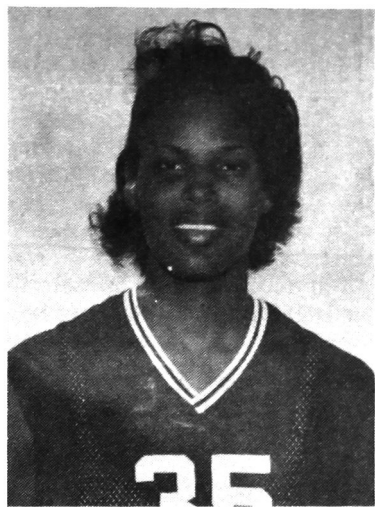

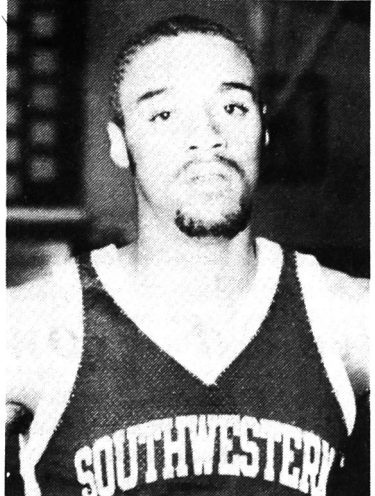

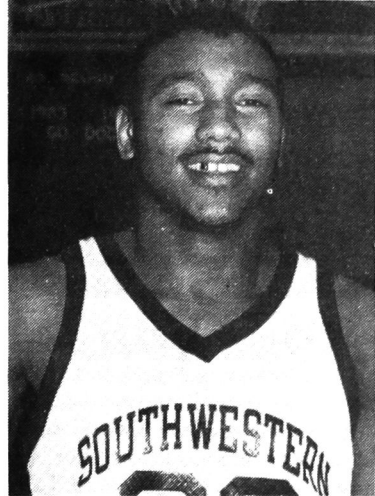

Young Dill Signs With Southwestern

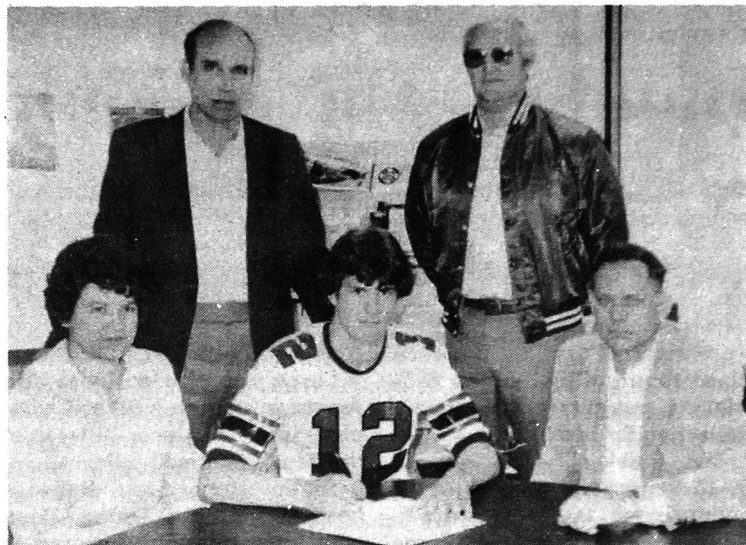

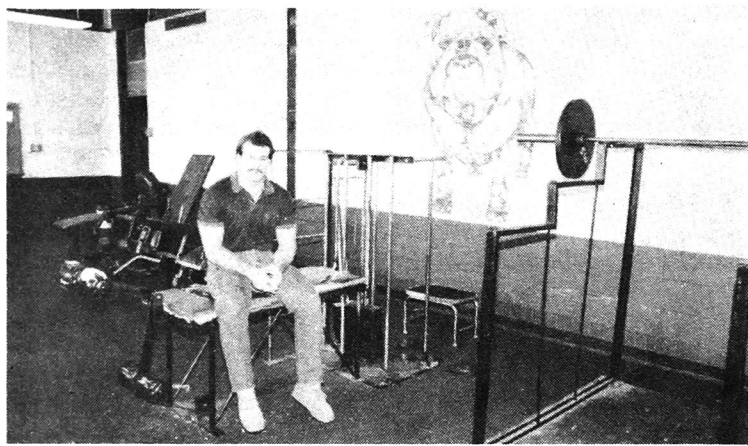
Dill received the "Most Valuable Player" and "Outstanding Offensive Back" awards from the

Donations Needed Now

The Weight Room in the Rankin Williams Field House needs donations in order to repair and purchase new equipment. All students, including athletic teams, use the weight room. Reprinted is a presentation made to the Student Senate:

"Scott Hoffman, student/athlete, was introduced to present the status of the Weight Room in Rankin Williams Field House. Hoffman proposed that the Senate take part in the renovation of this room. He stated that there is currently no budget for the Weight Room. According to Hoffman, the Weight Room is not in good condition. The facilities are not adequate, and what facilities are available are not safe. Since people other than just the athletes use the Weight Room, this affects the entire campus.

If the facilities were upgraded, Hoffman stated that recruitment would be improved. Some of the damage in the room is repairable, but other parts are beyond help. Hoffman has contacted several companies about the prices of new equipment and found the cost to be about \$2,000. Various organizations and individual donors would help defray the cost.

Hoffman asked for the amount of \$400-\$500 to begin the mail process. His basic proposal was to set up a Weight Room budget. If the Senate agreed to allocate the funds, they would join the efforts of the O Club, which will be donating \$700-\$800, and the Booster Club. After the initial donation was made, the Senate would give approximately \$50-\$100 each semester."

Alumni that would like to make donations to help with the Weight Room may mail their checks to the Alumni Association. It will be tax deductible.

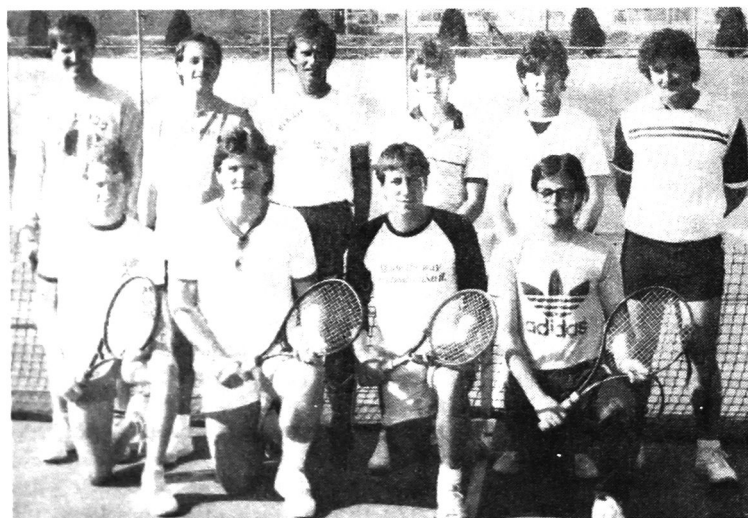
