Assessment Rationale

The Student Engagement Assessment Model provides the framework for programming and assessment conducted by the division of Student Affairs within Southwestern Oklahoma State University (SWOSU). For the purposes of this document, the term *assessment* encompasses student learning as well as the evaluation of student support services (Banta et al., 2015). The incorporation of General Education outcomes into appropriate co-curricular programs strengthen student affairs' connections to academic programs and student success (Kuh et al., 2010). Therefore, SWOSU Student Affairs aligns co-curricular assessments to the university's mission statement, committed to *creative endeavors and civic engagement*, General Education Goal Five: *Intellectual and Professional Aptitudes*, and the SWOSU strategic plan, goal 2: *Promote student achievement of educational and professional goals*.

Direct measures of assessment are typically embedded into coursework. SWOSU Student Affairs offices utilize the first year experience course, SWOSUConnect, as a vehicle for direct assessment. Where appropriate, grading rubrics are used with assessments in order to define levels of task performance (Roberts, 2017). Grading rubrics also communicate expectations to students and provide uniformity of instruction across multiple sections of the course. Specific rubric alignment correlates to the Association of American Colleges and Universities Written Communication VALUE Rubric (AACU, 2009). Certain offices within Student Affairs, including the Dean of Students and Wellness/Intramurals, sample specific students who use their services. Although data is obtained through the means of a survey, they are considered direct measures since they target a very specific population.

Other co-curricular departments rely upon indirect measures of assessment. Indirect measures of assessment require students to reflect upon their experiences in order to share their perceptions and attitudes (Banta et al., 2014). SWOSU administers the National Survey of Student Engagement (NSSE), the Student Satisfaction Inventory (SSI), and the SWOSU Co-curricular Survey in order to obtain student feedback and improve programming and services. These assessments are deemed appropriate because they ask students to reflect upon their experiences; the data provide Student Affairs' staff with multiple indicators, strengthening the evidence (Roberts, 2017).
