#### FS Motion 2006-10-01:

It was moved and seconded to take **FS Motion 2006-09-01,** *Teacher-Student Consensual Relations* policy, from the table. *Motion failed* 

#### FS Motion 2006-10-02:

It was moved and seconded to amend Article II, Section B, Statement 3 of the Faculty Handbook as follows (added text is in italics and larger type): The Departmental Continuance Committee\* shall meet and consider the strengths and weaknesses of the faculty candidate for continuance. Such consideration shall include, but not be limited to, the progress of the candidate, the expected needs of the department, and how the students may best be served. Since each case is unique, the committee shall decide the relative weight to be given to the various areas. In all cases the candidate must be treated fairly and respectfully in the opinion of the committee. The Department Chair/Associate Dean conducts the meeting and is a non-recommending member. This open discussion is followed by submission of a Faculty Recommendation Form for Continuance from each member of the committee to the Chair by October 15. Once the Chair has prepared the summary report it must be reviewed and signed by members of the departmental committee.

Motion Failed

#### FS Motion 2006-10-03:

It was moved and seconded the SWOSU Faculty Senate recommend that the Faculty Recommendation Form for Continuance include a third option to members of the departmental continuance committee members. This option will be "Recommend Continuance with Serious Concerns," and allows committee members to vote to continue while noting that serious issues need to be addressed within the next year.

#### FS Motion 2006-10-04:

It was moved and seconded **FS Motion 2006-10-03** be sent to the Personnel Policies Committee. *Motion carried; No administrative action required.* 

#### FS Motion 2006-10-05:

It was moved and seconded to change the wording of Article II, Section B, Statement 1.c. to read (added text is in italics and larger type): c. One peer review (peer chosen by the candidate) dated from the previous spring or current fall semester.

Motion carried; Forwarded to Provost for action. Approved and will be included in Faculty Handbook.

#### **FS Motion 2006-11-01:**

It was moved and seconded to adopt the AAUP statement on Consensual Relations Between Faculty and Students and have it placed in the Faculty Handbook. – See attached.

Motion carried; Forwarded to Provost for inclusion in Faculty Handbook.

Recently approved by Academic Advisory Council and will be included in Handbook upon approval by the President.

#### FS Motion 2006-11-02:

It was moved and seconded to accept the SWOSU Academic Dishonesty Policy as presented.

#### FS Motion 2006-11-03:

It was moved and seconded to return the SWOSU Academic Dishonesty Policy to the Student Policies Committee.

Motion carried; No administrative action required.

#### FS Motion 2006-11-04:

It was moved and seconded to accept the Policy and Procedures for Responding to Misconduct in Research and Scholarly Activities and have it placed in the Faculty Handbook after review by the University's attorney.

Motion carried; Forwarded to Provost for action.

Recently recommended for approval by the Academic Advisory Council and will be included in the Faculty Handbook upon approval by the President.

#### **FS Motion 2006-11-05:**

It was moved and seconded that in consultation with department faculty, department chairs and deans shall set which classes will be offered by IAV, the number of sites to be offered, and the maximum number of students that can be enrolled on campus and at IAV sites.

Motion carried: Forwarded to Provost for action.

Approved and will be forwarded to the Academic Advisory Council for implementation.

#### FS Motion 2006-11-06:

It was moved and seconded that the maximum number of IAV sites off campus that can be set is eight. The permission of the instructor is required to offer more than eight.

*Motion carried (division of the house); Forwarded to Provost for action.* 

Approved and will be forwarded to the Academic Advisory Council for implementation.

#### FS Motion 2006-11-07:

It was moved and seconded that an instructor who is broadcasting to IAV sites off campus will receive an additional \$100 per credit hour for every four sites or portion thereof.

Motion carried; Forwarded to the Provost for action.

Approved and will be implemented in Fall 2007.

#### FS Motion 2007-01-01:

It was moved and seconded that all forms of dishonesty such as cheating, plagiarism, knowingly furnishing false information to the institution, alteration or misuse of institution records or documents, including university identification cards, constitute violations of university

regulations for which students are subject to disciplinary action. Disciplinary actions may include penalties with range from an unsatisfactory grade on a particular assignment, examination, or course, to expulsion from the University. These actions shall be determined by the instructor of record or appropriate university official. The student may appeal the decision through the normal Academic Appeals Committee process.

Motion carried; Forwarded to the Provost for action.

Recommended to Student Affairs for implementation in Student Handbook. This policy is very similar to what already exists and should not be an issue.

#### FS Motion 2007-01-02:

It was moved and seconded that the FS Curriculum Committee research the possibility of creating of a University Curriculum Committee.

Motion carried; No administrative action required.

#### FS Motion 2007-02-01:

It was moved and seconded that effective immediately, any changes in and addition or deletion of courses and/or academic programs must originate in the department most directly affected and then be reviewed by all departments directly affected. Taking into consideration those reviews, the originating department then makes a recommendation to the curriculum committee, which is responsible for recommending approval or disapproval to the Provost.

#### FS Motion 2007-02-02:

It was moved and seconded that **FS Motion 2006-02-01** be tabled.

Motion carried; No administrative action required.

#### **FS Motion 2007-03-01:**

It was moved and seconded that a standing University Curriculum Committee be formed at Southwestern Oklahoma State University with the following (see attached) recommendations regarding the structure and function of the Committee.

Motion carried; Forwarded to Provost for action.

Recommended for approval by the Academic Advisory Council and will be included in Faculty Handbook pending approval by the President.

#### FS Motion 2007-03-02:

It was moved and seconded that the Faculty Senate recommends that the university encourage faculty to include a statement in their course policies regarding the classroom/laboratory use of personal electronic devices (e.g. Cell phones, pagers, calculators, MP3 players (ipods), laptops, etc.).

Motion carried; Forwarded to Provost for action.

Approved and will be forwarded to the Academic Advisory Council.

#### FS Motion 2007-04-01:

It was moved and seconded that the revised Faculty Grievance Procedure be adopted.
