    1. Executive Council Meeting of 10/12/2015
      - a) Budget—looking better, but not good
        - (1) Constitutional Institution
      - b) Gun Legislation—likely to gain momentum again
        - (1) Related to Texas Laws

      - c) Tuition Only Change: Instructors choosing to teach a summer class for tuition only will be paid 75% of the tuition collected.
